AMENDMENT NO. 1 TO GENERAL ORDERS NO. 5, DATED 29 JANUARY 1946

Amendment. Delete paragraphs 3 to 6, AFHQ General Orders Number 5, 1946, and substitute the following:

"3. In respect of Allied matters Headquarters Caserta Enclave will come under direct command of AFHQ. For this purpose, Commander Caserta Enclave will have direct access to the Deputy Chief of Staff AFHQ or the Chief of Staff AFHQ through SAC Secretariat.

4. a. Within the Enclave such Allied matters include the following:

- (1) Overall discipline, public safety, hygiene and traffic control.
- (2) Co-ordination of common-user accommodation and real estate.
- (3) Provision of water and electricity to the area, supervision of sewage and drainage, area fire services and rubbish disposal.
- (4) Provision of Engineer services, guards, cleaning facilities and fuel in respect of accommodation and areas, including roads, occupied jointly by United States and British forces.
- (5) Liaison with local civil authorities.

234 b. These tasks will be undertaken primarily by British military and other personnel under British control. Occasions may however arise when United States military personnel will provide assistance in respect of Anglo-American matters.

5. Headquarters CASERTA Enclave will not be responsible for these matters within purely United States areas, units or installations. Such responsibility will be exercised by Headquarters Command, Mediterranean Theater of Operations, United States Army, whose personnel, together with those of Headquarters CASERTA Enclave, are authorized to wear the AF Patch.

6. a. In respect of purely British matters the British element of HQ Caserta Enclave will remain under the command of HQ Naples Area. On the disbandment of HQ Naples Area, the British element of HQ Caserta Enclave will come directly under the command of GHQ CTF.

b. The Commander Caserta Enclave will be responsible for the following matters in respect of all British Troops under command:

- (1) Engineer works services.
- (2) Billeting and accommodation including families.
- (3) Operation of General Transport.
- (4) Engagement and payment of civilian labour.
- (5) Welfare.
- (6) 'Q' administration less supply of Ordnance stores.
- (7) Routine 'A' matters.
- (8) Issue of British Air Movement Orders. Details of the procedure are laid down in MOV/3/347/1 of 26 September 1946, which has been distributed to all concerned.

c. All other matters of a British nature will continue to be handled directly between Units and HQ Naples Area.

d. The Camp Commandant, British element AFHQ, will come under direct command of the Commander, Caserta Enclave, for all matters effective immediately."

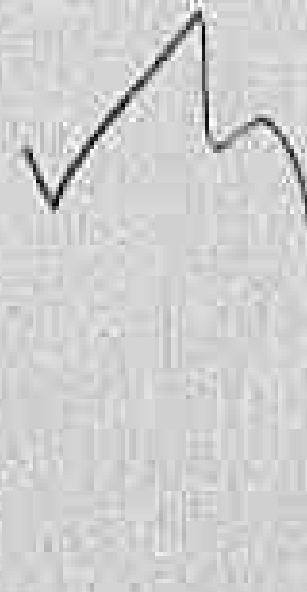

CASERTA ENCLAVE - CHANGE OF COMMAND

1. Effective 31 January 1946 control of "CASERTA Enclave" as defined in Allied Force Headquarters General Order Number 2 of 1946 will pass from Headquarters Command Allied Force to a new Allied Headquarters now forming consisting of a British Area Commander and Staff with a U.S. Increment.

2. This Allied Headquarters will be called "Headquarters CASERTA Enclave" and will assume responsibility for all matters of an Allied nature within the Enclave. "Headquarters CASERTA Enclave" will issue on such matters co-ordinated orders which will be applicable to personnel of all Allied armed forces within the Enclave.

3. a. Within the Enclave such Allied matters include the following:

- (1) Overall discipline, public safety, hygiene and traffic control.
- (2) Co-ordination of common-user accommodation and real estate.
- (3) Provision of water and electricity to the area, supervision of sewage and drainage, area fire services and rubbish disposal.
- (4) Provision of Engineer services, guards, cleaning facilities and fuel in respect of accommodation and areas including roads occupied jointly by U.S. and British forces.
- (5) Liaison with local civil authorities.

b. These tasks will be undertaken primarily by British military and other personnel under British control. Occasions may however arise when U.S. military personnel will provide assistance in respect of Anglo-American matters.

4. "Headquarters CASERTA Enclave" will not be responsible for those matters within purely U.S. areas, units or installations. Such responsibility will be exercised by Headquarters Command, Mediterranean Theater of Operations, United States Army, whose personnel, together with those of "Headquarters CASERTA Enclave", are authorized to wear the AF Patch.

5. In respect of purely British administrative matters, the British element of "Headquarters CASERTA Enclave" will take over from British Increment Headquarters Command Allied Force local administration of units within the Enclave, as far as 'Q' matters and Welfare are concerned. MS, 'A' and Ordnance matters will continue to be handled directly between units and Headquarters 56 Area.

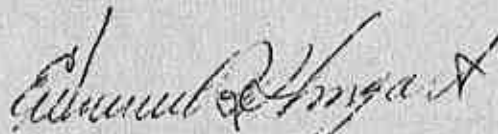
