I refer to your letter of 24 August in answer to my letter of 26 June. In which I drew your attention to the fact that the Italian Government was required to keep the Allied Commission informed of any negotiations with other governments.

I particularly have taken note of the last paragraph of your letter in which you state that the Italian Government always intended to comply with the clauses of the Macmillan Memorandum and that you have issued orders that from now on the Allied Commission is to be informed of any new proposed international agreements of a political or economic nature.

I am surprised, therefore, not to have received any communication from you regarding the negotiations leading up to the trade agreement with the Swiss Government nor a summary of the agreement as laid down in the Macmillan Aide-Memoire.

Dear Admiral,

I refer to your letters of June 25th and July 12th, n. 4001/240 and 4001/248/EC, concerning the application of para 3 of the Macmillan Memorandum.

I have no difficulty in conforming - with the reservation suggested by the position of the cabinet - the statement made by my predecessor, on. Bonomi, according to which the Government, complying with the content of the above mentioned memorandum, will not fail to inform the Allied Commission constantly and directly, about the negotiations which might be undertaken with other Governments on political or economic matters.

I also deem it advisable to point out that the mention of official statements to be made public by the press, contained in the letter of the Minister of Foreign Affairs of April 30th, must be understood as referring only to the case of the agreement with France for the resumption of direct relations and the definition of the status of the Italians in Tunisia. A different interpretation, implying that the Government meant to inform the A.C. of the stipulation of international agreements after they had been concluded, is therefore to be excluded.

For what particularly concerns the relief convention stipulated in Moscow on April 28th, for the treatment of Italian and Polish refugees, it must be acknowledged that the agreement had been mentioned before hand in the said letter of the Minister of Foreign Affairs, referring to 'soundings which are being made ... for relief to Italians interned in Poland'; however, because of difficulties in communicating with Moscow, the on. De Gasperi had not yet been informed that the agreement had already been signed. I have also been informed that, ever since April 8th, the Secretary General of the Ministry of Foreign Affairs had informed Ambassador Charles of the negotiations that were taking place and of their bearing, and that a copy of the telegraphic text of the agreement had been handed to Mr. Dowling, because of his functions of political advisor to the A.C.

The procedure suggested by the Economic section has been followed for the negotiations of the commercial agreements, though it isn't without inconveniences, which were recently brought to your attention.

I am most happy to show you with these informations, that the Italian Government always intended to comply with the clauses of the Macmillan memorandum, and I want you to know that I issued orders that, from now on, to avoid inconveniences, direct communication be given to your office of the news relative to international agreements of a political or economic nature.

On 25th May I wrote to your predecessor drawing his attention to paragraph 3 of the aide-memoire left with him on 25th February by Mr. Macmillan and myself. This paragraph required that the Italian Government keep the Allied Commission informed of any negotiations in which it might engage with other governments and suggested that a periodic summary be furnished of all negotiations completed and pending with other governments.

In reply I received a letter from the Minister of Foreign Affairs (reference Y/635 dated 30th April) which stated that all discussions of an economic character pass directly through the Allied Commission Sub-Commission concerned and Allied Commission was thus perfectly well informed. In addition it was stated that negotiations of a political character are published in the official communique and newspapers at the time they are completed.

On 14th June I wrote to Signor Bonomi explaining that this summary handling of the situation was not satisfactory and asking for his acknowledgment that the Italian Government fully understood their obligation in this matter. Signor Bonomi in his reply n.355 dated 18 June 1945 told me that he accepted the obligation of the Italian Government to keep the Allied Commission continuously and directly informed of all negotiations, either concluded or pending, and further that this information be passed on directly to this Office.

I shall be grateful if I can receive your assurance that this procedure will be adopted by the new Government.

My dear Mr. Prime Minister:

On 18 April in my letter 4001/209, I invited Your Excellency's attention to paragraph three of the side-memoire left with you on 24 February by Mr. Macdilan and myself. This paragraph required that the Italian Government keep the Allied Commission informed of any negotiations in which it might engage with other governments and suggested that a periodic summary be furnished of all negotiations completed and pending with other governments.

In reply I received a letter from your Minister of Foreign Affairs (reference Y/685, dated 30 April), which stated that all discussions of an economic character pass directly through the Allied Commission sub-commission concerned and Allied Commission was thus perfectly well informed. In addition it was stated that negotiations of a political character are published in the official communiques and newspapers at the time they are completed.

This summary handling of the problem is not satisfactory. I must request that in compliance with the intent of the side-memoire which you and your Government agreed, the Commission is to be kept continually and directly informed of all negotiations either concluded or pending and, further, that the information be passed on directly to this office. The Commission does not expect to accumulate this intelligence through perusal of the official communiques and published newspaper announcements. This is an obligation of the Italian Government to the Commission, and I must request that it be carried out in a correct and formal manner.

In your note n. 4001/EC of April 18th, you asked His Ex. the President of the Council for a summary of all the negotiations concluded or still unconcluded with other Governments, in conformity with the MacMillan memorandum of February 24th.

I will briefly sum up the situation.

All the discussions of an economic character go through the Competent Sub-Commission of the A.C. which is therefore perfectly well informed.

In political matters, the only negotiation brought to an end was that with France, about the resumption of direct relations, and the regime of the Italians in Tunis. Official communiques were at that time published in all the newspapers.

Soundings are being made for the resumption of relations with Yugoslavia, and conversations are taking place for the relief of Interned Italians in Poland and Albania.

I want to remind you that the Allies have, as you know, our codes, and are therefore perfectly well informed about all the above mentioned initiatives.

Note Signifying approval of Codes or Cypher No.1.

16th April 1945.

Following Code or Cyphers are approved for use between Foreign Ministry, ROME and Italian Embassy PARIS, subject to the conditions named below.

- 1. Cifrario AR 38, as a brevity code for non-confidential telegrams only.
- 2. Cifrario "IMPERO" with Appendix and Fascicolo di Liste C.D., Serie B and Tabella VITTORIA 3.
- 3. Sistema DEL LIBRO, volume P.G.1 with Tabelle di Numeri Personali No.1 H to 24 H.

In the case of the approval of this material for PARIS the Cypher Security Mission makes the following reservations:

- A. The approval of a system based on the compromised code Impero for PARIS is given in substitution for and not in addition to the approval previously given in principle for the use of such a system for posts in Central and South America.
- B. Since PARIS is on the most recent list in the possession of Cypher Security Mission of posts with which communication in code or cypher is NOT YET PERMITTED to the Italian Government, the approval given by Cypher Security Mission to the use of cyphers or codes for PARIS is conditional upon the appropriate authorities permitting the telegrams to be sent or received at PARIS, a matter which, it must be clearly understood, is not within the duties of the Mission.

My dear Mr. Prime Minister:

You will remember that in the Aide-Memoire left with you on 24 February by Mr. Macmillan and myself paragraph 3 required of the Italian Government that it keep the Allied Commission informed of any negotiations in which it might engage with other governments, and it was suggested that a periodic summary should be furnished of all negotiations completed and pending with other governments.

While it is understood that your Government accepted this proposal, this Commission has in fact never been informed of any such negotiations, nor has it received the suggested summary.

I therefore would ask you, my dear Prime Minister, to give this matter your attention so that I may be kept promptly informed of negotiations in line with paragraph 3 of the above-mentioned Aide-Memoire, and to give your confirmation of your acceptance of this procedure.

I -- ALLIED COMMISSION

1. Announcement of the establishment of the "Allied Control Commission" was made in AFHQ Administrative Memorandum Number 74, 1943, and its redesignation as "The Allied Commission" was announced in Section I, Administrative Memorandum Number 45, 1944.

2. The functions of the Allied Commission as set out in Administrative Memorandum Number 74, 1943, were defined as follows:

- "1. To enforce and execute the instrument of surrender under the orders and general directives of the Allied-Commander-in-Chief.
- "2. To insure that the conduct of the Italian Government conforms to the requirements of an Allied Pass of Operations, especially transportation and communications.
- "3. To be the organ through which the policy of the United Nations towards the Italian Government is conducted and the relations of the United Nations with the Italian Government are handled."
- 3. In accordance with the policy of the United Nations to afford Italy a greater degree of self-government, directives have been received from the Combined Chiefs of Staff that the control of the Italian Government under the Armistice and Surrender Instrument will be relaxed, and will only be exercised when military needs require it, thus developing in the Italian authorities a greater sense of responsibility. The rights under the Armistice and Surrender Instrument will thus be held in reserve in the matter of day to day administration subject always to overriding military needs and the requirements of the campaign in Italy.
- 4. Administrative Memorandum Number 74, 1943, will be interpreted accordingly detailed instructions, in accordance with those received from the Combined Chiefs of Staff in their telegram FAN 487 of 31 January 1945, have been communicated to the Acting President, Allied Commission.

In accordance with the policy of the United Nations to afford Italy a greater degree of self-government, directives have been received from the Combined Chiefs of Staff that the control of the Italian Government under the Armistice and Surrender Instrument will be relaxed, and will only be exercised when military needs require it, thus developing in the Italian authorities a greater sense of responsibility. The rights under the Armistice and Surrender Instrument will thus be held in reserve in the matter of day to day administration subject always to overriding military needs and the requirements of the campaign in Italy.
- 4. Administrative Memorandum Number 74, 1943, will be interpreted accordingly detailed instructions, in accordance with those received from the Combined Chiefs of Staff in their telegram FAN 487 of 31 January 1945, have been communicated to the Acting President, Allied Commission.

Further to my letter No. 723.1 of the 14th March, I have pleasure in informing you that no objection is seen by the appropriate Allied authorities to the carriage of sealed diplomatic bags by officials of the Ministry of Foreign Affairs who occasionally proceed abroad. It would be desirable as you suggest in your letter No. 3/355 of March 3rd that such officials should be furnished with a courier passport to protect their bags from investigation by the Allied military authorities at the place of departure and subsequent points en route to their destination. I should accordingly be grateful if you would be so good as to let me have a specimen of such a document in order that the Allied military authorities may be notified in advance of its existence and be able to familiarise themselves with its appearance.

As regards the question of the granting of undeposited cypher facilities, I much regret that for the time being we must accept the decision of the Allied military authorities that the Italian Government may communicate with their missions abroad only in cyphers of which copies have been deposited with this Commission. I would emphasise that this decision is based exclusively on grounds of military security and assure you that henceforth the only control which will be exercised on telegraphic communications between the Italian Government and Italian diplomatic missions abroad will be military in nature. In other words, there will be no political censorship of the contents of such telegrams. These cypher communications will of course continue to be scrutinised from the point of view of cryptographic security and this practice will continue to be necessary so long as military operations are being conducted in this theatre.

I have now cleared the new arrangement by which the Italian Political Representative (Ambassador) in London may send telegrams through the normal commercial channels, without our insisting upon a copy of the cypher telegram being given to the Allied Commission. As regards cable communications in undeposited cypher I cannot refrain repeating to you, my dear Admiral, our deepest disappointment for the deferment of a favourable decision on the matter - I am sure you will agree with me that the direct diplomatic relations between Italy and other States will remain partly unfruitful and devoid of practical contents until the Italian Government and their Representatives will be accorded free cypher facilities.

Outgoing telegrams from Italian F.O. to Italian Ambassador in London will have to continue to be shown to the Allied Commission before despatch as hitherto."

Mr Macmillan suggests that you and he should inform the Italian Prime Minister of this when you call upon him tomorrow.

The newly appointed Italian Ambassador at Washington is taking with him a cypher approved by A.F.H.Q. who say there is no objection from their point of view to his being given the same privileges as the Italian Ambassador in London.

8. CYPHER AND BAG FACILITIES FOR THE ITALIAN GOVERNMENT
(Paper No. SAC (F) (45) 6 and Addendum)

THE CONFERENCE had before them a paper recommending that undeposited cypher facilities should continue to be denied to the Italian Government and that, in principle, secret bag facilities should be granted to the Italian Government for use in correspondence with their representatives abroad, together with the views of the British Resident Minister on this matter.

LIEUTENANT GENERAL HARDING explained that, on grounds of military security, it was strongly felt that cyphers should not be used by the Italians. There was, however, no military objection to the use of secret bag facilities. In reply to a question by Rear Admiral Stone, he confirmed that Italian Government bags would be given the same facilities for transport on Allied communication aircraft as Allied bags.

MR. KIRK observed that the Italian Government held in general a high opinion of the security of their cyphers and that it was difficult to explain to them why agreement to their use of cyphers was refused on grounds of military security.

MAJOR GENERAL AIRY replid that, whatever the views of the Italian Government might be on this matter, it was the experience of the Allied forces (whose enemies the Italians had once been) that Italian cyphers were not in fact secure.

THE SUPREME ALLIED COMMANDER:

THE CONFERENCE had before them a paper recommending that undeposited cypher facilities should continue to be denied to the Italian Government and that, in principle, secret bag facilities should be granted to the Italian Government for use in correspondence with their representatives abroad, together with the views of the British Resident Minister on this matter.

LIEUTENANT GENERAL HARDING explained that, on grounds of military security, it was strongly felt that cyphers should not be used by the Italians. There was, however, no military objection to the use of secret bag facilities. In reply to a question by Rear Admiral Stone, he confirmed that Italian Government bags would be given the same facilities for transport on Allied communication aircraft as Allied bags.

MR. KIRK observed that the Italian Government held in general a high opinion of the security of their cyphers and that it was difficult to explain to them why agreement to their use of cyphers was refused on grounds of military security.

MAJOR GENERAL AIREY replied that, whatever the views of the Italian Government might be on this matter, it was the experience of the Allied forces (whose enemies the Italians had once been) that Italian cyphers were not in fact secure.

THE SUPREME ALLIED COMMANDER:

(a) Directed that undeposited cypher facilities should continue to be denied to the Italian Government, but that in principle secret bag facilities should be granted to the Italian Government for use in correspondence with their representatives abroad, and that the Chief of Staff and Chief Administrative Officer take appropriate action in accordance with this Policy.

(b) Instructed the Chief Commissioner, Allied Commission, to inform the Italian Government of the policy laid down under (a) above.

Your minute of the 14th February, CS/104.

I understand the position is as follows :-

(1) You will not permit outgoing cypher messages to be sent by the Italian Government to its representatives abroad.

(2) You are prepared to agree to bag facilities both inwards and outwards. I am most grateful for this concession, which I think will have a very good effect, and I am glad that you are able to accept the limited risk involved.

2. There is one further point. At present the Italian Ambassador in London, who holds a cypher approved by us, takes his cyphered messages to the Foreign Office to be despatched. This naturally somewhat cramps his style on reporting, interviews, etc. I am informed that AFHQ have no objection to his sending them direct to the Italian Foreign Office in Rome through the normal telegraphic channel. It has been the practice to give a copy of the cyphered telegrams to the Allied Commission so that it may check incoming messages. I take it that you see no reason for insisting upon this on security grounds, and I propose to abandon it on political grounds. Outgoing telegrams will, however, be shown to the Allied Commission as before.

With reference to the Paragraph on the Political Section in the Minutes of the Meeting on February 2nd to discuss the C.C.S' Directive (FAN 487), I feel very strongly that the abolition of the Political Section should be construed to mean that the Allied Commission should cease to act as, so to speak, the Ministry for Foreign Affairs of the Italian Government. In other words, the Commission would abandon its political functions altogether in so far as foreign countries are concerned and would merely retain them, as the Directive points out, for the purpose of safe-guarding Allied, i.e., Anglo-American, interests on matters of major policy.

This would mean in practice that Governments not in relations with the Italian Government would be forced either to resume such relations or to adopt some compromise procedure such as the appointing of Consuls-General, as the Dutch and Belgians have done, or merely maintain relations with the Italian Ministry for Foreign Affairs on an unofficial basis. This would cut both ways, as both the Italians and the foreign countries concerned would be deprived of the good offices and assistance of the Allied Commission which they have heretofore enjoyed, but it would be a step in the direction of normality and it would tend to force both the Italians and foreign countries concerned to compromise in order to secure the satisfaction of their needs.

1. Concurrence has now been received from the Combined Chiefs of Staff to the proposals contained in MAT 469 (a copy of which was sent to you under reference G-5: 387.4-1 of 19 December) namely that it is not yet advisable to allow the Italian Government to communicate with their representatives abroad in cipher undeposited with and not approved by the Allied Authorities and that the Italians can only be allowed bag facilities subject to their contents being disclosed to the Allied Authorities before despatch.

2. In the same cable CCS give adherence to the principle that bag and cipher facilities are not to be allowed at the present time to neutrals represented in Italy with the exception of the Swiss who are allowed facilities for a diplomatic bag. Subject to this there is no objection to neutrals in Italy having direct relations with the Italian Government providing the Allied Commission is kept informed as they are in the case of the relations of governments of the United Nations with the Italian Government.

3. It is requested that you act in accordance with the above and issue such instructions as may be necessary. For your information it may be stated that the possibility of relaxing or doing away with the restrictions on the Italian Government communications is being reviewed at the direction of the Chief of Staff this HQ and you will be kept informed of the position.

1. Under date 23 August 1944 instructions on the above subject were issued by this Headquarters (letter AFHQ OFF C/S, AG 387/045 GEG-O) which reviewed in some detail the function of the Advisory Council for Italy as well as the relations between the Allied Control Commission and the Italian Government. It is now desired to amplify those instructions, particularly with respect to paragraph 3. While any formal communications, especially if they look to executive action, must pass through the channels of the Allied Control Commission, it is not intended to curtail informal contacts between the Italian Ministers and members of the Advisory Council of a nature to keep the latter informed of current Italian affairs.

2. In saying that it is desired that you take occasion to bring up with the Italian Government the matter of its relations with the Allied Control Commission, it was not intended that a formal demarche be made; you may in your discretion present the matter quite informally.

3. As to the relations ^{with} between the representatives of neutral Governments accredited to the Government of Italy, the Combined Chiefs of Staff have given the following instructions. While there will be no objection to neutral representatives having unofficial dealings directly with the Italian Government, it is to be understood that their formal official relations must be conducted through the Allied Control Commission. It has been established that the representatives of members of the United Nations shall deal with the Italian Government through the Allied Control Commission; it is considered that neutral nations should not be in a more favorable position.

Functions of the Economic Section Sub-Commissions
in relation to the Italian Government.

Agriculture Sub-Commission.

Formulate policies and plans for revival of agriculture, forestry, and fishing, to secure maximum production of these industries and provide administrative supervision of operations of Italian Ministry of Agriculture.

Commerce Sub-Commission.

Advise and assist appropriate organizations and agencies of Italian Government on administering and reviving the commercial economy of the country. Administering control of prices of all non-subsistence commodities and rationing and control of goods, etc. on short supply. Responsible for exports.

Finance Sub-Commission.

Initiates and develops in conjunction with Ministry of Finance and Ministry of Treasury, Bank of Italy, Social Insurance Institutions, etc., policies, plans and procedures for restoration and maintenance of ordered financial and economic conditions, stabilized currency, and anti-inflation measures. Controls Italian Financial Institutions. Maintains records as to Italian indebtedness to Allied Nations and vice versa.

Food Sub-Commission.

Advise and direct, and exercises administrative supervision over Italian Government on equitable food distribution by price controls and rationing systems and controlling distribution of essential imported foodstuffs and local food supplies.

Industry Sub-Commission.

Formulates recommendations as to policies and plans concerning Italian industrial production, re-activation of normal exporting industries and rehabilitation of essential industries. Maintaining close liaison with Ministry of Industry, Commerce and Labour and supervises execution by Italian Government of instructions from I.C.C.

Labour Sub-Commission.

Supervises the policy, organization and administration of all labour activities and exercising controls essential to the needs of the Allied war effort. Advise Italian Government on revision of Italian Labour legislation, formation of free association of employers and employees and for arbitration between them. Supervises all activities of labour exchanges.

Public Works and Utilities Sub-Commission.

Assumes responsibility from Armed Forces for reconstruction and maintenance of roads and bridges, maintenance and repair of power plants, pumping installations, etc. Through Italian agencies arranges for rehabilitation, reconstruction or repair of public works, public utilities, (Electricity, Gas water, etc). Advise and exercises supervision over Ministry of Public Works.

Supervises the working of the Italian ship operating committee known as Cogona. Liaison with the Mediterranean Shipping Board.

Transportation Sub-Commission.

Arranges with MRS rail transport to meet essential civil needs in areas under Army control. In other areas exercises supervisory and advisory duties to ensure maximum use of limited rail and road facilities. Planning and liaison with Italian Ministry of Communications on future needs and policy of shipping in coastal waters and inland waterways. In conjunction with Italian Government, control and distribution of coal.

Functions of Administrative Section Sub-Commissions

Property Control Sub-Commission.





When territory is handed back to the Italian Government the staffs of the Regions can be and are reduced but are not withdrawn altogether, primarily because where Allied troops and Allied installations exist, it is necessary to have Allied Officers of the ACC ready to assist the military authorities in their relations with the local Italian authorities; secondarily because the Provincial Governments still need encouragement and practicable help in matters of supplies, transportation, etc.

19. The R.C. & M.C. Section (Regional Control and Military Government Section) is headed by the Executive Commissioner, Brigadier M.S. LUSH, who is also a Vice President. In addition to the Regions and Army AMG Areas the Executive Commissioner has the following branches, etc., under him; they and the work they do, are:-

These Sub-Commissions are responsible for formulating and implementing policy and for day to day administration within the spheres of their Ministries.

21. The first three of these Sub-Commissions are responsible for the reconstruction within the policy limits laid down by the CCS of the Italian Armed Forces.

22. The last named is responsible for the reconstruction of communications (telecommunications, posts, telegraphs) and is concerned primarily with the development of military communications and secondarily with the development of civilian means of communication.

20. The INDEPENDANT SUB-COMMISSIONS directly under the Chief Commissioner and the Ministries with which they deal, are:-

These Sub-Commissions are responsible for formulating and implementing policy and for day to day administration within the spheres of their Ministries.

22. The last named is responsible for the reconstruction of communications (telecommunications, posts, telegraphs) and is concerned primarily with the development of military communications and secondarily with the development of civilian means of communication.

PART II.

THE ORGANISATION AND FUNCTIONS OF ACC IN THE FIELD.

23. Policy is framed in the Administrative, Economic and Political Sections under their Vice Presidents in consultation with each other and the Chief Commissioner. This policy affects and is affected by external matters and the interior, political and economic situation in the country. The execution of policy is carried out by teams of Allied Officers both administrative and technical, in the field. In order to decentralise the work of the ACC in the field, the territory has been divided up into Regions under the command of Regional Commissioners. At present there are six Regions, viz., Region I (Sicily), Region VI (Sardinia), Southern Region (Calabria, Apulia, Lucania, Campania), Region IV (Lazio, Umbria and Rome), Region V (Abruzzi, the Marches), Region VIII (Tuscany).

24. In order further to decentralise, these Regional teams are divided into Provincial teams, each under an Allied Provincial Commissioner. The Regional Commissioner and the Provincial Commissioner have under their command Provincial Officers who deal with local Governments, police officers, legal officers, supply

16. As an example of our increasing close relationship with the Italian Government we have evolved a system whereby the decrees passed by the Italian Government are almost invariably made operative by us in Military Government territory. That this is possible is a tribute to the co-operation between ACC and the Italian Government in the planning of decrees. In this connection it should be mentioned that the policy of ACC is that except in certain cases where where military necessity dictates policy (e.g. restrictions of movement) the Italian Government are the planners and draftsmen of decrees and ACC are advisers on the general policy to such decrees.

17. The ADMINISTRATIVE SECTION whose Vice President, LORD STANSFORD, is not at present in Italy, is under the command of Colonel G.R. UPJOHN as Acting Head. It is responsible for co-ordinating the work of the seven Sub-Commissions and for planning general policies. Its Sub-Commissions and the Ministries with which they correspond are:

- 9. A diagrammatic representation of the organisation is at Appendix "A".
- 10. Before discussing the policy forming functions of these bodies it is desirable to specify the limitations under which ACC acts. ACC was formed primarily for the purpose of carrying out and supervising the Armistice Terms. Directives and the passage of time have imposed upon it further functions. In the first place in January last ACC assumed all functions previously carried out by the Allied Military Government in occupied territory and thereafter has been responsible for Allied Military Government in the territory not yet restored to the Italian administration in accordance with the Hague Convention and the recognised rules of International Law as modified by the Armistice Terms. Secondly its functions have to some extent been modified by directives from time to time received from Combined Chiefs of Staff.
- 11. The principles on which ACC is working are as follows:
 - (a) that long range commitments will not be made; in Italian Government territory
 - (b) that the ACC will act through the Italian Government and not itself assume the functions of government of liberated territory; and in such territory, subject to operational needs, it will in general administer Italy by Italian officials under Italian Law and through Italian Courts;
 - (c) that the means by which the Italian Government reaches the desired end is a matter domestic to that Government;

This subject is dealt with in greater detail in Part II hereof.

- 13. In Army areas policies formulated by the Chief Commissioner are in theory paramount but it is not possible or desirable to place all into effect at once. Only those of first importance to operations are brought into force, as may be expedient according to the course of operations and the requirements of the Army.
- 14. As conditions become more settled, the extent to which these policies are carried out extends until in the Regions under Military Government they are all in operation. In these areas the responsibility is full and can be implemented by direct order and extends to the actual administration of the territory.
- 15. In Italian Government territory the responsibility becomes that of the Italian Government; but, apart from matters covered by the Armistice Terms as to which we can require compliance, ACC functions by giving advice and the Italian Government has been found to be most co-operative as to this.

1. It seems desirable at this time to recall and emphasize certain essentials in the relations between the Allied Control Commission and the Italian Government. The Commission, representative of the United Nations, is charged with regulating and executing the conditions of armistice with Italy; it is the organ through which the policy of the United Nations toward the Italian Government is conducted and the relations of the United Nations with the Italian Government are handled. The Commission is placed under the orders and general directions of the Supreme Allied Commander, who is represented by the Deputy President and Chief Commissioner. The Deputy President is accordingly the executive head of the organization. The Commission is divided into Subcommissions, each having knowledge and competence in a particular category of matters.

2. The Advisory Council for Italy was subsequently created with terms of reference approved at the Moscow Conference, and attached for advisory functions to the Commission. The Council is to "keep itself closely informed of current Italian affairs"; it will "advise the respective Governments ..."; the Council has "the duty in particular of watching the operation of the machinery of control"; it will "advise the Allied Commander in Chief in his capacity as President of the Allied Control Commission on general policy connected with the work of control"; for this purpose it will "have the right to ask him for information or explanations on matters relating to the Council's work." Upon examination of its terms of reference it becomes apparent that the Council is in direct contact with the Allied Control Commission, and that its members may make joint or several representations to their Governments. It is not in direct contact with the Government of Italy.

3. It is desired that you take occasion to point these essentials to the attention of the Italian Government, making it clear that its approach must be directly to the Control Commission; to the Advisory Council or its members it has no direct channel or privilege of access. Any representation which the Government may wish to make to another Government must accordingly be effected through the executive part of

Attitude toward Italian Officials

12. The members of the Commission, whether acting officially or otherwise, should maintain a correct attitude toward members of the Italian Government, neither autocratic on the one hand nor familiar on the other.

It must be emphasized that the Allied Control Commission occupies a position in relation to the Italian Government which is quite different from that of Allied Military Government. The Commission advises and supervises; it does not govern. This fundamental difference must be thoroughly understood by all officers, who will adjust accordingly their attitude toward Italian officials and agencies, allowing them to develop their functions without undue interference.

If basic differences arise between officers of this Commission and the corresponding representatives of the Italian Government, the matter at issue will be submitted to the Chief Commissioner for adjustment with the Head of the Italian Government.

Government operating in the field will be coordinated by this headquarters.

- 1. The Allied Control Commission will operate from Headquarters.
- 2. All communications between the Allied Control Commission and the governments of the United Nations will be transmitted through this headquarters.
