Italian custom activity will be resumed in all areas not specifically reserved to Allied Naval or Military operations, and to the latter as and when they are released. The Finance Officers will maintain liaison between Army and Navy operations Officers and the Italian Customs service, to the end that a continuous customs barrier may be maintained on the perimeter of reserved areas.

Close contact with the principal Italian Customs Officer of the Region will be maintained.
