Dear Admiral Stone,

In the last few days, some newspapers of the Capital published the news that Hitler had ordered all interned foreigners to be shot before the allied liberating armies reached their concentration camps.

This Ministry had informations which confirmed that the Italian officials who refused to co-operate with the Germans, and the interned Jews had been killed in mass by the retreating German troops.

These news greatly alarmed the Italian families which have relatives in Germany.

I want to give you these news at once so that you will kindly see whether it is possible to ask the Allied Governments to give a new and public warning to the German authorities, through whatever channel they will deem most advisable, against committing again such crimes, and threatening reprisal from the Allies and the punishment of those who are responsible.

On its side, the Ministry of Foreign Affairs has already asked for the intervention of the Central Committee of the International Red Cross in Geneva, asking it to do what it can to prevent such atrocities from happening again.

With many thanks, I beg you, my dear Admiral, to let me know the result of your intervention with the Allied Governments.

MINUTES OF THE 26th MEETING
OF THE ADVISORY COUNCIL FOR ITALY

Dicember 1st, 1944

EXTRACT

4. German Atrocities in Northern Italy. (13)

The Chairman noted that at the 24th meeting of the Advisory Council for Italy, the Council, in consideration of Sir Noel Charles' inquiry, had transmitted a communication to Allied Force Headquarters suggesting the desirability of giving wide-spread publicity to General Alexander's public warning to the Germans. He reported that the Council had received a reply from Lt. General Gammell reporting that such publicity had been given to General Alexander's warning at the time of its release. Lt. General Gammell's letter, referred to by the Chairman, reads as follows:

 - c. It was also repeated broadcast from Rome on short waves beamed to Germany and was fully covered by the whole liberated Italian medium broadcasting system.
 - d. It was dropped in leaflet form in enemy territory and among front line German troops in Italy.
- It will thus be seen that the widest possible publicity has already been given to the warning.

"Ottawa, November 17, 1944."

He stated that in view of the Italian Government's position outlined in this note it might be well for the Council to adjourn consideration of this problem until such time as a further communication had been received from the Italian Government.

The Council accepted the Chairman's suggestion.

4. German Atrocities in Northern Italy

The Chairman noted that subsequent to the last meeting Commodore Stone informed the Council of a public warning issued by General Alexander on October 19th to the Germans on the subject of atrocities committed by them in Northern Italy (See Appendix 1). He then noted that in reply to this communication Mr. Kirk, as Acting Chairman of the Advisory Council, has addressed a note to Commodore Stone, on behalf of the Advisory Council, requesting Commodore Stone to ascertain from the Italian Government whether, in view of General Alexander's public warning, it still considered that an urgent intervention of the United Nations in this matter was desirable (See Appendix 2). — (10)

Mr. Kirk inquired from Commodore Stone whether he had been able to sound out the views of the Italian Government in this connection. (11)

Commodore Stone replied that he had written the Italian Government, but had received no reply. He believed that the Italian Government still desires the issuance of a statement on this subject by the Governments concerned. (12) 1/3

The Chairman then suggested that the Council await reply from the Italian Government before proceeding further with the consideration of this problem.

M. Couve de Murville stated that if the Italian Government wished further action in this matter then the Council could consider the draft of the resolution on this subject which had been circulated to all Representatives. (See Appendix 3).

Sir Noel Charles inquired whether the Council would consider it desirable that wide publicity be given to General Alexander's warning and suggested its release to the international press.

Mr. Kirk suggested that perhaps the best way to achieve this objective would be to suggest to the Supreme Allied Commander that AFHQ should initiate the necessary steps for such publicity and proposed that a communication to this effect be drafted by the Secretariat. (See Appendix 6.). 16 17 18

MEMORANDUM FOR THE POLITICAL SECTION, A.C.

To the German atrocities already reported by the Ministry of Foreign Affairs to the Political Section, A.C. in previous Memoranda, must be added the horrible mass murder of the almost entire population of St. Anna di Stazzema (about 600 inhabitants) by the German S.S., on August 12th last.

The following particulars have now come to hand :

" On the pretext that a German soldier had been killed, in circumstances not clearly specified, about 300 S.S., subdivided into squads, entered the village and immediately began the massacre. The men were absent as they had fled in order to avoid the law on forced labour. The first squad of murderers ordered out of their homes about 100 old people, the women and children and sent them out of the village, but as soon as these unfortunate people were grouped on the road, a German Officer fired his tommy-gun, killing five women. The others immediately entered the two nearest houses to save themselves. The Germans then made fast the doors and from the windows dasrtardly attacked the unfortunate inmates with hand-grenades and flame-throwers. Not less than

The following particulars have now come to hand:

The first squad of murderers ordered out of their homes about 100 old people, the women and children and sent them out of the village, but as soon as these unfortunate people were grouped on the road, a German Officer fired his tommy-gun, killing five women. The others immediately entered the two nearest houses to save themselves. The Germans then made fast the doors and from the windows dastardly attacked the unfortunate inmates with hand-grenades and flame-throwers. Not satisfied with this, the bloodthirsty Germans extracted the bodies from the two houses (some of them still alive) and after having tied them to the railings surrounding a Cross on the square, fired against them hundreds of shots. They then crowded Church pews and furniture round the bodies, setting fire to the tragic heap. The other squads meanwhile had not been idle; rushing

about the village they set fire to the houses, massacring all those that had taken refuge.

At the end of the horrible massacre, 514 bodies were collected in the village; other bodies were found amongst the ruins of the demolished homes and among the remains of the pyres. *G.H.P.*



Dear Mr. Goshie:

With reference to the discussion at the Advisory Council on the 20th October about German atrocities in Northern Italy there has just come into my hands a copy of a public warning from the Commander-in-Chief, Allied Forces in Italy, on this subject. I enclose a copy of this warning which was broadcast by P.W.B. on the 19th October and which will be further disseminated in leaflet form. It appears that the whole question had been brought to the attention of General Alexander through other channels not only in his capacity as Commander of allied operations at the Front but also as Commander of Patriot activities behind the lines. In view of the immediate action which General Alexander has taken on the evidence presented to him, the Advisory Council may wish to reconsider the term of the recommendation which they had intended to forward to the Supreme Allied Commander, Mediterranean.

WARNING

to German officers and men

by General Sir H. R. Alexander, Commander in Chief,

Allied Armies in Italy.

1. Reports of atrocities - killings of hostages, mass reprisals against innocent civilians, torturings and the like - committed by German troops in Northern Italy are becoming daily more frequent.
2. I therefore call the attention of all German officers and men in Northern Italy, who otherwise might give or carry out orders to commit such atrocities, to the following:
3. The fact that in, for example, a certain village Italian patriots - whether or not wearing uniforms, arm-bands or other recognizable insignia - may have attacked German soldiers is not, according to the Jus Gentium or any other Legal or moral code, a justification for collective reprisals upon the population of the village, nor for the killing of persons without due legal trial and conviction.
4. Officers or men giving or carrying out orders for such acts are war criminals.
5. In accordance with the agreement made between the governments of Great Britain, the Soviet Union and the United States of America at Teheran in November 1943, it is provided that all German officers and men who are accused of committing war crimes shall immediately after the war be returned to the countries in which they are accused of having committed these crimes, to be tried according to the laws of these countries.
6. I have ordered all Italian patriots and Italian civilians in German-occupied territory to make careful, written note of the names, units and other particulars of German officers and men who have given or carried out orders for the commission of the crimes.
7. As a result of this order, names and particulars have been reported to my Headquarters of German officers alleged to have been accessories to, amongst many others, the following war crimes:

On March 24th 325 Italians taken from prisons in Rome were
murdered by SS troops in the Ardeatine caves near the Via Appia Antica.

Between the 14th and 19th of April, 1944, troops of the Hermann
Goering division carried out a massacre in the commune of Stia. Of the
103 bodies which were recognisable on recovery; 50 were women, 15 children
under 15 years old, and 5 children under 4 years old. An old woman of 84
and a baby of 6 months were among those shot.

On the 21st of June troops of the 85 Mountain Regiment murdered
15 civilians in Camerino.

On the 29th of June troops of the Hermann Goering Division entered the village of Civitella in the Val di Chiana and began a systematic destruction of the village with flame throwers and grenades. The villagers were mostly in the church at the time; the women and children were taken out and driven to the woods; the men, including the 80 year old priest, were machine-gunned, and their bodies thrown on the burning buildings.

On the 2nd of October German troops in the village of Roncastaldo hacked to death 8 Italians with axes.

8. All information received of such alleged atrocities or war crimes in recorded at my Headquarters, and is thence transmitted to the Italian Government and to the Allied War Crimes Commission.

(4) The Chairman stated that this item was included on today's agenda at the request of the Supreme Allied Commander in a note dated October 9, 1944 addressed to the Advisory Council for Italy and stated that copies of this note had been transmitted to all Representatives on the Council. He noted that the decision of the Allied Governments to punish persons responsible for atrocities had been announced and published repeatedly, referring particularly to the November 1, 1943 announcement signed by President Roosevelt, Prime Minister Churchill and Marshal Stalin regarding atrocities. He stated that it was questionable whether a mere reiteration of this decision without the basis of supporting evidence of concrete facts may be considered advisable and indicated that such a statement might even subtract from the force of the original statement. He expressed the opinion that this connection suggested to the Council that it request from the Supreme Allied Commander, for transmission to the respective Governments represented on the Council, a detailed report on atrocities committed by the Germans in Northern Italy. Upon receipt of this report, the Governments concerned could issue, if they so desired, a joint statement again warning the Germans in this matter.

Sir Noel Charles stated that in his opinion the inclusion of a list of atrocities would make a published warning decidedly stronger and supported the Chairman's proposal.

The Chairman stated that if the other Representatives approved the Council could request the Supreme Allied Commander to transmit all available data on this subject.

The Chairman pointed out that it was the desire of the Supreme Allied Commander that the Council consider this matter with a view to advising upon the best means of inducing the Germans to stop these atrocities, which had increased recently to an appalling extent. He noted that the decision of the Allied Governments to punish persons responsible for atrocities had been announced and published repeatedly, referring particularly to the November 1, 1943 announcement signed by President Roosevelt, Prime Minister Churchill and Marshal Stalin regarding atrocities. He expressed the opinion that a new warning citing recent atrocities might be effective and in this connection suggested to the Council that it request from the Supreme Allied Commander, for transmission to the respective Governments represented on the Council, a detailed report on atrocities committed by the Germans in Northern Italy. Upon receipt of this report, the Governments concerned could issue, if they so desired, a joint statement again warning the Germans in this matter.

Sir Noel Charles stated that in his opinion the inclusion of a list of atrocities would make a published warning decidedly stronger and supported the Chairman's proposal.

The Chairman stated that if the other Representatives approved the Council could request the Supreme Allied Commander to transmit all available data on this subject.

Commodore Stone pointed out that the Supreme Allied Commander requested for the Council to consider this problem originated from information presented by the ACC.

The Chairman pointed out that the ACC information was presumably based on data furnished by the Italian Government and stated that the Supreme Allied Commander could obtain and might have available information from other sources as well.

Commodore Stone then read into the record a list of atrocities committed by the Germans, which was compiled by the Italian Government. (For copy of this list see Appendix 2).

The Chairman mentioned that he had also heard about atrocities at Sant'Anna in Tuscany where the Germans had massacred 400 inhabitants out of a total of 500. He suggested that it might be well to combine information received from the Italian Government with that received from the Supreme Allied Commander so that complete data may be submitted to the proper authorities.

ACTIONS OF RETALIATION CARRIED OUT BY THE GERMANS AGAINST THE
SICILIAN POPULATION IN OCCUPIED ITALY

It is impossible for the moment to furnish complete data as the informations which reach the Italian Government are necessarily fragmentary. The facts reproduced in this note are exclusively those which have been controlled beyond all doubts. Naturally they are largely inferior to reality. Only after the liberation of all the national territory it would be possible to complete them so as to give a full account of the atrocities carried out in such great numbers by the Germans in Italy.

IN PIEDMONT: killed, 613 men, 27 women, 11 children; deported to Germany, 3,250 men; two villages destroyed; 50 farms burnt.

Retaliations in which the spirit of cruelty of the Germans was put into particular evidence: on the 9/9/43 the Germans, after having machine-gunned the population of Boves (Cuneo) burnt the parish priest alive in the square, killing another one whilst he was administering the Sacraments; the 24/7/44 the village of Ceva was completely burnt and the population in flight was machine-gunned by the Germans.

In LOMBARDY: killed 933 men, 303 women, deported to Germany 1,300 men.

Retaliations in which the spirit of cruelty of the Germans was put into particular evidence: In November 1943, at Marchirolo (Varèse) shot 8 civilians, some of which were buried alive; the 15/7/44 at Bergamo, the Germans omitted, for retaliation, to sound the alert as a result of which about 1,000 workmen perished in a factory during the air raid.

IN VENETO - TREVISO - VENEZIA GIULIA - killed, 79 men and 5 women.

Retaliation in which the spirit of cruelty of the Germans was put into particular evidence: on the 19/7/44 at Triest, 15 civilians were handed to the trees in the road and were left exposed for several days.

IN THE MARCHE: killed, 55 men, 6 women, 2 children.

Retaliations in which the spirit of cruelty of the Germans was put into particular evidence: on the 2/6/44, Lt Filippini, chief of a Band of Partisans, presented himself to the German military authorities so as to take on himself the responsibility of some incidents which took place at Calderola (Macerata) against the Germans and therefore avoid retaliations against the civilian population: he was hanged and the retaliations were carried out just the same.

IN TUSCANY: killed, 847 men, 72 women, 32 children.

Retaliations in which the spirit of cruelty of the Germans was put into particular evidence: on the 20/6/44, at Civitella della Chiara (Arezzo), 250 civilians on the 350 inhabitants of the entire village were shot; on

the 14/7/44, at Molin dei Falchi (Arezzo) 48 civilians, after having been tortured were blown up with dynamite and the Germans prevented the priest from providing for the burial.

Reports of these last days point out that the atrocities committed by the Germans in northern Italy increase daily in number and gravity, particularly in the immediate rear of the front. The Germans, in preparation of the imminent retreat, carry out operations of repression against the patriots on a scale unheard of until now.

It is reported that in the city of Bologna, about 10,000 persons have been deported by the German and Fascist authorities. Also at Bologna, Padua, Ferrara and Verona, Triest, and numerous other localities of Northern Italy, scores of patriots and of hostages have been shot in the course of these recent weeks. In several cases their bodies were left exposed to the public and the religious authorities were prevented for several days from giving them burial.

At Triest, the execution of 7 Germans carried out by the patriots was recently revenged by the murder of 77 Triestini, hanged to the trees of one of the most important streets of the town.

On the 24 September ult. near Bologna, 7 patriots were condemned for anti-German activity by court-martial and immediately shot. For the same reasons, on the same day, 4 patriots were shot at Reggio Emilia and other ten at Turin.

At Triest, the execution of 7 Germans carried out by the patriots was recently revenged by the murder of 77 Triestini, hanged to the trees of one of the most important streets of the town.

On the 24 September ult. near Bologna, 7 patriots were condemned for anti-German activity by court-martial and immediately shot. For the same reasons, on the same day, 4 patriots were shot at Reggio Emilia and other ten at Turin.

Subject : German atrocities

Following activities of civilian groups, German retaliation in the Casoli area have assumed the complexion of real and true ferocity. There are numerous cases of civilians shut up in buildings and liquidated with hand grenades, with no attempt to respect women and children.

One young man of 22, arrested by German troops because of his attempt to cross the lines in the Casoldi area, was bound and cast alive into a burning house (source: town people of Casoli)

In the locality of Madonna Delle Rose, on the road between Lama dei Peligni and Torricella on 18 Jan 44, were found the corpses of two little shepherds a boy of 12 and a girl of 10, slain on 10 Jan 44 by the Germans shot with revolvers while they were carrying piles of straw (source: Porreca Domenico of Fallascoso - Chieti -- reliable)

On 21 January, at 0500, a German patrol of 12 men approached a group of rural huts in the S. Agata section (Valley of the Aventino river) and precisely a 2 room house (kitchen and stable) where several families were living (names of Diluzio - Cianna, etc.) They ordered everybody out of bed, and forced the occupants of the other huts, women, children and old men, totalling about 30 to come in; the Germans then tossed hand grenades inside the room. After a while they entered the room to make sure that all civilians were dead by touching the bodies with burning pieces of wood. One of the victims, Di Luzio Niccoletta of the late Domenico, of Torricella Peligna, 16 year old, a war orphan, was covered by the corpse of her mother, Maria Cianna of Cincent 37 years of age; she suffered severe neck burns, to which she submitted without giving signs of life. As soon as the Germans departed she fled and got to the British lines, where she was given first aid and taken to the civilian hospital at Casoli; she was still there on 23 January.

Those who perished were: Di Luzio Vincenzo 14; Di Luzio Leonardo, 9; Cianna Camillo, 35; Porreca Rosina, 30; Cianna Euro, 10; Cianna Anna Maria, 6; Cianna Annita, 4; Di Marco Teresina, 11; Di Marco Gabriele, 8; Coladonato

At Torricella Paligna, on 14 Jan 44, at the farm of a Felicia Ficca, the Germans gave orders to vacate the premises immediately.

When they saw the women come out with blankets and other effects, the German soldiers killed 12 of the women and children with hand grenades. An 8 months old baby girl, who escaped death, has been taken to Altino, in the S. Angelo section (source: Porreca Domenico of Folla Scosochieti)
