1. The second meeting of the Committee on Contract Clauses convened at 1000 hrs on WEDNESDAY 6 DEC 44 in the G-4 (A) Conference Room AFHQ.

5. It was recommended:
 - (a) That the clause shown in Appendix "A" be adopted for general use by the Services, subject to approval by the Joint Military Financial Committee.
 - (b) That no other clauses should be adopted for general use.
6. No date was set for the next meeting.

APPENDIX "A"

PAYMENT OF CONTRACTORS' EMPLOYEES

1. The total amount paid by contractors to their employees for:

- a. Base Pay (Retribuzione Ordinaria)
- b. Presence Indemnity (Indennita' di Presenze)
- c. Cost of living Indemnity (Indennita' di Carovita)
- d. Family Allowance (Assegno Familiare)
(Element payable by contractor)

will not exceed the Allied Forces daily maximum rate for the particular occupation, except in cases of employees regularly employed by the firm on a piece work basis. Such cases will be declared by the contractor and any reasonable necessary excess over the maximum daily rates of pay may be approved.

2. a. The contractor will be required to pay the proper agencies the employers' contributions for:

- Sickness Assistance (Assistenza Malattia)
- Social Insurance (Assicurazione Sociale)
- Accident Insurance (Assicurazione Infortuni)
- Salary Integration Fund (Cassa Integrazione)
- Fund for workers called to arms (Cassa Richiamati alle Armi)

b. The contractor will also be required to pay the amount of employees' contribution for:

- Sickness Assistance (Assistenza Malattia)
- Social Insurance (Assicurazione Sociale)

which contributions will not be deducted from employees' pay.

3. The contractors' estimate or bid will consider payment for family allowances of only 20 percent of the base pay, the contractor being reimbursed by the State for the remaining cost of such allowances.

4. The contributions prescribed by Italian law for the benefits described in paragraph 2 hereof will be calculated on the base pay, and overtime where applicable.

E X T R A C TII -- JOINT MILITARY FINANCIAL COMMITTEE

1. A Joint Military Financial Committee is hereby established with the following composition and terms of reference:

a. Composition:

Chairman - Chief Administrative Officer, AFHQ.
Vice-Chairman - To be nominated by the Chairman.

Members:

Colonel Bernstein- Financial adviser to the North African Economic Board.
Colonel Sims - Finance Officer, AFHQ.
Brigadier Tunlop - Financial Adviser (Br.) to the Chief Administrative Officer, AFHQ.
Brigadier Rabino - Currency Adviser to the Chief Administrative Officer, AFHQ.
Representative of- The General Purchasing Agency of the Military Department of the North African Economic Board.

Secretariat:

To be provided by the Financial Adviser (Br.) to the Chief Administrative Officer, AFHQ.

b. Terms of Reference: The Joint Military Financial Committee will:

- (1) Insure the close regular coordination of Allied military financial policy in the North African theater.
- (2) Issue such instructions as are necessary to spending.

b. Terms of Reference: The Joint Military Financial Committee will:

- (1) Insure the close regular coordination of Allied military financial policy in the North African theater.
- (2) Issue such instructions as are necessary to spending Special Staffs and Services as will insure this coordination, with particular reference to financial relations with public bodies, contractors, owners of hired premises and like agencies.

2. In the discharge of these duties, the Joint Military Financial Committee will work in close cooperation with the Civil Department and the Military Department of the North African Economic Board and will insure that its military policy is in agreement with the broader policies set by the North African Economic Board. To assist to this end, the members from the

Military and Civil Departments of the North African Economic Board are charged with the additional duty of liaison between the two bodies.

3. All instructions issued by the Joint Military Financial Committee will be issued through the normal procedure for the publication of AFHQ, Administrative Memoranda and will therefore be coordinated with G-1 or G-4 as applicable, before being submitted to the Adjutant General for publication.

4. The Joint Military Financial Committee shall have power to elect such additional members as may from time to time be desirable and shall also have power to require persons to attend upon it to give evidence necessary to the discharge of its duties.
