SUBJECT Losses and Pilferage of Supplies

9. IG C-4 25 May  
1945

1. A review of this case has failed to reveal that any United States personnel were involved in the alleged diversion of United States material in Sardinia. The CID investigation does indicate that there was considerable laxness in the method of accounting for the items turned over to the Italians. Little effort was apparently made by the Army in early stages to reconcile the differences between the ships manifest and the reports made by the Italian Board as to the amount received or damaged.

2. This file does indicate that poor supervision and a lack of a proper checking system, with no follow-up existed. These factors were no doubt responsible for the fact that acceptance notes were not always delivered by the Italians to cover the full amounts received. The responsibility for these deficiencies would be difficult to fix at this time as much of the United States personnel involved is not now within this theater. Many pertinent records are not available. There also appears a possibility that some of the alleged diversion might be traced to inaccurate transcription of records as may be the case is cited in paragraph 13, Incl 26 (statement of Major L. Forsett). Ship's manifests indicated that 240,000 lbs of macaroni were loaded for the Italians, but only 24,000 lbs were reported to the Combined Italian Armed Forces Supply Board and this latter figure was probably the one used on the Italian Acceptance note.

3. However, since the CID investigation has not found any grounds for, nor made any allegations against United States personnel in connection with the alleged large scale diversion of United States material in Sardinia, it is recommended that no action be taken by this section.

4. In view of the statement of the Provost Marshal General to the effect that no evidence of the alleged large scale diversions could be obtained from sources of information available at the present time in Sardinia, further CID investigation is not considered warranted and since other United States personnel who may have been involved are not now in the theater and pertinent and accurate records are not available to fix the responsibility, it is recommended that this case be closed. **030**

1. With reference to your letter of 27 March, a preliminary investigation by the American Provost Marshal General has been ordered to collect evidence on the general question of the diversion and misuse of American supplies referred to in the report received by you from the Head of the Land Forces Sub-Commission (HMIA).

2. SUBJECT: Theft of Allied Clothing in Sardinia.

To : Chief of Staff, A.F.I.Q.

1. There is forwarded herewith papers dealing with the above subject submitted to me by the Director of my Land Forces Sub-Commission.

2. In my opinion, the conclusions reached in paragraph 4 of General Browning's letter and paragraphs 6(c) and 6(d) of Colonel Kerr's letter may well not be warranted. The extent of the Minister's culpability, if any, would depend on how familiar he was with all the details of the case. My own opinion is that Minister Casati probably felt that Colonel Borda was seeking to convert into cash, for the benefit of his troops, certain excess Allied property of which he was not illegally in possession.

3. I do not, however, hold a similar view as to Colonel Borda, and I am somewhat uneasy that American personnel may be involved.

4. In my judgment there is nothing in the political situation involved which would justify Allied failure to investigate the handling of this American property, and I recommend that an investigation be ordered.
