SUBJECT : Visitors to Italy.

TO : AFHQ G-5.

1. I am pleased to see from your letter G-5: 000.7 dated 27 Nov 44 that the question of important visitors to this theatre is engaging attention.
2. The procedure proposed in TAM 367 would, in my opinion, effect a considerable improvement over the somewhat haphazard methods hitherto adopted.
3. To make it operate satisfactorily however, it is essential that you give us ample warning of the arrival of visitors in Rome and the nature of their business. Whenever possible we would like them instructed to contact on arrival AG Public Relations Officer (telephone 476719). He in turn would pass them, in the first instance either to myself or to one of my deputies.
4. It is worth emphasizing that a number of visitors first visit AFHQ, where initial contacts may often be made. Then, armed with a certain amount of information and names of personalities, individuals tend to be more independent on arrival here. I should be grateful therefore if your staff would tell the visitors what to do and whom to see on arrival in Rome.

To avoid future trouble from embarrassing press statements by important visitors from any of the United Nations to ITALY, following orientation procedure suggested:

Immediately upon arrival, they should be received by the Chief Commissioner of the Allied Commission or some competent and fully informed subordinate designated by him. He should tactfully enlist their help without implying anything in the nature of a "gag". It would be dangerous for a formal warning to be issued.

In the interview, full information should be given to the extent permitted by the requirements of military security of the particular troubles of the moment and the steps being taken to meet them. In doing so, opportunity could be taken to warn them of the difficulties caused by partial, and sometimes NOT disinterested, quotation of hastily formed opinions. The hope could be expressed that visitors will take plenty of time to study questions and to comment at leisure, bearing in mind the over-riding importance of NOT impeding the Allied war effort.

State Department and Foreign Office will attempt to instruct all prospective visitors that immediately upon arrival, they should present themselves before the Chief Commissioner. It must be understood, however, that it is the responsibility of the Theater to be sure that visitors, upon arrival, are conducted to the Chief Commissioner or his designated representative at the earliest possible moment.

SUBJECT: Censorship of Statements by Visitors to Theatre.

TO : Headquarters, Allied Control Commission, APO 394
(Attention: Acting Chief Commissioner)

1. Receipt is acknowledged of your letter *000.7* of 27 August. The problem of censoring the expressions of civilian visitors to the theatre has been reviewed, and your observations carefully considered. It is felt that the answer to the question posed in your paragraph 4 must be in the negative. Censorship in this theatre has been based upon military security, not the acceptability of the political sentiments expressed. It is believed that the standards already set up by the censorship branch should apply generally, and that no special procedure is required for matters arising within the A.C.C.

2. Aside from the importance in principle of permitting freedom of the press in matters which do not directly affect military operations, it is believed that censorship inspires a belief that there is "something to hide" and so arouses mistrust of Allied policy.

3. The proposal in your paragraph 5 has been considered and has been referred to the War Department and War Office. It is realized that no warning could be enforced after the visitor had returned home. Moreover, any restriction which had the appearance of a gag-rule might only provide one more point for criticism by those inclined to misrepresent. Considering that the evil resulting from irresponsible talk will ordinarily be felt more at home than in the theatre - and that anything having even the semblance of censorship may itself become a matter of public concern - it is felt that the problem is one for examination in the War Office and War Department where permission to visit is arranged. We are suggesting, in letters to the Director, War Department, and the Director of Civil Affairs, War Office, that they may see fit, in appropriate cases, to draw the attention of prospective visitors to the disservices they might do to the Allied cause by heedless comments leading to provoke recrimination, and to remind them that it is unfair to take advantage of the theatre of operations where they are visiting to make it a forum for the discussion of controversial issues. It is believed preferable that such cautions be administered at home than by the authorities in this theatre.

MEMORANDUM TO: Colonel Charles M. Spofford, G.S.C.
Asst. Chief of Staff, G-5
Allied Force Headquarters

1. I enclose copies of a message which was filed by the Associated Press yesterday, reporting an interview given by the two American Labor leaders, Mr. George Baldanzi and Mr. Luigi Antonini.

2. In view of the open criticism of probable Soviet Army conduct in Berlin implied in the first paragraph and of the strong Anti-British statements contained later in this report, the Censorship Branch of AFHQ referred it to the ACC for advice before dispatch. After consultation with Mr. Alexander Kirk and Sir Noel Charles, Censorship were advised that for military reasons this report should not be dispatched. These military reasons were that such anti-Soviet and anti-British remarks would undoubtedly find their way back to Soviet representatives in Italy as well as to British forces in this area. In that case they could but prejudice good relations between soldiers which were vital in an operational theatre.

3. This morning I was informed that, despite this advice, Col. Scott-Bailey and Col. Hayden had both reached the decision that they could not hold this report in view of the repercussions such a dispatch would involve. It was consequently dispatched last night.

4. This incident raises two questions. In the first place it is for decision whether the Censorship in Rome should not be instructed that in these matters they must follow the advice given by the Head of ACC, acting in agreement with the British and American Representatives on the Advisory Council. An alternative arrangement would be to instruct the Censorship that, in the event of their disagreeing with the advice proffered by the Head of ACC, acting in agreement with the British and U.S. Representatives on the Advisory Council, they must refer the matter to A.F.H.Q. before any such report is dispatched. The obvious objection to this latter course is the question of time.

5. The second question that arises is whether civilian visitors to Italy of such standing as these two American Labor leaders should not be informed before leaving their country of origin that on entering a theatre of war they automatically assume certain grave responsibilities. The first of these must be that in any public utterances they

should be most careful not to say anything that is likely to hinder the war effort in the area, and of course unmeasured criticism of Allies is bound to be prejudicial. It would probably be helpful if a warning of a similar kind could be given to such civilian visitors immediately on their arrival.

6. I am sending copies of this memorandum to Sir Noel Charles and Mr. Alexander Kirk, as well as to Col. Scott-Bailey.
