ISTRIA LIBERATED BY ALLIED TROOPS

London, May 4th (reuter).-- The Yugoslav radio broadcast today an order of the day of Marshal Tito announcing that Allied troops have liberated Istria, a zone not included in the jurisdiction of General Vietinghoff. Marshal Tito reported that two German divisions (30,000 men) were completely destroyed in the operations ending in the taking of Trieste.

A communique from Marshal Tito's headquarters, after protesting against the entry of the Allied troops into Trieste, Ronfalcone and Gorizia, goes on to say that the allies have acted in this matter without previous agreement with the Yugoslav military authorities. This misunderstanding must be cleared up, adds the communique, if unpleasant consequences are to be avoided.

The situation created by the surrender of German troops south of the Alps is now the subject of much discussion in the best informed circles of the capital. The first sense of satisfaction created by the exchange of messages between Churchill and Bonomi has been intensified by the rumours of other significant contacts between Italian and Allied authorities, as for example, the recent conversation between Bonomi and Alexander, which is reported to have been most cordial. It is felt that, with the end of military operations, the international situation of Italy will undergo rapid development and that Italian expectations will not be disappointed.

The news that Trieste has been occupied by Eighth Army troops and that more are coming in from central Italy is regarded as a confirmation of the assumption that, from the point of view of Washington and London, Trieste is an integral part of Italy. SUBJECT: Transportation Requirements - Allied Commission.

To: Allied Force Headquarters.
Attn: G-5 Section.

1. Reference is made to conference at AFHQ on 12 April 1945 when it was arranged that detailed survey of transport requirements of this Commission should be sent to Brigadier Herr, drawn up on a joint Anglo-American basis.
2. Enclosed are four copies of such detailed survey and the suggested needs of this Commission on the complete occupation of Italy.
3. I would like to emphasize that the important time for these vehicles is at the beginning of the occupation, and though the policy of requisitioning, which has been approved, will assist materially, I am afraid that the impressed vehicles will not stand up to the heavy work which they will have to do if my officers are to function adequately.
4. For this I do most strongly urge that these impressed vehicles be replaced at the earliest possible time by good WD vehicles.
5. This will have the added advantage of our then being able to make mobile the many civilian officials who will be working with us.

1. The Supreme Allied Commander directs me to inform you that he has reviewed the existing arrangements for visits by Russian officers to 5th and 8th Army Areas and Prisoner of War Camps.

2. The Supreme Allied Commander has decided that all previous arrangements (including those set out in letters AG 091.112/480 A-0 of 30 March 1945 and OR/3491/2/G1(Br) of 31 March 1945, addressed directly to the Russian Military Mission, copies of which are attached for your information) be superseded and that the following procedure be complied with in future:

- (a) No Russian officer is to enter 5th or 8th Army Areas or any Prisoner of War Camp without the written permission of Allied Force Headquarters.
- (b) Applications for such visits are to be addressed by you through the Allied Commission to Allied Force Headquarters.
- (c) Such applications to visit either Army Area are to be made well in advance of the time of the desired visit, giving details of the purpose of the visit, proposed dates, itinerary, and names of personnel concerned. Allied Force Headquarters will then, if the visit is approved, arrange with the appropriate Army Headquarters for a liaison officer to meet the visiting Russian officer on the Rear Army Boundary and to escort and offer every assistance to him throughout his visit.
- (d) Visits shall only be for the purpose stated in the application.

3. I am further directed by the Supreme Allied Commander to inform you that the establishment of and compliance with this procedure will be of mutual benefit to all concerned in expediting the solution of questions arising from the urgent problems of repatriation.

1. I think it may be helpful to explain the policy of the Allied Commission with regard to Allied Military Government in newly liberated (Northern) Italy in the light of the conditions which we are finding at present.

4. The greatest delegation possible should be made to the Italian authorities who will, in many cases, be members of the SM's. At the same time every effort should be made to impress upon the people and the authorities that Allied Military Government is the temporary forerunner of the Italian Government, and that Allied Military Government is working in the closest cooperation with that Government at the Headquarters of this Commission.
5. We may well be approaching in Northern Italy a state of affairs somewhat similar to what was found in France, and it should be our endeavour to help the Italians to make of Italy one administrative entity, and to allow them to take over the management of their own affairs as early as possible.
6. The conditions at present prevailing, both political and economic, indicate the probability of a rapid transition from Allied Military Government to Italian Government.
7. The implementation of this policy will not be easy. The greatest

7. The implementation of this policy will not be easy. The greatest tact, the greatest patience will be necessary. We should all remember that it is for the Italians to determine their own destiny, and that military Government in circumstances prevailing now is necessary only for the protection of Allied troops and installations. A light rein with a firm hand should be the order of the day.
8. Above all, we must remember that it is our duty to administer rather than to intervene in the political future of Italy.

Mr. Nelson C. Brown, Chief of the Division of Forestry in the Agriculture Sub-Commission of this Commission, is leaving shortly for Washington. He has completed a long range forestry planning program for Italy.

We would like very much to have his report mimeographed or printed and given wide distribution to those agencies who may be interested in it in the United States, and we would also like to have a number of copies sent to us.

This program has been adopted by the Director General of Forestry as well as the Minister of Agriculture.

You may be interested to know that a plan has been suggested by Mr. Brown to establish the Franklin Delano Roosevelt Memorial Forest by the Italian Government somewhere in Italy, to be planted with both Italian and American species of trees. This has also been approved by the Minister of Agriculture and Forests and Director General of Forestry.

The Minister for Occupied Italy has approached the Psychological Warfare Branch and this Commission with a view to initiating a series of daily broadcasts addressed to Northern Italy. The matter has been referred to the Supreme Allied Commander, who has given his approval subject to the conditions which are set out hereunder:

(a) The subject of broadcasts will be confined to:

- (i) Activities of the Italian Government.
- (ii) Information from people in liberated Italy to relatives in the North. This will be worded to avoid exposing relatives to reprisals.
- (iii) Appeals for unity among Patriots.
- (iv) General appeals for action against the enemy.
- (v) Reviews of the Italian press.
- (vi) Criticisms of Fascist and German propaganda.
- (vii) News of Patriots.
- (viii) Reviews of the events of the week.

(b) The script, which will be strictly adhered to in the broadcast, will be subject to the approval of the Military Censor, Psychological Warfare Branch and this Commission.

(c) If the Psychological Warfare Branch are unable to agree to a particular broadcast which your departments wish to make, the broadcast will be withheld and the point at issue will be referred to this Commission for the decision of the Supreme Allied Commander.

The Supreme Allied Commander further considers that the broadcasts to occupied Italy should not be confined to the Ministry for Occupied Italy, but should be made by various Ministries representing the four parties in the Government. The Supreme Allied Commander also considers it desirable that Your Excellency, as Prime Minister, should personally open the series.

Two recent appointments in the Questura at Rome do not appear to be in keeping with the principles of the Italian Government regarding Fascism.

- 1) Commissario SCALI has been appointed Chief of Cabinet of the Questore (Capo Gabinetto). This Officer is alleged to have been most active in his operation against anti-fascists while he was Commissario of the Campo Marzio district. He is also alleged to have denounced a number of Jews. My dear Mr. Prime Minister,

Following the receipt of your letter of 27 February 1945, in which you gave us a general view of your Government's intention with respect to the holding of local elections, officers of the Local Government Sub-Commission conferred with officials of the Ministry of Interior in order to get a clarification and elaboration of your proposed plans. I cannot but feel that the voting methods intended to be used by the Italian Government based upon the 1915 Law do not provide sufficient controls and guarantees to ensure the possibility of holding an independent, free and secret vote. As described to us, the system lends itself too readily to corruption of the voters and election officials, misuse of the ballot by the voters and unfair political party pressure.

Some of the principal defects in the existing system are:

- (a) no formal nomination of candidates prior to the voting;
- (b) no official ballot paper;
- (c) no control of electioneering at the polling places.

Since the Allies are greatly interested in the rehabilitation of democratic institutions in your country, I feel that I must most earnestly recommend to you that the present election law be amended prior to the holding of elections in territory under the control of the Italian Government.

Furthermore, the Allied Commission could not countenance the holding of elections in Allied Military Government Territory under the 1915 system. Substantial improvements and amendments to the existing law, tending to establish more truly democratic procedures, would first have to be made in AMG Territory. j 52 0

- (a) no formal nomination of candidates prior to the voting;
- (b) no official ballot paper;
- (c) no control of electioneering at the polling places.

Since the Allied are greatly interested in the rehabilitation of democratic institutions in your country, I feel that I must most earnestly recommend to you that the present election law be amended prior to the holding of elections in territory under the control of the Italian Government.

Furthermore, the Allied Commission could not countenance the holding of elections in Allied Military Government Territory under the 1915 system. Substantial improvements and amendments to the existing law, tending to establish more truly democratic procedures, would first have to be made in AMG Territory. 3.2.4

I wish to reaffirm my interest in this subject and my readiness to have the Allied Commission available for any assistance and advice which your Government may deem desirable.

Current status of Italian tiremaking requirements is as follows:

1) LAC airgram 114 dated April 4th formally requests items covered by cables addressed to you with exception of motor for 4/1/2 inch extruder, 8 inch extruder and certain chemicals, moulds, curing bags and/or drawings for same.

2) Total requirements reference drawings and machinery for Tivoli per your cable 89 dated March 28th not received by War Office. However it is unlikely that any of these items are available in Spain. Even if they were it is unlikely that Spaniards could be induced to part with them.

3) In discussing Italian tire situation with Ministry of Supply, it developed that major part of information on synthetic rubber usage is of American origin and is conveyed to rubber industry here only under certain conditions specified by American Rubber Reserve Company and when passing this information to other third parties, e.g. France, Holland, etc., it is necessary to have rubber reserve agreement. This is equally necessary with Italy.

4) In view of paragraph 3 above, Ministry of Supply cable BRMM Washington for necessary clearance per their cable TAMAR 2007 dated April 5th. We also cabled SECSTATE urging that request be promptly granted per Winant's cable 3543 dated April 7th. Ministry of Supply have now been advised per HMM Washington's cable RAMAT 2079 dated April 9th that textile bureau have refused to allocate tire cord for Pirelli Rome factory and that in accordance with policy of not shipping rubber until other component materials are available, Combined Rubber Committee has withdrawn approval for shipment of rubber. 3518

5) Until decision per paragraph 4 above is modified, nothing can be done to advance Italian tire production program. See our cable SUMOC 228 dated April 11th addressed to Batt, Vice Chairman War Production Board Washington urging that decision be reconsidered. This cable has been repeated to you.

6) Reference cable from AFHQ to War Office F51871 dated March 29th requesting Barker's services. At a meeting with Ministries of Supply and Production yesterday it was agreed that Barker would leave for Italy this week, but due to action taken by Combined Rubber Committee his visit must be temporarily cancelled.

Mr. Broad strongly suggested that the Italian authorities be urged, in their own interests, to postpone the court-martial while a solution was being sought through diplomatic channels.

2. I spoke to Mr. Halford and Mr. Bowling, both of whom agreed with Mr. Broad's suggestion.



My dear Mr. Ambassador:

With reference to conditions in the Mental Hospital at Palermo, a report was asked for from the Regional Public Health Officer in Sicily and he has made the following points: -

(a) He has made frequent inspections of the Hospital during the past fourteen months and all his inspections were made without prior warning. He states that while conditions were bad, he never saw patients sleeping on piles of straw, there being no necessity for this as the institution has an adequate supply of beds and bedding. 1. The draft letter of 4 April to the Prime Minister forwarding interim report of the Advisory Anti-inflation Board has not been and will not be signed. Instead, I conferred with the Prime Minister yesterday setting forth our concern over the inflationary trend of wages, specifically as to its effect on the employment of civilians by Allied Armed Forces. I stated that the question of wage control was but one of the factors involved in the general inflationary trend; that for the purpose of giving advice and assistance to the Italian Government pursuant to the new directive under which the Commission operates, I had established an Advisory Anti-inflation Board which had submitted to me an interim report; that I should be glad to make this interim report available to the Prime Minister in the form of an Aide-Memoire for his consideration if he so desired. The Prime Minister stated that he would be glad to receive the Aide-Memoire and welcomed our continued assistance.

In accordance with established procedure concerning imported articles, I.C.E. is responsible for obtaining disposition instructions from the Italian Press Commission for newsprint and for entering shipping bids with the transportation authorities. I am informed that the Italian Press Commission issued these disposition instructions to I.C.E. about a week ago and that railway bids were then placed. The pressure of rail traffic requires that all bids must be entered two weeks in advance of shipment.

1. Since the issue of the Anti-Inflation Committee report, there have been many changes in the economic conditions in Italy. It is now necessary to consider anew what measures should be adopted both by the Italian Government and this Headquarters to check the continued tendency towards inflation.

Dear Minister de Gasperi:

Further to my letter No. 1/723.1 of the 14th March, I have pleasure in informing you that no objection is seen by the appropriate Allied authorities to the carriage of sealed diplomatic bags by officials of the Ministry of Foreign Affairs who occasionally proceed abroad. It would be desirable as you suggest in your letter No. 3/355 of March 3rd that such officials should be furnished with a courier passport to protect their bags from investigation by the Allied military authorities at the place of departure and subsequent points en route to their destination. I should accordingly be grateful if you would be so good as to let me have a specimen of such a document in order that the Allied military authorities may be notified in advance of its existence and be able to familiarise themselves with its appearance.

As regards the question of the granting of undeposited cypher facilities, I much regret that for the time being we must accept the decision of the Allied military authorities that the Italian Government may communicate with their missions abroad only in cyphers of which copies have been deposited with this Commission. I would emphasise that this decision is based exclusively on grounds of military security and assure you that henceforth the only control which will be exercised on telegraphic communications between the Italian Government and Italian diplomatic missions abroad will be military in nature. In other words, there will be no political censorship of the contents of such telegrams. These cypher communications will of course continue to be necessary so long as military operations are being conducted in this theatre.

My Dear General,

In October last I wrote to General WILSON asking for an aeroplane to be made available for the use of the Commission and received a reply from Air Vice-Marshal MCENTEGART that the communication aircraft supply position was such that it was not possible to accede to my request.

On 17 October 1944 at SAC's Political Committee 29th Meeting, SAC directed thatAir Commander-in-Chief, Mediterranean, consider sympathetically the request of the Allied Control Commission for a Dakota for their exclusive use, and that he make one available as soon as circumstances permitted".

Now that we are coming close to a time when the distance from my Headquarters to my forward Regions will be doubled I am writing to ask you to reconsider this question. The large centres of population which may shortly fall into Allied hands, for the Military Government of which this commission will be responsible, will give rise to many political and other problems which can only be handled satisfactorily by my officers being able to make frequent and speedy visits to the Northern Regions. The allocation of an aircraft to the Commission for this purpose seems to me to be essential to the proper discharge of those responsibilities with which this Headquarters will shortly be faced.

From a most reliable source we learn that the appearance of opposition to Italy on the part of the French authorities has recently been notably accentuated.

An anti-Italian organization has been created in Paris. Its head, Mr. Soustal, of the "Studies and Research Offices", is directly responsible to General DeGaulle.

The newly formed French 2nd Army, composed of the 27th and 1st Alpine divisions and the 4th Moroccan division, is drawn up on the French-Italian border between Switzerland and the Ligurian Sea. Numerous contingents of recruits, well-armed and equipped largely with American material, are flowing into the adjacent rear areas.

There is definite information that French officers have been designated to fill pre-established posts in Italian districts. For example, a Captain has been designated "Chief of Military Security in Aosta". A few score Italian extremists in French service have already entered Italian territory with the task of causing trouble at the proper moment and supplying pretexts for intervention. 32.1

Several plans of the city of Turin have been seen with the hotels and buildings to be requisitioned by French headquarters and troops indicated thereon.

In a call which I had from the Prime Minister at my house two days ago, he informed me that Minister Pasenti had agreed to the deletion from his proposed decree of all references to corporations. MEMORANDUM TO: Vice President, Civil Affairs Section.

I was waited on today by women representatives of the "Centro Italiano Femminile" and the "Unione Donne Italiane" to discuss the question of de-requisitioning of some schools. They estimated that approximately half of the school population from the ages of five to twelve are receiving no schooling.

You will recall that on 28 December I wrote the Prime Minister drawing his attention to the failure on the part of the Italian Government to de-requisition schools. Will you please have an up-to-date survey prepared so that I may send another letter to the Prime Minister. I am informed that the refugees, both Roman and out-of-town, now quartered in schools could, without great difficulty, be accommodated in space now available in Rome.

In view of our new directive, I propose to justify my returning to the attack with the Prime Minister on the grounds that I have been asked to do so by these Italian women's agencies.

1. The Italian Council of Ministers at their last meeting considered a Draft Decree proposed by Minister PEBETTI. It is understood that at their next meeting further consideration will be given to this Draft Decree.

3. The possibility of socialization of big industries such as FIAT and FIAT may well hamper the Allied war effort. The Council of Ministers has appointed a Committee of Ministers to consider the draft. Instructions are requested as to whether the AC should take any position in this matter from the military point of view.
