SUBJECT: Local government in Ascoli and Macerata Provinces.

TO : RI, Abruzzi-Marche Region.

1. Thank you for your letter R5/507/22 of 2 October, to which I have delayed my reply until I could receive and consider Capt. Williams' reports on his recent survey of these two Provinces. I enclose copies of these reports herewith.

2. I congratulate you and the PG on the good progress which has been made in the reorganization of local government in both Provinces. There are only a few points which need special mention.

3. Italian Officials for Ascoli:

I will obtain from the Ministry another Vice Prefect Vicario, instead of Dr. CONTINI and send him back to you. CONTINI should then be removed from office and ordered to Rome to report himself to the Ministry of Interior. Of the two Vice Prefect Inspectors, the Prefect prefers to keep RIGUCCI. PERONCINI should be ordered to Rome to report to the Ministry of Interior, where he is required for another Province. The Consigliere, Dr. CAPANIG, should be ordered to Rome likewise.

4. Italian Officials for Macerata:

The position is fully set out in Appendix B of Capt. William's report. I am taking the necessary action with the Ministry. Will you, on your part, arrange for (a) Consigliere BERTUCCI to go from Aquila to Macerata; (b) Rag. VENTRIGLIA to be retired forthwith, and (c) for FALLEGGINI, MESSIO and BORELLI to be likewise removed as soon as their replacements arrive. When removed, each one of these three should be ordered to Rome to report to the Ministry of Interior.

THE PREFECT is Dr. Guido Broise, who is an official by profession. He was Prefect of Ascoli before, and was arrested and taken to Rome by the Head of Police. He is a Major in Infantry, Roll of Honour, took part in the Great War as a volunteer, and was wounded and decorated several times for gallantry. He is competent, co-operative and generally well regarded.

THE VICE PREFECT VIGARIO is Dr. Giovanni Contini. He is old and lacks energy and initiative. He is neither respected nor trusted and his removal has been requested.

THE VICE PREFECT INSPECTOR is Dr. Leopoldo Perongini, who was in close contact with the Head of the Province during the Nazi-Fascist Government, and he must be sent elsewhere as soon as possible.

Besides these there are another Vice Prefect, Dr. Giovacchino Rignesi, and five Councillors, of which one is Dr. Carlo Capasso, once Capo di Gabinetto of the Head of the Province of Teramo. His transfer has been asked for, as his presence here is not advisable.

5. SINDACI.

The Podestà having been abolished, the administration of the 72 Communes is dealt with by Sindacos and Commissioners. At the moment 70 Communes are administered by Sindacos, and 2 by Commissioners who will shortly be replaced by Sindacos.

All the Sindacos work without being recompensed. In the last few weeks the Sindacos of S. Benedetto and Offida have been changed. The former was a Communist working man, not suitable for an important town, the latter because he was undesirable to the majority of the population. There is no difficulty in the province as to the nomination of unpaid Sindacos.

6. DEFASCISM.

The Prefettura has given the local administrations precise directives for the preparation of forms for each employee as regards defascism. Awaiting the decisions of the clearing commissions, the employees who were most involved have been suspended. There is some difficulty in the case of suspension of doctors and veterinary surgeons, as it is difficult to replace them without upsetting the most important medical services. As soon as it is possible they will however be replaced. Among the Fascist Officials, the Heads of the Consiglio dell'Economia, of the Istituto Nazionale della Previdenza Sociale and of the Istituto Previdenza e Assistenza Impiegati dello Stato are still in service.
