SUBJECT: Monthly local government return for April.

4 June 1945

TO : PU Ancon.

1. Reference your AC/1/5/10/10 of 4 May, and enclosed return for April, the comment as to Prefetto Reggente Gen. FIECHE has been noted with interest. Lt. Col. Elves, when he was in Rome about the middle of May, mentioned to the Deputy Director of this Sub Commission the possibility of Gen. FIECHE desiring either to serve in a northern province or to retire. The matter was left that Lt. Col. Elves would ascertain whether this was in fact the General's desire. If so, he would write this HQ accordingly, whereupon the question of replacing him would be taken up with the Italian Government with a view to a strong and capable successor being appointed. Would you please let this HQ know what is the present position.
2. The absence of any Vice-Prefect Inspector has been noted. The filling of this post was under discussion with the Italian Government during April, the position being that the candidate they had nominated was not satisfactory to this HQ and they had been asked to nominate another one. At the time when the province ceased to be under AMG, this second nomination had not been received.
3. The Italian Government have been asked whether they intend to proceed with the filling of this appointment and they have replied that they consider the staff at the Prefecture adequate and that they do not intend to send a Vice-Prefect Inspector. They are, of course, very short of qualified personnel; and now that the province is under Italian control, the filling of this appointment is a matter which must be left to them.
4. These inquiries as to the post of Vice-Prefect Inspector have delayed the acknowledgment of your report.

1. PREFECT

The Prefect - General Picche - has co-operated well and I have been very pleased
 with him. He has, however, lost "caste" a lot since his name appeared in the Rome
 papers as having been executed. He is a Prefetto Regente and thinks that he will
 very shortly be substituted - therefore is no longer the firm man he was. Being
 a General - and therefore a King's man - he is not at all popular locally and I am
 constantly being asked by local Italians if I realize how much my administration suffers
 because of this fact.

As it seems that a career Prefect will be appointed I personally feel it would
 be as well to make the change as soon as possible.

General Picche is anxious to become Prefect of a Northern A.G. controlled Province
 or else allowed to retire.

2. VICE PREFECT VICARIO

Not yet appointed.

*Signor Dott. A. G. Santoro - Consigliere 1st Class -
 is doing the job of Vice-prefetto Vicario. He is good at his
 job but doesn't seem to get on with anybody.*

3. VICE PREFECT INSPECTOR

Not appointed.

A minor demonstration occurred in Ancona on 5 Dec 44 during a second conference being held between the Executive Officer of the Province and a committee of citizens on the city.

During the meeting, at which various problems concerning the evacuation of civilians from two streets of the city for health reasons, ration supplies, etc, were being discussed, a crowd outside the Prefettura became impatient and noisy.

The crowd was dispersed by the CC RR with several CEF in attendance. No violence was attempted.

The meeting was satisfactorily completed and quiet restored. No further demonstrations are expected in the near future.
