Summary of the Statement of Dr. Antonio Parrotta, citizen of Gerace.

TO : ALLIED CONTROL COMMISSION

12 OCT 1945

Dr. Antonio Parrotta, citizen of Gerace (province of Reggio Calabria) makes a full statement of the dishonest and disloyal activity of the five people who are holding the controls of Commune.

These are:

Bebè Sansalone, Sindaco, assessore delegato.
 Malfarina Filippo
 Pietro Fimignari, first communal doctor.
 Filippo Fimognari, second communal doctor.
 Migliaccio Giovanni, teacher.

These five people are the same who have controlled the Commune of Gerace during the whole fascist period, of which regime they were strong supporters, and important leaders.

The same despotic conduct they had in the past 20 years of fascism is now the basis of their behaviour towards the population of the Commune. This Commune is, politically and administratively isolated from the rest of the country as it is ruled with fascist systems and principles.

Dr. Parrotta asks in the name of the citizens of Gerace that the above named five people be dismissed, for the benefit and the liberty of the population.

Memorandum for local government report on Province of Reggio Calabria for month ending 31 July 1944.

Reference is made to monthly report to R.C. Region VII 1170/27 July 1944 sent 29 July 1944 to HQ together with an extra copy which may be attached hereto. Such report discusses in greater detail the local government situation in this Province.

1. Deputazione Provinciale

- a) "Rittorato" abolished
- b) Members of the Deputazione Provinciale selected
- c) (1) The president and 3 members represent the Democratic Party; 2 each to the Demo-Cristiano and Socialist Parties; 1 each the Communist and Partite d' Azione.
 (2) Names and political interests are set forth in full in monthly report. Ramirez and Franco are large land holders. The other membership consists of 2 Doctors, 2 Lawyers, 1 Engineer and 1 Industrialist. As stated the membership predominantly represents a division of political rather than economic interests.
- d) Meetings held on 24 June; 3 July; 18 July.
- e) Attendance by Allied Officers at meeting of 18 July.
- f) Agenda received in advance of meeting of 18 July.
- g) (1) President nominated immediately after Allied Occupation.
 (2) President On. Avv. Domenico, Tripategori.
- h) As far as observed, this body is reasonably business like and somewhat above average calibre.

11. Giunta Provinciale Administrativa

- a) Four citizen members elected at meeting of Deputazione Provinciale held on 18 July.

- d) Meeting held 20 July attended by Allied Officer. Further contact with this body on 31 July.
- e) An agenda in advance requested.
- f) Present appraisal of body:- Mediocre, politically minded and not inclined energetically to assume its responsibilities or act within the ambit of its authority.

IV. Biographical data on Italian Officials

- a) The Prefect is not a career man, being a lawyer by profession. He is a Socialist, an ardent Anti-Fascist and appears to be well liked.

As with other officials, he is at times apt to consider his political future paramount to his office. He is understood to have ambitions of becoming Senator and is loath to commit himself to any steps which would weaken his political position. He is intelligent, energetic and politically adroit.

- b) No appraisal has yet been made of the Vice Prefect Vicar.
- c) Vice Prefect Inspectore is active and has had a long experience in municipal affairs at Reggio Calabria. He also is inclined to weigh suggested action in the light of his future personal position. An attempt has been made to get him out into the Province and not let him become a sedentary official.
- d) The Archbishop, the director of religious affairs, is young, capable and intelligent. He takes an active interest in the affairs of the Diocese and seems to be cooperative.
- e) Biographical data and further appraisal of various officials scattered throughout this Province will be submitted in a later report. Due to lack of personnel transport, etc., it has been impossible in three weeks time to make intelligent appraisals of Sindacos even in larger towns.

V. Sindaci

- a) "Podesta" abolished and title of "Sindaco" adopted
- b) Number of Commissari Prefittizi: Twenty five (25)
- c) Mayors replaced since July 1 1944: Nine (9)
- d) Difficulty of getting persons to act as Sindaci has increased since Allied Occupation. Some of the glory has worn off and hard work remains to be done.
- e) Mayor of Reggio City was Vice Sindaco when present Prefect was Sindaco. He is stated by the Prefect, of whom he is a close friend, to be capable.
- f) Relations between Mayor and Segretario Comunale of Reggio City are said to be good. The Segretario appears efficient (see memo).
- g) The Mayor of Reggio City does not appear to have distinguished himself so far in the handling of the Municipal Giunta.

VII. Relationship A.C.C. with Italian Officials

General attitude and cooperation of senior Italian Officials, is as above indicated. Many are politicians first and administrators secondly. Particularly in view of fact that it is the general belief that more and more A.C.C. personnel will be withdrawn from this Province, officials are, quite understandably, not willing to take steps which they consider politically or personally disadvantageous and to be left holding the bag. The result is that as to suggestions solely in the Allied interest, they are inclined to resort to delay, excuses and evasion to avoid taking action. Personal relations however, remain satisfactory and no direct refusal to take action has come to notice.

I- General Background.

(1) The Province of Reggio di Calabria is the most southerly of the 3 comprised in Region VII which is identical with the Italian former Compartimento of Calabria. Prior to 23/4/44 it formed part of Region II.

(6) Agriculture.- The high table-land of the Aspromonte (3500 feet) and the ridge extending from it to the north-east occupy most of the province and hardly of any productive value. The best land is in the western coastal plain which is intensively cultivated, particularly between Cape Vaticano and Reggio where the steepest slopes are skilfully terraced for the growth of olives, citrons, fruit trees, mulberry trees (for silk) and vines: in the extreme south the cultivations of bergamot is important. The uplands produce cereals, beans and potatoes. The eastern coastal plain is sandier and less fertile: more barley and oats are seen and less fruit-bearing trees.

(7) Industry.- The size of Reggio ($2\frac{1}{2}$ times that of the next largest town in Calabria) has attracted a certain amount of industry of purely local importance. The manufacture of citrons, fruit products, including essential oils, is concentrated in this neighbourhood. There is an important olive oil refinery at Gioia Tauro and several silk mills between Reggio and the Straits of Messina. The most important product is olive oil: but the silk industry, small as it is, has become valuable as a source of supply for the Allied Nations.

(8) The towns and villages from Reggio to Villa Giovanni exhibit considerable damage from the shell fire and bombing that preceded the landing in September last. Further north there are few obvious signs of fighting. Some of the principal bridges have been thoroughly demolished but by no means all: in the southern half of the province in particular they are hardly touched. Groups of burnt-out rolling stock are to be seen on the railways; but they appear to be running a reasonably good service. The ferries between Reggio and Messina are in regular working. Apart from these points, the fighting appears to have passed over the province lightly. The main roads are generally in good condition and damage in the Reggio district has been repaired very roughly. (9) The condition of the people appears to be reasonably good in present circumstances. Evidences of poverty and undernourishment are, as usual, more apparent when the population is concentrated (i.e. in Reggio and the coast to the north of that town).

His personal position vis-a-vis the late Government may also, I think, have caused him to proceed with caution and strict correctness.

(17) At the moment, therefore, no Deputazione Provinciale or Giunte Comunali exist. Neither are there any "citizen members" of the G.P.A.. In the latter case, the Prefect pointed out that, according to the proposed Decree the citizen members were to be elected by the Deputazione, so that the latter body would have to be set up before the citizen members could be appointed.

(18) On the other hand, the expressions "Presidente and Sindaco" are in use to designate the heads of the Provincial and of all Communal Administrations.

(19) The Prefect has moreover selected the members of the Giunte Comunali and Deputazione Provinciale and could make the appointments within 3-4 weeks of the promulgation of the Decree. He has not yet consulted the FC on the nominations, but he intends to do so.
