TO : His Excellency the Minister of Interior.

Your Excellency:

1. Reference your letter of 23 October 1944 (Pila Div. 2 Sec. 1 16500-3/4 1) together with the enclosures.

2. The matter has been investigated by the Regional Commissioner of Toscana Region who makes the following comments:

(a) "From a perusal of the file it appears that the Lake of CHIUSI has formed part of the state domains since 1859. The concession used to be auctioned but in 1939 it was leased to Doctor GIULIETTI for 18 years at an annual total rent of L. 33,600.

(b) This man is alleged to be an ardent Fascist and a General of the Fascist Milizia and to have left CHIUSI with the Germans when the Allies captured the place.

(c) It seems strange that he is now at ROMA, making petitions to the Ministry of the Interior.

(d) The Comune of CHIUSI has taken over the concession and asks that the concessions to GIULIETTI be cancelled and that the Comune be admitted in his place.

(e) It is suggested that this is a problem for the Italian Government to solve. In view of the fact that Dr. GIULIETTI has been an ardent Fascist, I recommend that the Comune be left in possession pending a decision."

3. I am in agreement with the observations of the Regional Commissioner that this is essentially a problem for the Italian Government. However, since the concession is in a comune in territory under the jurisdiction of the Allied Military Government, I suggest the status quo be preserved. Following the eventual turnover of the territory to the Italian Government, you may, of course, make any other disposition of the matter.
