SUBJECT : Note of interview with Ing. Giacomo FERRARI, Prefetto Reggente of PARMA - on 11th July 1945

TO : Director, Local Government Sub Commission

FROM : Captain W.I. CUNNINGHAM

1. The Prefect is not very impressive. I think however he is a reasonable worker. He appears to be very anxious about the legality of his actions. On the other hand he unlike most other Prefects was not eager to get career officials sent from Rome. He would prefer to appoint local men.

2. The Vice Prefect Vicario is a career official. He is efficient and cooperative but he has been denounced to the Spuntation Commission and the Prefect is afraid he will have to go. He will be retained as long as possible. The Prefect says he can find a local man to take his place.

3. Vice Prefect Inspector is Mr. Aristide FOL. He is non career and C.L.N. nominee. He is going round the Communes advising Sindaco and Giunta and etc.

4. He has 6 career Commissari two of whom have been dismissed. He does not require any more officials. I explained the proper procedure to obtain these officials to the Prefect.

5. The Deputazione Provinciale has been functioning with only 5 members instead of the 9 members required for a Province of this size. The Prefect is getting nominations for the remaining members and will have them appointed soon.

6. C.P.A. held its first meeting on 5th June and has been meeting regularly since. The four citizen members are appointed.

7. Giunta Comunale are all functioning.

8. Sindaco have all been appointed.

9. Segretario Comunale. Career officials are working in 37 of the 46 Communes. In the other nine Communes there are non-career officials under the supervision of a career Segretario for the neighboring Communes.

10. Electoral Lists. The forms have been distributed to all Communes and the Prefect has a receipt for each Sindaco. He has also set up the electoral office in the Prefecture. He is getting names for the electoral Commissions too. The Prefect said that the Provincial Commissioner was holding a gun at his head and pressing him all the time about the Electoral Lists. I told him that the Provincial Commissioner was being equally pressed on the same subject by his superior officers. The Casellario Giudiziale are all in perfect order according to the Prefect.

11. Function. The Provincial Commission has been set up and is working.

on 11th July 1943

FROM : Captain W.I. CUMMINGS

1. The PC had Forms A and B ready. They are attached to the file copy of this report. Regional and Provincial HQs already have copies.
2. The Prefect Reggente Ing. Giacomo PERRARI is the C.L.N. nominee and is a Communist. He was officially appointed on 23rd May 1943. PC doubts his honesty. He is probably getting directions from the C.L.N. The Prefect does not wish to take any decisive action and always wants A.C.C. to shoulder the responsibility. PC keeps urging him to stand on his own feet.
3. The Vice Prefect Vicario Dott. Vincenzo GALLIA is a career official. PC doesn't think he will be epurated. The Vice Prefect Inspector Avv. Aristide FUA is a non career C.L.N. nominee. He is also called Vice Prefect Politico.
4. The Deputazione Provinciale and C.P.A. are functioning. C.I.C. has raised some objection to the President and PC is examining the matter. It may be necessary to have a new president.
5. Sindaci. The position of the Sindaco of all 46 Communes has been regularised by Decree of the Prefect. I pointed out to the PC that the appointments were only temporary and that Sindaco could be changed at any time if they did not give satisfaction.
6. Giunta Comunale composed of C.L.N. nominees were functioning in all Communes.
7. Segretario Comunale were working in all Communes. PC had asked the Prefect for formal notice of their appointments and that they were all there.
