1. I outlined the problems involved in the compilation of electoral lists. The Prefect, Avv. Martini Service, member of the Liberal Party and designee of the CLN, was characterized by the Provincial Commissioner as a very good administrator. He had been acting in the underground movement and was highly respected. He had courage enough to defend the Carabinieri on one occasion after he had taken office. He is a young man and impressed me with his eagerness and fresh point of view. The RV said there is no trouble with the CLN now; that they quit issuing decrees after AMG was in the province 5 days. Relations between the CLN and AMG are good. The CLN is very cooperative.

2. Public order in the province is good. Some partisans have been absorbed into the various police services. Outlaw bands are diminishing. There is still some trouble with these bands, which are operating under the guise of being partisans.

3. The political complexion of the province is Liberal—perhaps a little to the right of that. Coal is the key to the solution of all the problems.

4. The Deputazione Provinciale has not been formed yet. Not all the names of the members for that body have been received as yet. However, it is hoped that the Deputation will be selected within the week. The Vice Prefect situation is as follows:

Avv. FRANCIO Vittorio - designated by the CLN as Vice  
Prefect "Politico" - non-career  
BELLINI Lodovico - Vice Prefect Vicario - career  
FEROLANTE Francesco - Vice Prefect Inspector - career  
Gonniglio with functions of VPI

The rest of the Prefecture is well staffed with trained officials.

5. In all of the Comunes, Sisimi and Giunte Comunali have been appointed. In the case of the Giunte, they have been reduced to the legal size. There are Segretari Comunali in almost all communes.

6. The four members of the CPA naturally have not been selected, since the Deputazione Provinciale has not been created as yet.

3. The political complexion of the province is Liberal—gaining a little to the right of that. Coal is the key to the solution of all the problems.

4. The Deputazione Provinciale has not been formed yet. Not all the names or the numbers for that body have been received as yet. However, it is hoped that the Deputation will be selected within the week. The Vice Prefect's situation is as follows:

AVV. FRANCIO Vittorio - designated by the CINI as Vice Prefect "Politico" - non-career  
 BENEDETTO Lodovico - Vice Prefect Vicario - career  
 FRANCESCO Francesco - Vice Prefect Inspector - career  
 Giacintino with Puntoloni of VFI

The rest of the Prefettura is well staffed with trained officials.

5. In all of the Comunes, Sindaci and Giunte Comunali have been appointed. In the case of the Giunte, they have been reduced to the legal size. There are Segretarii Comunali in almost all comunes.

6. The four members of the GPA naturally have not been selected, since the Deputazione Provinciale has not been created as yet.

7. Forms showing the provincial situation were left to be completed and have recently been received by this Sub Commission. Requests for several Secretaries and Class "Q" employees have been forwarded to the Ministry of the Interior for any necessary action.
