SUBJECT: Interview with Dott. Pietro INNAMARO - Prefetto Reggente of NOVARA
on 25th July 1945

TO : Director, Local Government Sub Commission

FROM : W.I. CUMMINGHAM, Captain.

1. The Prefect is a thin active type of man. He seems rather tired and nervous and is carrying on his professional work at the local Hospital as well as acting as Prefect. He had the V-V and V-VI present at the interview and of course I could not ask him for an opinion on them. They are both Political appointees so I do not think he would have expressed any but a favourable opinion.

2. There are three Consiglieri, 2 career 1 political, and 3 Secretaries. The Prefect does not require any more officials.

3. The Deputazione Provinciale holds its first meeting today at 3 p.m. and will nominate the 4 citizen members of the C.P.A. The Deputazione has 6 members and 2 supplenti.

4. Giunta Comunale are in all 141 Communes.

5. Sindaci have been appointed everywhere by the Prefect's Decree.

6. Segretari Comunali. There are 132 career Segretari and 9 non career.

7. I spoke to the Prefect about a car for the official to inspect the preparation of the lists in the Communes and he said that if this official would give him a list each evening of the Communes he wished to visit, the Prefect would put a car at his disposal the next day. The Prefect agreed that this was important and said he would help in every way. He had had a talk with Parri and Merri on the preparation of the lists at the funeral of Solari and would see that there was no avoidable delay.

SUBJECT: Interview with VVV Luigi CARPA and Dott. SPADAZZA - Consigliere in charge of preparation of the Electoral Lists. - on 25th July 1945 -

TO : Director, Local Government Sub Commission

1. The forms had arrived and been distributed in good time and work had commenced on 15th July as set out in the Decree.

2. Of 144 Communes only about 2 had their records destroyed. These had asked for an extension of 3 months on this account. We had a long talk about extensions and I stressed how important it was to cut them down to a minimum. They said the Legal Officer had said the same thing to them and that they thought a month or 6 weeks would be sufficient extension. One of the Communes in question has only 5,366 inhabitants and I said I thought I could prepare a list of them in a week or so.

3. There are 2 Casellari Criminali in the Province. Both are intact and records in order. The VVV said they were understaffed and thought that a potential source of delay would be the getting of replies from Casellari all over Italy. 15 days were allowed for this by law and it was not enough in the present state of communication.

4. There are career Segretari in all but 20 Communes. These are being looked after by neighbouring Segretari. Sindaci have all been appointed by Prefectural Decree.

5. The Electoral Commissions were being set up. Names had been obtained for the members.

6. The Provincial Election Commission has been set up.

7. The main difficulty was transportation for the officials to get round the Communes. A.M.G. had allowed 15 litres of petrol per day but they had no car. I promised to speak to the Prefect about this.

SUBJECT: Interview with Major G.P. MARSH, PC Novara, 25 July 1945

TO : Director, Local Government Sub Commission

FROM : Captain W. I. Cunningham

1. Prefetto Reigento Dott. FURIO PARVA is a Children's Doctor of International repute. He was the CIN's choice for the position. He is a very strong Socialist but has promised to give up politics while acting as Prefect. He would like to resign. PC has persuaded him not to resign at present as his departure would be a great loss to the Province. He is a strong man and is not afraid of anyone and stands up to the Communist Party. He will probably resign when the Province is handed back to the Italian Government and another Prefect will then be required.
2. VAV Luigi CARLA is a political non-career appointee. PC has not a very opinion of him.
3. VET Dott. ERNANO LAMARCA is a Medical Doctor and a non-career political appointee.
4. Deputazione Provinciale had been established and would appoint a CRA possibly today.
5. Giunta, Sindaco and Segretari were in all communes.
6. CIN. Were not giving any trouble. They had been told what the position was and were being kept under observation. They had obeyed orders quite well.
7. The preparation of the electoral lists was going on quite well. The Legal Officer had gone home but another was expected soon and would keep an eye on the work.
