Replying to enquiry letter dated 24 August 1945, paragraph 1/c.: in every Comune of the Province a Sindaco has been appointed upon the recommendation of the local CLN after the usual investigation performed by the Prefect's office. The greater part of these have been appointed in block, visted by the P.C., however due to the constant turnover and the fact that the majority of Sindaci object to the old form of oath (a matter which has been submitted to the proper authorities for consideration) there are some Sindaci which have not as yet been confirmed. The matter is receiving constant attention and no difficulty is anticipated in having them all confirmed as soon as the matter of the oath is straightened out.

1. There are 4 Vice Prefects contained on the list of personnel that had been prepared. One of them--BOLDO--is a non-career official. The Vice Prefect PIRANO is subject to epuration. Of the 2 Vice Prefect Inspectors, STRASSER is on leave and actually has not worked in the Prefettura. The PC said he would inform us as to whether he wanted us to retain the man. Lett. MARTUSCELLI, the other Vice Prefect Inspector, is thought of very highly by the PC. In fact, the latter believes he would make a good Prefect.
2. The PC characterized the Prefetto Reggente BERTINELLI as a capable, reliable and energetic official. A Socialist, he was the unanimous choice of the CIN and is very popular with the people. He was appointed by the PC, the certificate of General Rube not having been delivered as yet. The PC said that the Prefect does not want his job but is willing to serve out of loyalty to AMG. The Prefettura is well staffed and no further officials are required.
3. An Electoral Office has been set up in charge of Vice Prefect Inspector MARTUSCELLI, who is assisted by Consigliere SARGENTI. The electoral material has not been delivered to these Communes which are difficult of access. However, the Prefect hopes to have them distributed in the next few days. The Deputazioni Provinciale was formed about 15 June. However, the 4 citizen members of the CIN have not as yet been selected. The Prefect said they would be selected very shortly. Electoral Commissions have not been formed as yet.
4. Population registers are all in good shape and the Casellari Giudiziali are intact.
5. There are Sindaci and Giunte Comunali functioning in all of the 201 Communes. However, only about 150 have been formally confirmed in office. The PC intends to have an "en bloc" appointment by the Prefect and for the remaining ones. All the Communes are adequately covered by Segretari Comunali. FOR JUNE 1945

COMO: Deputazione Provinciale formed and appointed, proceeding with its functions. Giunte Comunali forming up. Sindaci appointed. General progress good. Epuration commissions making fair progress. Food supply condition satisfactory. Harvest of crops in hand. Regional Order No. 11 on cereals published. Forestry products coming out. Commercial fishing resumed in lakes and producing small quantities of fish. A 5 million lire public works program has been prepared for Province, dredging and improving water ways chief items planned. Refugees are now arriving from Switzerland. One thousand or less per day so far. Additional barracks secured for use in handling projected refugee plans of increasing daily flow.
