In the case of communes and provinces the Prefect is required to approve both the budget estimates and the advances of funds that are requested, and he is advised what actual financial assistance has been given by Allied Military Government.
3. In the case of Lampedusa, which was formerly within the province of Agrigento, it was decided to refer the communal budget to the judgment of the Prefect, as he was the one Italian official in that area most competent to express a just opinion, having also at his disposal, for reference, the budgets of previous years. In discharging this function the Prefect acted not in an administrative but in an advisory capacity to the Regional Finance Officer, Allied Military Government, Sicily.
4. The establishment of a credit in favour of the comune of Lampedusa with the R. Tesoreria Provinciale, Palermo, was in accordance with the normal practice, and the Provincial Treasury was instructed to transfer these funds to the Treasurer of the comune, namely, the Banca del Lavoro, Lampedusa.
5. In territory under Allied Military Government the governing law is that of Allied Military Government. So far as possible the Italian law is followed, and in the present instance nothing that is contained in the Testo Unico 3 March 1934, n. 385 or D.L.L. 24 August, 1944, n. 211 is inconsistent with the procedure that has been adopted.

With a telegram dated the 14th of September n. 138186, the Prefect of Agrigento made us the following declaration :

The Allied Governor of the island of Lampedusa and the provincial officer of the Allied Control Commission ask that the island still remaining with the Allied Military Government should pass under the administration of the Italian Government. Particularly, they ask that the Serral should provide for the services of the food supply for the population, that the Intendenza Finanza should pay the pensions and that the Provveditorato of Studies should pay the salaries of the primary school teachers. That the service of payments to the family of those called to arms, should be reinstated and allot general assistance funds for the payment of the allowances to needy families. That, their being no public revenue in the Comune because of the miserable conditions of the inhabitants, a fund should be allotted to pay the remunerations to the employees of the Comune. I inform the Hon. Ministry of the above asking them to send me telegraphically the necessary authorisation, I will send you later the estimate of the expenses for the Italian State.

The Prefecture of Agrigento received the following answer, dated the 23rd of September, with the telegram n. 9393 :

To provide the financial help asked for the functioning of the services of the Comune of Lampedusa, we need immediately the balance sheet to carry on the concern, with enclosures, and the opinion of the Administrative Giunta Provinciale. I also send on to you the following letter of the Accountancy Section for Sicily in Palermo, concerning the above island:

Major Withers, Head of the financial Allied Regional Office ( A.C and A.M.G.) has expressed his wish to administrate personally from Palermo, through the National Bank of Work, the above advances.

He has issued, the 2nd of this month, the mod. 200/10, of which we enclose a copy, in favour of the High Commissariate on account of the Comune of Lampedusa. ( Prefecture of Agrigento ), to be used by issue of an order, of the High Commissariate himself, changeable in bank-drafts of the Bank of Italy, to be paid by the National Bank of Work, see of Palermo, Cashier of the Comune of Lampedusa.

It is a matter of adopting the system in force before the institution of this Delegato Office, system that does not constitute different difficulties than those made by a separate accountancy.

The Accountancy of the Prefecture of Agrigento will take into account the above advances and those that they will receive in future, for the compilation and the audits of the accounts and balance sheet of Lampedusa.

As what the Prefect has here referred is in contrast with his information in the above-mentioned telegram of the 14th of September, in as much that the passing of the Comune under the administration of the Italian Government would entail the application, in regard to the Body, of the dispositions of the communal law and provincial law in force (T.U. 3rd of March 1934 n.383) and, for the completing of its balance-sheet, of the Lt.'s Law Decree of the 24th of August, 1944 n. 211, we ask the Commission to kindly explain us the above, through the Ministry.

Con telegramma in data 14 settembre u.s.n. 138186. il Prefetto di Agrigento riferiva nei seguenti termini:
