The papers in this file relate to certain correspondence (brought to notice by Civil Censorship) between FLORES, Chief of Cabinet to the Presidency of the Council of Ministers and GALATA, Prefect of Ricci. The papers disclose FLORES recommending one ANGELELLI, a through-going fascist, for the post of Commissioner of the Fondazione Sabine Pasoli.</p> <p data-bbox="1062 1088 1297 2361">2. This S/C is only concerned with the action of its Prefect, GALATA. He seems to have behaved quite correctly in drawing FLORES' attention to his protégé's fascist background & in rejecting the nomination accordingly.</p> <p data-bbox="1297 1131 1502 2361">3. FLORES is not within the purview of this S/C. 1. The allegations of fascist activities have been found to be correct in all details.
2. Flores acted in good faith and had no knowledge of ANGELELLI's past other than a very misleading report supplied by ANGELELLI himself (copy attached).
3. Flores made the request on the strength of a recommendation made by a Colonel BALSAMO, Via Tirso 101, . This man was formerly personal private secretary to Badoglio.

Pro memoria written and signed by ANGELELLI and submitted to Mr. FLORES.

It is necessary to appoint a "Commissario to the Fondazione Sabina Popoli". The Commissario must not have any contact with state bodies or with the Ministry of Agriculture. The Commissario will increase the incomes of the firm by practical and economical means, employing only the necessary personnel, and giving a sure income every year. It is suggested to not appoint another official, already filling a post, in order not to do the same mistake of the Fascism when one person used to accumulate so many posts. For the appointment of the Commissario to "Fondazione Popoli" is suggested G.R. UFF. ANGELELLI Attilio, a Senior officer of the Army, who took active part, as a patriot, to the War of Liberation in the Lazio Region.

1. Attached hereto is a copy of correspondence supplied to us by Civil Censorship Group.
2. The following additional information re Subject has been obtained. ANGELINI lives at Via Arno 79, Rome. In his Prefettura file Subject has numerous letters signed by SEBASTIANI, Private Secretary to MUSSOLINI, others from various Ministers of the Fascist Era, all recommending him for his merit.
3. It appears from the censored correspondence that FLORES has been attempting to support the candidature of Subject, an undesirable Fascist, for the position of Commissario della Fondazione Popoli at Rieti.
4. This information is passed to you for information and such action as is desirable through Italian Government channels.

The writer Attests: " Caro Flores, In answer to your second letter, in which you recommend me to appoint Gr. Uff. Angellelli, Commissioner of the Fondazione Popoli, I am sending you enclosed a copy of the curriculum the same produced to my predecessors, In which, although the time was very different to the actual moment, it is not retained opportune to grant the inspiration of Angelelli. Angellelli Comm. Attilio
Member of the Direttorio Provinciale dei Tecnici Agricoli. Centurion of the M.V.S.N.- subscriber to the foundation, to the National Fascist Party from August 1921, took active part as squadrista in the Marcia su Roma and at the organization of the first fascist fighting men and of the Provincial Syndicates.
He gave his services of honour at the 1st Gran Consiglio Fascista, comprising the squadra of action Granatieri. He participated at the first meetings and at the first fascist movement of the Urbe, from 1919, giving his services with the legioners in August 1921, composed of squadra d'azione.
He was appointed by the Direction of the Party and by the Federation of the Urbe as a member of the first Consiglio Provinciale Agrario in Rome (1926-27).⁹

N.B. The letter has no stamp or sign which shows if it is of any official office.
