TO : RC, Region V

1. I refer to the conversation between Lieut. Lewis and Lt Col Pickering today.
2. I attach copy letter produced by the above-named whom the Italian Government desires to send to the Prefecture, Vasto, where his services are urgently needed in the capacity of 1st Secretary.
3. As stated to Col Pickering, a pass has been issued to enable him to proceed to Campobasso, where he had been told to report to Public Safety.
4. He has not been screened, and this Headquarters does not know whether his appointment has the approval or otherwise of A.M.G.
5. I understand that Col Pickering will deal with these points and if satisfied, will arrange for MARSILIA's dispatch to Vasto.
