This HQ has had dealings with Sig. NUCCI, Director of the Consorzio Agrario Provinciale, for 8 months and can fully confirm the Head of the Federazione's statement that Sig. NUCCI is able, honest and hardworking; that the position is one of great responsibility and that the Vice-Director is not capable of taking full charge. In fact, I do not know of any other person in the Province who would carry on the work as satisfactorily, and consider that Sig. NUCCI's tenure of the position is essential for the War Effort, - especially during this period of Harvest.

TO : Interior Sub-Commission.

1. Sig. Nucci, Michele fu Federico, is at present Director of the Consorzio Agrario Provinciali, Foggia Province. He has written the Federazione dei Consorzi Agrari, Naples, requesting that his status be clarified to facilitate the work of that organization. The matter is referred for your consideration, with the original letter and "memoriale" enclosed.

2. The Capo dell' Ufficio of the Federazione states that Sig. Nucci is able, honest, and hard working. The position is one of considerable responsibility, and difficult to fill. The Vice Director is not considered capable of taking full charge.

3. It is suggested that ACC, Region V, Foggia Province, through their association with Sig. Nucci in recent months, may be able to advise in the matter.
