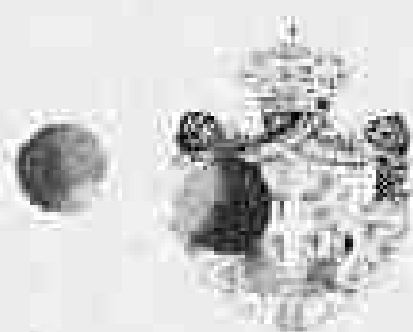

For these reasons, the Prefect not needing him, he asked for the undersigned to be returned to Rome. As the situation has not changed, the undersigned does not consider that his presence in Livorno is necessary,

6) Lastly, he points out that he is still convalescent, as a medical certificate which he is ready to show, can prove, the undersigned is not well enough to face the long and difficult journey to Livorno.

7) He respectfully asks that the Provincial Commissioner of Livorno, in agreement with that Prefect and the Ministry of the Interior, should send the communication referring to his definite removal from Livorno and return to Rome, as soon as possible.
