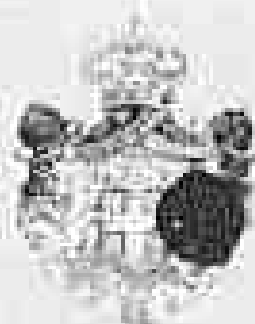

Your Excellency:

1. I refer to your letter no. 3753 Gabinetto dated 25 August written in reply to my letter dated 22 August.
2. Since this correspondence, it was agreed, in an interview on 5 September between your Chief of Cabinet and myself, that Dott. CIPRIANI should be called to Rome and kept at disposition here with a view to his appointment as Prefect of some newly liberated province; he was provisionally nominated for SAVONA.
3. I understand from Captain Williams, who saw H. E. Dr. Berruti on the point yesterday, that you agree that the arrangements made on 5 September cancel our previous agreement with respect to Dott. CIPRIANI becoming Prefect of RAGUSA.
4. I should be glad therefore to receive a nomination for the office of Prefect of RAGUSA. I am anxious to have this as soon as possible so that I can inform the Regional Commissioner in Sicily and request him to make arrangements to assist Dott. CIPRIANI's journey to Rome.

TO : His Excellency the Minister of Interior

Your Excellency:

1. I have received your letter no. 2289 dated 3 August and the enclosed statement.
2. DONADU, DE COYZUETA, VIRIGLIO: - the views of the Allied Control Commission upon your proposals as to these three Prefects will be conveyed to you as soon as possible.
3. SCIORILLI-BORELLI: - No specific proposal is made in respect of this Prefect. Does the Italian Government intend to give him an appointment and, if so, what; or can he be regarded as available for appointment (if satisfactory to the Allied Control Commission) to the prefecture of a newly liberated province.
4. ZANELLI, MOCCIOTTA, MESSA, SOLIMENA, SEVERINI, PETRAGNINI, PALMARDITA: - your intention to suspend these Prefects under Art. 22 of R.D.L. 29 July 1944 no. 159 as to actions against Fascism has been noted.
5. In connection with RAGUSA, the Regional Commissioner of Sicily states that he considers CIPRIANI, Dott. Cipriano, at present Reggente of this Province, to be worthy of promotion to the rank of Prefect. The selection of a name for this Prefecture is of course primarily a question for you to decide. I do not therefore make any recommendation as to Dott. CIPRIANI; I merely pass on to you the observations of the Regional Commissioner and ask you to take account of them when considering this province.
