Reference your 1st Ind R/3024, d/4 Sep 44.

- 1 - At the request of the Prefecture, the CERASO CC RR suggested several names for the appointment of a Sindaco. As RAGO's name appeared suitable for this nomination the Prefecture demanded a more detailed report on this man's account. The Major i/c CC RR at SALERNO Town submitted a favourable reply on 5 Aug. The report stated that - a) RAGO did join the FASCIST Party in 1930 but never held political office, but that he was a Militia Squad Leader (Serjeant), which RAGO admitted to the Prefect at a later date, b) that he was not a member of any political party but that he sympathized with the Democratic Liberals, c) that it was felt that he would be a good administrator, d) that his appointment as Sindaco would be favourably received by the population of CERASO. No immediate action was taken by the Prefecture on receipt of this CC RR detailed report.
- 2 - On the 15 Aug the Democrazia di Lavoro party with a membership of 200 in this Comune wrote the Prefect asking for RAGO's appointment. The Salerno Provincial Commissioner gave his approval to this appointment when asked by the Prefecture. On the 22 Aug RAGO was appointed.
- 3 - On 29 Aug a telegramme was sent to the Prefecture from the Liberation Committee of CERASO protesting against this appointment, on the grounds that RAGO had been a Squad Leader and was not liked by the people, and they asked that the Prefect annul the Decree. The Provincial Liberation Committee confirmed the CERASO Committee's telegramme on the same day. Again on the same day the following parties sent telegrammes and appreciation and applaud for the appointment of RAGO: Italian Liberal, Cristiana Democ. Lavoro, and Partito d'Azione. Dated 4 September, but received only recently, The Ministry of Interior (Cabinet) complained about this appointment, and the same Ministry (Public Safety) asked for an investigation to be held.
- 4 - On 11 Sep RAGO called on the Prefect, who asked him to resign. RAGO agreed to do so and wrote out the necessary document, which he has NOT as yet presented to the Prefecture. This is expected any day now.
