3. I mentioned the matter to Camer yesterday. He says MIGHIORINI's party office was quite a minor one, it is not one which renders an official liable to deportation proceedings. The Ministry thought therefore that they might use him in the South.

~~in Vico~~ Col Spicer referred to the Ministry's letter nominating him as Sindaco ~~in Vico~~. GIANNINI had called on Col Spicer and objected to that nomination intimating that he should have a position of higher importance, e.g. Prefect. Col Spicer had pointed out that the nomination and nature of the employment suggested came from the Italian Government and any consideration of their proposal should be dealt with by them. He therefore referred the matter to Berruti with a request to be notified of the Ministry's decision upon GIANNINI's objection.

2.

MIGLIORINI - Vice-Prefect

Col Spicer reminded Berruti of the arrangement under which all appointments of and above that of Vice-Prefect for restored Italy must be approved by ACC. He referred to letter 8 file 1/102 which suggested that MIGLIORINI had already gone to Sicily. ACC were not prepared to approve him. Camara stated that he had not yet gone and the letter was meant to signify that he had merely been appointed to the position. It was agreed that Col Spicer would write to the Ministry within 3 days.

3. Col Spicer stated that PATERNO', Prefect of Florence had interviewed him regarding the great difficulties he was experiencing in the proper discharge of his work on account of the activities of the C.L.N. ACC held the Prefect in high regard and reminded Berruti that the Prefect (under ACC) was the only proper Government authority in Florence.

Berruti stated that as the Government had no jurisdiction in this ~~ACC~~ area, it was their earnest wish that "everyone in Florence" should co-operate and obey the prefect and that his authority be respected. If the state in Florence exists in other towns, the problem would become worse.

Yesterday, a member of the C.I.M. (one of moderate tendencies) visited the President Bonomi and recounted the state of affairs from the C.I.M. point of view. This member had complained that the Prefect "was not tactful". Col Spicer agreed that the C.I.M. might charge PATERNO' with tactlessness, but it appeared to him that their charge was based on the fact that the Prefect would not do what the C.I.M. wanted him to do. Strong men were frequently ~~not~~ tactful.

The C.I.M. also complained because he was a Sicilian. Berruti said that the C.I.M. might feel they were "losing the game" and had therefore sent a moderate man to Bonomi with a view to the Prefect's removal. The view of the Government to which the President personally subscribed, was that the Prefect should be kept in office - at any rate until such time as the C.I.M. was brought to heel.

Berruti agreed with Col Spicer that if AMG had called a meeting of the C.I.N. immediately on the arrival of the Prefect and presented him to them as such, with the full authority of AMG behind him, many of the difficulties at present occurring might not have happened.

Berruti stated that the Prefect had offered to resign. This had been refused by the President. Col Spicer agreed.

4. COMITATO CENTRALE DI LIBERAZIONE

Col Spicer referred to previous enquiries regarding the existence of this Central Body and stated that he had seen correspondence officially headed as such. Berruti stated that he had enquired of Bonomi who said that the central organization had ceased to exist as a political body since the formation of the present Government. It continues to exist, however, as an administrative body dealing exclusively with matters concerning Partigiani.

1. An unofficial report has reached me that the Italian Government is considering to transfer of Dr. Stanislao MIGLIORINI, now Vice-Prefect in Frosinone, to a post in Littoria Province,
2. Inquiry reveals that Dr. MIGLIORINI is not well liked here. Apparently in the months before the end of Fascism, he was a Fiduciario del Gruppo Rionale Fascista "Genelli" in Littoria City. It is probable that it would be a great mistake to transfer him here again and I suggest that a representation be made to A.C.C. and the Italian government to that effect.
