1. The Prefect of Frosinone--ZANFRANCO--called and saw me on Tuesday, 14 November 1944, at 10:30 hours. He referred to the Ministry's proposal last September to transfer him to Lecce--see No. 14 on file--a proposal afterwards withdrawn because you wanted him ~~for~~ for the north and considered he would be handier if he stayed in Frosinone.

2. ZANFRANCO would like his transfer from Frosinone reconsidered for the following reasons:

(a) Provincial HQ Frosinone is Fiuggi, 750 metres above sea level and very cold: they had 50C of frost last week.

(b) He himself has not been well and was out of office recently for five days.

(c) His wife who is with him in Frosinone has been an invalid for five years.

(d) He would like to move himself and his family to a warmer climate.

(e) He has relations at Lecce with whom he could leave his family when called forward to the north.

3. ZANFRANCO emphasized that he was still entirely willing to go forward when called for. I believe it. He said he would guarantee to leave Lecce within 24 hours of being called, and to be in Rome within another 24 hours thereafter.

4. Points for your consideration:

SUBJECT: Prefetto Giovambattista ZANFRANCO.

18 November 1944

TO : His Excellency the Minister of Interior.

Your Excellency:

1. His Excellency the Prefect of Grosinone made a visit to this Sub Commission on 14 November, and referred to the proposal made by the Ministry in letter of 23 September last for his transfer from Grosinone to Lecce--a proposal which we subsequently agreed to abandon for the reason that this Prefect is held in reserve for the north and it would be more convenient and cause less changes among the Prefects if he would remain at Grosinone until required for a newly liberated Province.
2. Dr. ZANFRANCO inquired if his transfer to Lecce could not be re-opened, explaining that he would like to remove himself and his family to a warmer climate. He emphasized that he was still most willing to remain at our disposition for the north, and that he could leave Lecce immediately after being called and be in Rome a very short time afterward.
3. I hold Dr. ZANFRANCO in high regard, and I have given his proposal very careful consideration. It is, therefore, with regret that, in informing Your Excellency of the Prefect's request I feel bound to add that I do not think the Commission could properly agree to it. The principles of good administration must take priority over the personal wishes of public servants. If Dr. ZANFRANCO's request were accepted, it would involve a double change in the office of Prefect at Lecce--the one immediately and another in the near future when Dr. ZANFRANCO is called north. Moreover, if I admit questions of personal convenience as good grounds for transfer in this case, other cases will have to be treated in the same way: and I am convinced this cannot be done in hard times like the present without detriment to an administration which Your Excellency and this Sub Commission are already hard put to it to restore and keep efficient.
4. Please be good enough to convey my decision to the Prefect: please assure him that I am indeed sorry not to be able to meet his wishes, and that I hope an opportunity will arise very soon to enable him to serve his country in a newly liberated Province.

SUBJECT: Interview with Mornillo, Prefect of Benevento

DATE : 11 October 1944

1. The Prefect, MORNILLO, came to see Col. Spicer because he had received a cable from the Prime Minister, Bonomi, stating that as of the 11th October he was to be at the disposal of AOC, and that he was to be substituted in his position at Benevento by Rosso.
2. He had been told that we could throw some light on the situation. I ascertained from my file that he was to be made available for an assignment in a northern province, and that in the meantime he was to be in Rome, subject to call. The Prefect explained that he did not want to give the impression that he was unwilling to take assignment north; that as a matter of fact he was quite disposed to do anything in the service of his country.
3. He merely wanted to point out that he had been ill for two months with some stomach trouble and that within thirty or forty days he would be able to get proper medical care, so that his health would be sufficiently restored to enable him to withstand the rigors of any difficult assignment.
4. I informed him that there was no immediate assignment for him and that he would have some opportunity while awaiting assignment to take care of himself. That seemed to satisfy him sufficiently.
5. He now lives in Rome, having already left Benevento. His address is Via Scarsa 22, Piazza Tuscolo, Interno 13, Rome. He has no telephone but he gave me the telephone number of a friend who lives in the same floor, namely, 760466. Incidentally, he indicated that there was no current in the building, as a consequence of which water is not pumped up in the apartment and he wondered if we could be of any help. I told him that the distribution of current is in the hands of the Italian authorities, and that he should take the matter up with them.
6. Mornillo stated that if it were at all possible he would like to be Prefect of Padua. He knows Padua only as a tourist, however. The reason he asked was a personal one again; namely, he would like to be near a place where his wife, who suffers from rheumatic fever, could get medical aid. His family consists of a wife and one child.

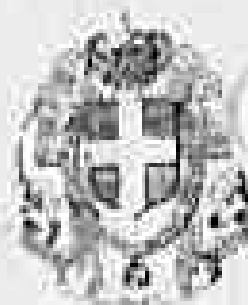

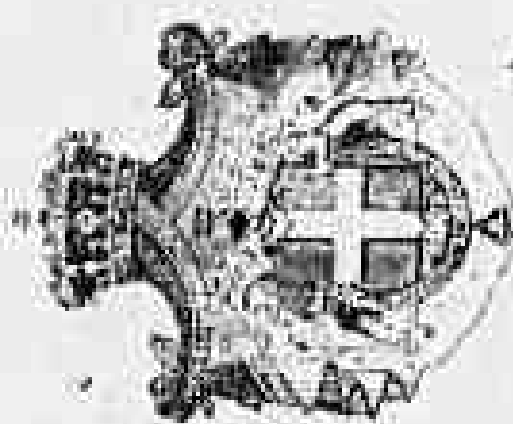

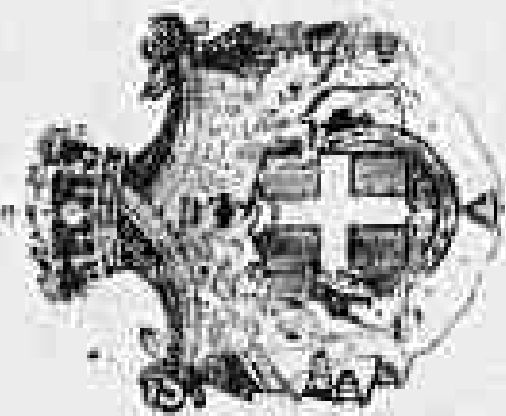

SUBJECT: Movement of Prefects

TO : His Excellency the Minister of Interior

Your Excellency:

1. I refer to your letter of 23 September and the enclosed list of movement of Prefects, and to my reply of the same date. When Captain Williams saw Dr. Camera yesterday, some alternative proposals were mentioned to him; and Captain Williams conveyed my views upon these proposals to your Chief of Cabinet this morning.

2. It is accordingly agreed that instead of the proposals described in the list annexed to your letter above-mentioned under the heading "trasferimenti", the following shall be substituted:-

ZANFRANCO. . . . to remain at Frosinone for the present and to be regarded as at the disposition of the Allied Control Commission if and when he is required for a northern province;
 PORTIGNONE. . . . from Catanzaro to disposition of the Italian Government;
 SOLDANI. . . . From disposition to Catanzaro;
 GIAMMICHI. . . . from disposition to Messina;
 MORILE. . . . to remain at Venevento for the present but to be regarded as at the disposal of the Allied Control Commission if and when he should be required for a northern province;
 ROCCA. . . . to remain at Lecce;
 VOLPE. . . . to remain at Salerno;
 STELLA. . . . to be recalled from Sicily to Rome to remain at the disposition of the Allied Control Commission for a forward province when required;
 FORTI. . . . to remain at Macerata.

All the above proposals are agreed to.

3. The following additional proposal is also agreed: -

VENTURA from disposition to Catania.

4. It is agreed, I understand, that the Vice-Prefects recommended for promotion named in paragraphs 5, 6, and 7 of my letter of 23 September, shall remain at our disposal. The proposal to Dr. FOTI in paragraph 9 of my letter is also agreed to.

5. With regard to the calling of functionaries from distant seats, I understand that Drs CIPRIANI and MOZZI are expected in Rome this week, and that you are telegraphing to recall Dr. STELLA today. I am communicating with the Regional Commissioner of Sicily asking him to facilitate Dr. STELLA's journey.

SUBJECT: Movement of Prefects.

TO : His Excellency, The Minister of the Interior.

Your Excellency,

1. I refer to the letter dated 23rd September (and to the annexed table showing proposed transfers and promotions of Prefects) which your Chief of Cabinet left with me this morning. The observations of the Allied Control Commission are set forth below.

2. Trasferimenti:-

ZANFRANCO I am anxious to have this Prefect's services in some province of importance in the north. He should be considered as at the disposal of the Commission and in the meantime should remain in his present post.

PONTIGLIONE. This Prefect is considered by the Commission to be exceptionally weak and inert, particularly in the matter of putting into effect R.D.L. 4 April 1934 No. 111. The province to which he is proposed to be transferred, SALERNO, is also particularly backward in this respect: and it requires someone with more energy and decision than Dr. PONTIGLIONE has shown. I would ask you to consider the desirability of placing him at disposition rather than transferring him to SALERNO.

SOLDANI: See above in connection with Dr. ZANFRANCO.

GIAMMICHI No objection.

NORMILE: No objection but the Commission would like this Prefect to be considered as at their disposal for a newly liberated province.

ROCCA: }
VOLPE: } These Prefects are not acceptable for newly liberated Provinces.

STELLA: We wish to keep Dr. STELLA at our disposition for the North. This is most specific.

PONTE: As this Prefect was sent to MACERATA only two months ago, I cannot see my way to agree to his transfer.
