SUBJECT: Note of interview - Ministry of the Interior

DATE : 15 December 1945 - 10.00 hrs.

PRESENT: Dr. Giuseppe ROMITA, Minister of the Interior
 Dr. Giuseppe SPATARO, Under Secretary of the Ministry of the Interior
 Dr. CATERINI, Chief of the Cabinet
 Major R.A. Temple, Director, Local Government G/3.
 Mr. Arrigo Nico, interpreter.

1. I told Dr. ROMITA that I was paying this visit as a courtesy call and that I wished him all success in his new office.
2. I assured him that the new cooperation which existed between the Local Government G/3. and his predecessors would continue. He expressed his gratitude for my call and that he was sure relations would continue to be cordial.
3. I informed the new Minister that the matter of having inspectors-general to watch the progress in compiling electoral lists had been raised at the Regional Commissioners' meeting in Milan, and that the idea had been approved.
4. I could therefore inform Dr. ROMITA that the proposal of the Ministry to organize a special inspection service had the approval of the Allied Commission.
5. I also informed him that I would send a formal letter to that effect.
6. I told Dr. ROMITA that instructions could have to be issued shortly by the Ministry to all Prefects in the territory which was coming under the jurisdiction of the Italian Government on 31 December explaining whom to contact in connection with various military or civil administrative matters.
7. At the present time instructions to Liaison Officers and Military Commanders were being prepared.
8. I showed all three officials the graphs that had been prepared by the Sub Commission which depicted progress concerning the compilation of electoral lists. They were enthused about them and Dr. ROMITA asked if they might be borrowed by the Ministry so that copies could be made. I left the charts with them for copies to be made.
9. After I had left Dr. ROMITA's room, Dr. SPATARO raised the matter of the replacement of the Prefect of Milan. I told him that I was awaiting a decision by the Government. Dr. SPATARO then asked whether I would be good enough to discuss the situation with Dr. ROMITA. I consented to do this whenever

9. After I had left Dr. Ronzini's room, Dr. Spataro raised the matter of the replacement of the Prefect of Milan. I told him that I was awaiting a decision by the Government. Dr. Spataro then asked whether I would be good enough to discuss the situation with Dr. Ronzini. I consented to do this whereupon Dr. Spataro called Dr. Ronzini into the room. I told Dr. Ronzini that I had mentioned the subject to Dr. Spataro two days before.

10. It was desirable to fill the vacancy at Milan caused by the assumption of the post of Minister of Transport by the former Prefect of Milan. I informed Dr. Ronzini that the Regional Commissioner had expressed his opinion that a career prefect was desirable, and that he asked whether the Italian Government may consider in particular the possibility of Dr. Biondini former Prefect of Como, who the AL had met at Milan.

11. However I made it clear to Dr. Ronzini that the Allied Commission did not insist on the appointment of any particular type of prefect that is career or not career, or any specific man - that this was a decision for the Italian Government to make -. Dr. Ronzini said that he understood perfectly.

12. (Mr. Catenacci later in the hall explained that was perfectly obvious to me, i.e. that there was a division of opinion on the subject of career and non-career prefects between the new Minister who is a Socialist and the Under Secretary who is a Christian-Democrat.)

Apparently Mr. Catenacci and Dr. Spataro hoped that I might tip the balance in favour of a career Prefect by indicating that this was officially the desire of the Allied Commission.

I carefully refrained from taking any stand on this point).

SUBJECT: Note of interview - Ministry of the Interior

DATE : 13 December 1945 - 11.30 hrs.

PRESENT: Dr. CATENACCI, Chief of Cabinet, Ministry of the Interior
Major R.P. Temple, Director Local Government S/C.
Dr. Arrigo Rice, Interpreter.

1. I told Dr. CATENACCI that we had received a telephone call from the Regional Commissioner of Lombardia and pointed out that a replacement was necessary for the Prefect of Milan, inasmuch as the incumbent, Dr. Lombardi, had been appointed Minister of Transport in the Cabinet, and was relinquishing his post of Prefect.
2. I explained that the MC had suggested that a career Prefect be nominated and asked that the Italian Government consider the possible nomination of Dr. Mario TRINCHERO. The latter had been Prefect of Como until the Fascists threw him out of office.
3. The MC who had met him was very favourably impressed by him. I told Dr. CATENACCI, however, that I understood that the OLI in Milan was split on the question as to whether a career Prefect or a non-career Prefect should be appointed. Furthermore I informed Dr. CATENACCI that the Allied Commission was not insisting on the appointment of a career Prefect, but merely wished to bring to the Government's attention the suggestion of the Regional Commissioner, who was usually in a position to appraise the local situation most accurately. Dr. Catenacci said that he was familiar with Dr. TRINCHERO, and that the latter was a very capable official who had been imprisoned by the Fascists and in fact had escaped to Switzerland.
4. He said Dr. Trinchero had a very good reputation and probably would be politically acceptable. In any event he would have the matter taken up with the Ministry of the Interior and the Presidency of the Council and would let us know.
5. I indicated that if the Government desired to submit several names they may do so.

I conferred with the Provincial Commissioner first on the compilation of electoral lists and other local government matters, and then later we both went to the Prefect's office where we covered the same and additional ground. The Provincial Commissioner pointed out that the city of Milano is under another Allied officer (Lt. Col. Hershenson) and that his jurisdiction is that of the rest of the province excluding the city.

2. It was his opinion that the Prefect, who is a member of the Party of Action, was still under the influence of the CLN to too much of an extent. In fact he showed me some documents which contain the "visto" of AMG and the seal of the Prefettura. In the center of the seal of the Prefettura, the Royal Arms have been removed and replaced with a star and the initials "CLN". I obtained a copy of one of these documents in which a Sindaco was appointed in this Comune in the Province. The PC said that he has not taken this point up because he does not think it means too much and it is just a continuation of a longer series of similar incidents. So far as the administration of the Prefect was concerned, the PC thought he was an able man. My own impression was that he was a capable person who had a broad point of view and realized his shortcomings. In fact, shortly after we began talking and he realized what the nature of our conversation would be, he asked whether he could call in his legal adviser who was familiar with the administrative law and apparently was the person upon whom he leaned in connection with the administration. The Prefect is a young man, and impresses one with his sense of responsibility and power.

5. There is no problem regarding the lack of Communal Secretaries. Practically of the old ones were retained in office by the Prefect in spite of their background, and he is now making substitutions. The Association of Communal Secretaries is submitting names of possible candidates. There is a school for communal secretaries located at Milano.

6. Sindaci have been appointed in all of the Communes. They are now being formally confirmed in office. The PC was under the impression that all the Sindaci were under the thumb of the CLN. All of the old ones had been thrown out of office and replaced when AMG moved in. The Prefect mentioned the fact that the rates of pay of temporary employees made it difficult for him to put on such personnel since they were unwilling to work at the rates fixed as of 3rd April. He thought that this difficulty might prevent their recruiting staff for the task of compiling electoral lists. I informed him and the PC that I would bring this matter to the attention of the proper authority at this HQ, and suggested that Labor Sub Commission be sounded on this matter.

7. Giurte have been established in every comune, but in most cases they are larger than the size provided by law. The Prefect is now reducing them in size and hopes that this task will be completed in two weeks for receipt of the formal approval by the Provincial Commissioner.

8. A Deputazione Provinciale of 10 members and 4 substitutes have been appointed by the Prefect and approved by the RG. The 4 citizen members of the CPA have not been appointed. Names for candidates will be submitted to the Deputazione Provinciale in a day or two, so the Prefect informed me. The Prefect said there was no shortage of expert and technical personnel in the Prefettura. The following are his top personnel:

VZV - Dott. FREMURRI He is a career Vice Prefect who was on leave when the Allies entered the province. He did not take the Oath to the Fascist Republican Government.

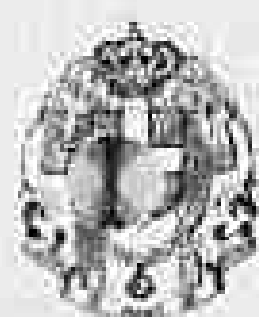
Naturally Accame declared that he insisted as charged to do so by the Allies - like many Italians have unfortunately taken the habit to do when their interests and rancours are at stake.

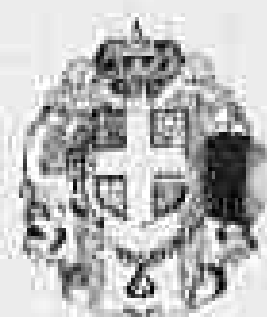

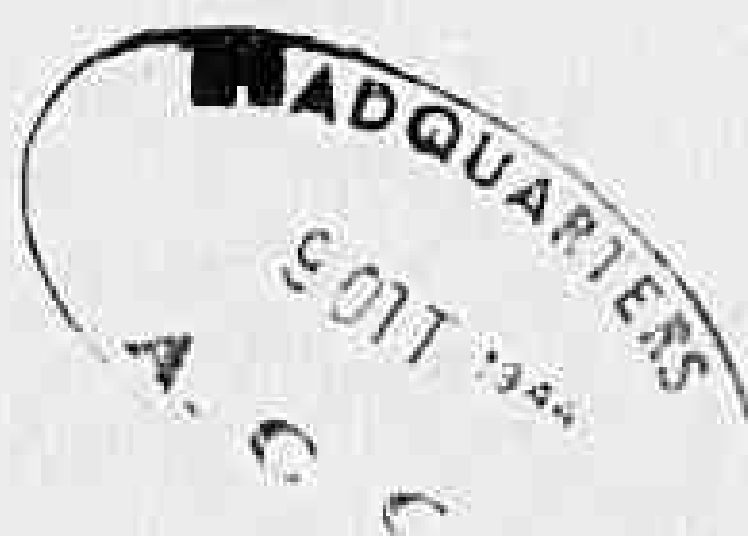
1. We have received the copy of your letter to the Chief Commissioner concerning prefects and sindaci of Milano. The suggested names were of interest since this Headquarters had already received information concerning all of them. We shall be interested in receiving additional names, as you receive them, not only for Milano Province but also for the other provinces in the Lombard Region.

2. We appreciate fully the necessity for working closely in these matters with the Italian Government. However, in spite of any suggestions and information received now, we consider it unwise to make any selections until we are actually in the Region.

3. My views on reported prefects are well known to you because of the discussions we have had frequently on the subject. During the early period of AMG administration in Lombardy, we believe that as a general policy local men should be selected to serve as acting prefects. Bringing to Lombardy ready-to-wear prefects from Southern Italy will not satisfy local public opinion, it is feared. Good prefects, we are sure, can be found within the Region in the same way that we found them in Sicily and in Naples and Rome provinces.

TO : Office of the Chief Commissioner
(Personal attention of Col. Montford)

1. I have interviewed Generale ACCAME and frankly I was impressed with his personality.

2. As you are aware, the Prime Minister himself had expressed the wish to be consulted closely in the appointment of both the Prefects and the Sindaci of the larger towns in the north of Italy.

3. I discussed the suggestion of General ACCAME with him. His reply was that he did not know him, that he had not been heard of, and considered him to be an unsuitable appointment for such a city as Milano, where, in the opinion of the Italian Government, a Prefect and a Sindaco who were publicly known throughout Italy were required. Generale ACCAME might be known to a small circle of industrialists, he could under no circumstances be called a national figure.

4. He gave me the following names:
