Col. Ruggero Bambini

Born in Bettona. Subscribed in the Fascio of Perugia, together with Uccelli, in February 1922. Regular officer (captain) in the 1st Artillery of Foligno. Owner of estates of a certain extent, sold everything including the family tomb, to face the huge expenses ~~coming from~~ ^{due to his} luxurious life and love affairs. When short of money, he contracted debts for some hundred thousands lire from ~~local~~ ^{people who} had made small savings and afterwards he became bankrupt with sentence of Perugia's Tribunal (1929, 1930). Was radiated from the Army. He moved to Rome where he frequented a questionable society and made money with immoral bargains. Joined the Fascist Militia where he was given the rank of "SENIORE", and was attached to the General Hdq. (1932, 1933). During the last months of the African war he ~~was~~ went as volunteer and stayed some ^{4 1/2} ~~time~~ in a warehouse, and this position gave him some benefit.

He participated to the war against Greece, and he behaved well.

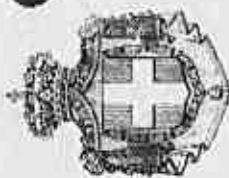
At the Armistice, he was an Artillery Colonel in Pisa. Afflicted with a prostatic disease and not being able to delay the surgical operation, he was taken to the hospitals of Spoleto and Spello. After the liberation of Umbria he was still in Cannara, not being yet able to move and he lived with his brother in law, the fascist podestà. Then He contacted the local antifascists, to whom he stated that he had been harassed by the doctors in order not to serve the Germans.

Afterwards he succeeded being appointed "Sindaco". As his past has arisen and his manoeuvres to save his brother in law and to go back to the Army became clear, he says that nobody can remove him as he is a friend of the Prefect^{and} of the Questore, who were his subalterns, and a relative of ~~the~~ General Gigliarelli. He states he is backed up also by Count Pucci.

He is detested by the whole population. 1180

ISTITUTO NAZIONALE DELLO STATO

COL. RUGGERO BAMBINI - Nativo di Bettona. Iscritto al fascio di Perugia, assieme ad Uccelli, nel febbraio 1922. Capitano di carriera nel 1° Reggimento Art. di Foligno.

Possessore di beni immobili di una certa entità con il fratello, si vendette tutto, compresa la tomba di famiglia, per affrontare le ingenti spese provenienti da lussi ed amori giovanili. A corto di denaro contrasse prestiti per alcune centinaia di migliaia di lire presso i piccoli risparmiatori di Bettona. In seguito a ciò fallì per bancarotta fraudolenta con sentenza del Tribunale di Perugia nel 1929-30.

Fu radiato dal R.Esercito.

Si trasferì a Roma dove frequentò ambienti equivoci esercitando immorali mercati per guadagnare.

Un impiego presso la Federazione degli Industriali gli fu tolto per le pressanti richieste dei creditori ai dirigenti.

Entrò nella M.V.S.N. dove ebbe il grado di seniore presso il Comando Generale: tale era nel 1932-33.

Durante gli ultimi mesi della guerra d'Africa partì volontario al comando di CC.NN. e stette vario tempo presso un magazzino, circostanza che gli procurò dei benefici.

Prese parte alla guerra di Grecia, dove si portò bene.

L'armistizio lo trovò colonnello di artiglieria in Pisa.

Malato alla prostata ed in condizione di non poter differire l'operazione chirurgica si fece ricoverare presso l'ospedale di Spoleto e di Spello.

Alla liberazione dell'Umbria era in Cannara, ancora in condizione di non potersi muovere, presso il cognato, podestà fascista.

Si mise in contatto con gli elementi antifascisti, cui dichiarò di essersi fatto massacrare dai medici per non servire i tedeschi. In seguito a ciò riuscì a farsi nominare sindaco.

Emerso il suo passato e le sue manovre per salvare il cognato e ritornare nell'Esercito attualmente dice di essere inamovibile perchè amico del Prefetto e del Questore, già suoi subalterni, e parente del generale Gigliarelli. Dice di essere aiutato anche dal conte Pucci.

E' malvisto dall'intera cittadinanza.
