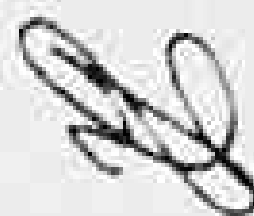

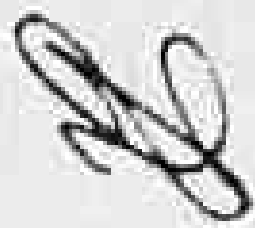

had an arrangement with the Director General of Personnel to go back and see him and discuss these matters.

9. In fact, he returned to Rome a day or two ago. He did not report to the Ministry to the Director General of Personnel, or to anyone else in the Ministry, or return to Aquila.

10. Dott. OMODEO-SALE's statements to the Prefect are entirely contrary to the orders he received by the Local Government Sub Commission. He must have known he was making untrue statements.

11. Because he did not stay at Aquila, the Prefect of that province did not comply with the Ministry's orders to send Dott. COLUCCI, who was then his Vice Prefect, to Teramo. As a result of Dott. OMODEO-SALE's behaviour and the Prefect's failure to comply with orders about Dott. COLUCCI, the arrival of the Vice Prefect at the Teramo Prefecture (where there was urgent need of one) was delayed for nearly two months.

12. In the meantime, the Ministry had proposed the promotion of OMODEO-SALE to the rank of Prefect and to substitute him at Aquila by Dott. VADALE, both the Ministry and the Local Government Sub Commission believing that Dott. OMODEO-SALE had taken up his duties as Vice Prefect at Aquila.
