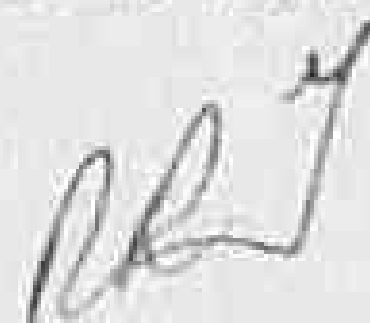

SUBJECT : Notes of interview with avv. Ambrogio VIALI, Prefetto Delegato di Imperia - on 22 July 1945

TO : Director, Local Government and Communities

FROM : Captain, S.I. CUNNINGHAM.

1. The Prefect is a pleasant mannered person. He appears to be efficient and to know how the Prefecture should function. It is difficult to form an opinion of such a man on one short interview but I think he is lacking in drive. He leans rather heavily on the Vice Prefect VIALI. He appears younger than the general run of Prefects.

2. The Vice Prefect VIALI. VIALI is a very good worker and the Prefect is very pleased with him and thinks a lot of him. He is a career official who came from Beseneto recently where he assisted in preparing the electoral lists. He is the only senior career official.

3. Vice Prefect Inspector. There is no career Vice Prefect Inspector but there are two "Politicos". avv. VITTORIO formerly leader of the local partisans and avv. GIANNI a local lawyer. The province has been divided between them and they are fighting round the Communes and paying particular attention to the preparation of the electoral lists. The Prefect says they are both good workers.

4. Other officials. There is only one Consigliere in the Prefecture but there is another Consigliere for the "Fondi del Culto" and he has been roped in to sit on the CPA when necessary. There is one segretario. The Prefect has written to the Ministry asking for his requirements. He would like two more Consiglieri, a segretario and a 1° Regischiere.

5. Deputazione Provinciale was meeting regularly and was established according to the law with 6 members and 2 supplenti.

6. C.P.A. was also functioning. The four citizen members were appointed and meetings were held with the assistance of the second Consigliere from the "Fondi del Culto".

7. Giunta Comunale. There are 53 Communes in the province and all have Giunta but in 23 Communes this has not been constituted in office. The Prefect

2. The Vice Prefect **Vincenzo Petti**. Petti is a very good worker and the Prefect is very pleased with him and thinks a lot of him. He is a career official who came from Benevento recently where he assisted in preparing the electoral lists. He is the only senior career official.
3. Vice Prefect Inspector. There is no career Vice Prefect Inspector but there are two "Politicos". **Antonio Vittorio** formerly leader of the local Partisans and **Avv. Benedetto** a local lawyer. The Province has been divided between them and they are going round the Communes and paying particular attention to the preparation of the electoral lists. The Prefect says they are both good workers.
4. Other officials. There is only one Consigliere in the Prefecture but there is another Consigliere for the "Mondi del Gulto" and he has been roped in to sit on the G.A. when necessary. There is one segretario. The Prefect has written to the Ministry asking out his requirements. He would like two more Consiglieri, a segretario and a 1° Regidore.
5. Deputazione Provinciale was meeting regularly and was established according to the law with 6 members and 2 supplenti.
6. G.P.A. was also functioning. The four citizen members were appointed and meetings were held with the assistance of the second Consigliere from the "Mondi del Gulto".
7. Giunta Comunale. There are 33 Communes in the Province and all have Giunta but in 23 Communes this has not been confirmed in office. The Prefect is examining the position and confirming them as quickly as possible. Several Communes had been occupied by the French until 10th July and this had delayed the setting up of Giunta.
8. Sindaco. Every Comune has a Sindaco regularly appointed by Decree of the Prefect.
9. Segretario Comunale. There are 34 career officials. Some are looking after two Communes. All Communes have the services of a segretario and the Prefect is satisfied that the arrangement is working reasonably well.
10. Preparation of electoral lists. I had a special meeting on this subject with the Vice Prefect **Vincenzo**, the Vice Prefect Inspector and the Consigliere. As stated before the Vice Prefect **Vincenzo** has already had experience of the preparation of the lists and he seems to have everything working smoothly. The work has continued in all Communes and he is getting the two Vice Prefect Inspectors to visit them regularly to see how it is going on. They have put in an application for a 60 days extension of time as in several Communes the records (anagrafe) were completely destroyed. I stressed the importance of sticking to the time-table and the Vice Prefect **Vincenzo** said that the extension might not be necessary but that they had applied to keep the deadline right. He assured me that they were paying particular

attention to this work and that there would not be any avoidable delay. The -Casellario Giudiziale was intact in Imperia Province but they had a lot of people born in other provinces resident in Imperia now and it would take a considerable time to get their records from all over Italy and Sicily especially as many Casellari had been destroyed. The electoral Commissions were being established soon. The Prefect had already named his nominees and the other names were being obtained.

11. The Provincial Election Commission had been set up. There was a difference of opinion between the career Vice Prefect Vicario and the Partisan Vice Prefect Inspector as to how it was functioning. The Vice Prefect Vicario was satisfied but the Vice Prefect Inspector thought it was too slow and too soft!

2. The Prefetto Benigno Av. Ambrogio VIANI is absolutely straight and honest and the PC has a very high opinion of him. He is a Christian Democrat. He cooperates fully with us, but the PC think he is too weak to carry on alone when things go. The Italian Government should be urged to put in a strong career Prefect as soon as it goes.
3. Vice Prefect Vitorio Belli, known well, arrived from Benevento about four weeks ago. The PC was not impressed with him at the first but he had got down to work well and had made himself popular with the people. He was not afraid of saying what he thought and the PC thought he might be suitable as a Prefect for Benevento. Belli, however, had been in charge of the preparation of the electoral lists in Benevento and was supervising the work here.
4. Vice Prefect Inspector. There are two men career Vice Prefect Inspector. One is Umberto Vittorio in a partisan leader. He is a good honest chap - one of the good partisans. The other is Paolo Manuel GEMELLI a local lawyer. Both are going around the Communes checking appointments and supervising the preparation of the lists.
5. Other officials. Are very scarce. The Prefect has written for more. Revision is set out in Form A which was forwarded.
6. Delegations Provinciali was functioning regularly. Members were obtained from C.L.N. and if acceptable were approved by us.
7. C.L.N. The four citizen members have been appointed and the Giunta was functioning.
8. Sindaci and Giunta Comunale were in all Communes.
9. Segretari Comuni. Some Segretari were lacking after the Communes but all Communes were being served by Segretari.
10. C.L.N. The PC had not had much trouble with them. They understood their position and that they could only offer advice. He found them quite cooperative.
11. Preparation of electoral lists. The Communes had all been received and delivered to Communes and the work commenced. Most of the Communes were occupied by the French until 10th July and the forms were distributed to these Communes immediately the French moved out. The Prefect has applied for an extension of time of 60 days owing to destruction of Communal records in several Communes but this application is being held up pending receipt of instructions from us. He is being urged to get the work finished as soon as possible.

The Electoral office has been set up in the Prefettura and names are being obtained for the electoral Commissions.

12. The Provincial Deputation Commission has been set up and is functioning.

13. The PC doesn't think that the Province or any of the Northern Provinces should be handed back to the Italian Government for several months as the Public Safety position requires a lot of attention and he is afraid there will be trouble when AME goes.

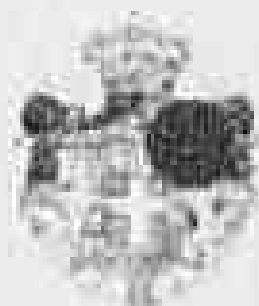

1. PARENTI produced the list (at fo. 718) of officials available to North as Vice Prefects.
2. We observed that the first name on the list was GARDINO-SALIS, as to whom we had long ago informed the Ministry that he was not acceptable to the Allied Commission in any capacity.
3. We also observed that 7 officials were marked "soltanto giurato". He explained that this meant that the only charge of Fascism against them was that they had taken the oath to the republican Government, and that they had not yet passed through epuration. I said that under no circumstances could we accept any official who had not undergone due process of epuration.
4. I observed that there were a number of new names on the list we had never heard of before, and I should have to look into it and reply to the Ministry in writing as to who was acceptable or not.
5. He then referred to the discussion on Friday last, 25 May, and to the agreement reached with Dott. GABBA that all officials liable to serve in the North should be warned in advance of their liability, so that they could make their excuses now. He said the Ministry had overruled Dott. GABBA and agreed with his view and did not propose to warn people in this way. I said I had written a letter to the Ministry on 26 May summarizing the results of this discussion and referring to the proposal of warning officials in advance. If the Ministry were now unwilling to do this, I must have that in writing. He agreed to send the letter.
6. Ferrara. Dott. COCCIA would be in Rome on Friday, 1 June, ready to go North. He has been informed of the new grant of 20,000 lire. (Note: Obviously his plea of illness was a lie.)
7. Piacenza. D'ERRICO has plead illness after being informed of the grant of 20,000 lire. The Ministry will give us another nomination tomorrow.
8. Bologna. I said we telegraphed PC Ancona to facilitate this official's journey to Bologna direct. PG, however, had telephoned today (Major Maudera - Capt. Lewis, to say that BELLO had just been given 15 days leave to go to home on private affairs. As to this, see file 4/117 fo. 131. As there is no signal communication with Venetia Region and it is very improbable BELLO would leave home before his private affairs are completed, no matter how imperative his orders, we said it seemed better to make another nomination. PARENTI agreed and promised to give another nomination tomorrow.

9. Imperia. PARSONI said the Ministry's nomination for this post was PERI, Dott. Armano, now Consigliere 1^o classe at Benevento. After some discussion, we accepted him and he said he would be in Rome ready to go on Friday, 1 June.

10. Before agreeing to PERI, however, we pointed out again that obviously the idea of a "pool" was not working. In this case, for one of the chief vacancies in the North, the Ministry nominated an official quite unknown to us, for whom we have no biographical particulars, and who is not in Rome. *or who is now suggested for the "pool" for the first time.*

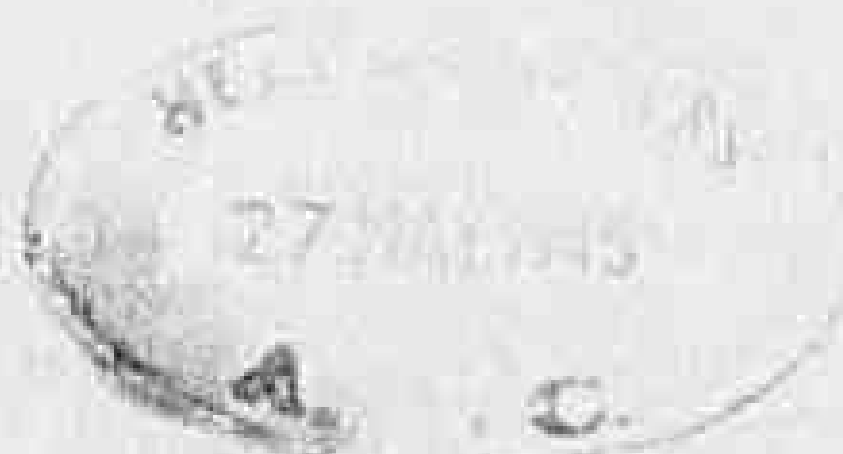

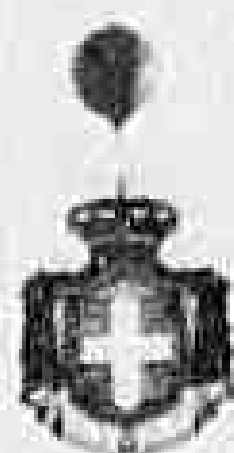
