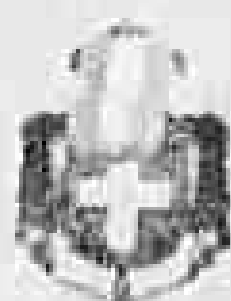

1. Reference is made to RC Sondrio's letter to this HQ, reference 80/leg.195, dated 15 September. I annex a copy of this letter, as it does not appear on the face of it to have passed through your HQ.
2. The transfer of Dott. BERTINI from Pavia to Sondrio for which the RC asks is a matter entirely within your competence, as these 2 provinces are both within your Region. There is no need to refer to this HQ or the matter, much less the Italian Government.
3. The Sindaco of Sondrio had no business to write to the Ministry of the Interior on the matter: he should have referred his request through his Prefect and RC. It might be advisable to bring this to his notice.

1. The Prefect said that he was in need of a Vice Prefect Inspector, 2 Consiglieri and 2 Segretari. I informed him that arrangements already had been made to dispatch a Vice Prefect Inspector and outlined the procedure for securing personnel below that grade. The Provincial Commissioner characterized the Prefect CONTI as a very good man, but who has a disproportionate view as to what is important. The Vice Prefect Vicario has the legal grade of Vice Prefect Inspector and is a typical career functionary, but seems to be quite energetic and interested in his work. He has set up the Electoral Office, to which he has assigned Dott. CARONERA and Dott. RENEVENTO, both Vice Segretari. Dott. CARONERA, although a non-career recent appointee, impressed me as being a capable official. The organization of the Prefettura reveals a serious lack of trained officials. In fact, the Vice Prefect Vicario and the Capo di Gabinetto are the only trained men on the administrative side. Consigliere Dott. BAREATO does not report to the office--he is subject to eparation. The Prefettura is also weak on the accountancy side. The Rag. Capo (RE MEO) is old and ill and Dott. CONTI, Ragioniere, is not well also. This lack of Consiglieri explains why the CPA has not been able to be properly constituted, although the 4 citizen members have been appointed.

2. The Deputazione Provinciale has been established. In the 78 Communes, Giunte Comunali and Sindaci are functioning. All of them have been confirmed en bloc by the R, but not all have received formal notice of their appointment by the Prefect. The Prefect was urged to do this immediately. All of the Communes are covered in whole or part by Segretari Comunali. There is a lack, however, of some trained officials. Some instructions have been sent to the Communes, but not all the electoral material has been distributed as yet. I urged the necessity of distributing all the material immediately and not to await responses from the Communes as to what they need.

3. Electoral Commissions have not been established as yet. There are 5 "mandamenti" in the province.

4. All the cumulative registers are intact, but 3 Communes have

CARBONERA, although a non-career recent appointee, impressed me as being a capable official. The organization of the Prefettura reveals a serious lack of trained officials. In fact, the Vice Prefect Vicario and the Capo di Gabinetto are the only trained men on the administrative side. Consigliere Dott. BARGATO does not report to the office--he is subject to epuration. The Prefettura is also weak on the accountancy side. The Rag. Capo (RS NEO) is old and ill and Dott. OGNI, Ragioniere, is not well also. All of them have been confirmed 'en bloc' by the R, but not all have received formal notice of their appointment by the Prefect. The Prefect was urged to do this immediately. All of the Communes are covered in whole or part by Segretari Comunali. There is a lack, however, of some trained officials. Some instructions have been sent to the Communes, but not all the electoral material has been distributed as yet. I urged the necessity of distributing all the material immediately and not to await responses from the Communes as to what they need.

3. Electoral Commissions have not been established as yet. There are 5 'mandamenti' in the province.

4. Almost all the population registers are intact, but 3 Communes have reported that they are destroyed. The records in the Casellari Giudiziali have not been destroyed. Relations with the CLN are outwardly good, although the PC says there may be some undercover work going on. Incidentally, I noticed that the stamp of the seal of the Prefettura of Sondrio had in its center a five-pointed star with the initials 'C.L.N.' inside the star. The PC said that he had given definite instructions that the CLN initials be obliterated from the stamp and repeated his order to the Capo di Gabinetto.

5. The Prefect seems to be a capable and efficient official, but seemed to lack interest in the matter of compiling election lists. This task had been delegated to the Vice Prefect as it has in other provinces. In the case of this province, however, the Prefect took part in our conference, but left soon after to attend another meeting and never returned. The Provincial Commissioner stressed the importance of the job of preparing the election registers as a No. 1 task. I suggested that he speak to the Prefect personally since the latter was not present when the PC made his remarks.

TO : The Minister of Interior

1. Dott. CAROTENUTO nominated as Vice Prefect Inspector for SONDRIO reported to this Hq. yesterday evening. He said he was ready to go but but wished the Allied Commission to arrange transport for his wife and child also. Owing to the difficult transport situation it is impossible to arrange this transport and Dott. CAROTENUTO was informed accordingly.
2. He has now definitely refused to move unless his wife and child go with him and in the circumstances has been instructed to report back to the Ministry.
3. It is again stressed that these personal problems of Italian Officials should be dealt with by the Personale Division of the Ministry of Interior and that when an official is sent to this Hq. for transportation to his new Province he should be prepared to go there without presenting personal problems and excuses with which the officers of this Hq. are not qualified to deal.
4. Owing to Dott. CAROTENUTO's action nineteen days have been wasted in supplying an urgent, needed official to Sondrio. In view of the urgency amongst other things of the preparation of the Electoral Lists, please furnish this Sub Commission with the name and biographical details of a well qualified official who is available in Rome and ready to move immediately.
5. This letter has been read to H.E. Belli Micali of the Personale Division of the Ministry over the telephone today in order to avoid any delay in transmission.

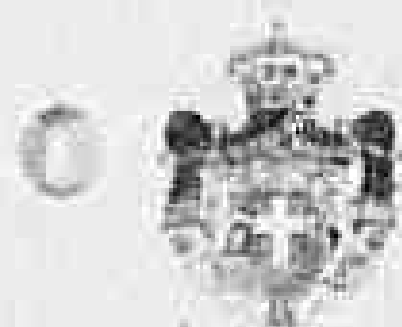
