- 6) - BRANCIA Dott. Gaetano - Vice Prefect Inspector - from Cosenza to Reggio Calabria with vicarious functions.
- 7) - VADALA' Dott. Riccardo - Vice Prefect Inspector - from disposition to Aquila with vicarious functions.

The latter is already known to the Sub Commission but he had not been used yet because he had been placed on expiation trial, the issue was favourable as the Commission decided that there was no sanction to be taken in his regards.

Considering the urgency of the matter we ask the Commission to kindly give us an answer on the subject as soon as possible.
