Referring to the above letter, we inform the Sub Commission that the Vice Secretary on approval dott. Giorgio Giovannozzi was appointed to Grosseto in 1940, but, following his call to arms, he was compelled to leave his office shortly after he had presented himself at that Prefecture to carry out his first service.

Through the Prefecture of Florence, the Official in question has pointed out that as he is now discharged from Military Service he is in a position to resume his civil service, and expressed his wish to be assigned to the above mentioned Prefecture.

The Ministry has therefore asked to know the opinion of the Commission in regard to the official's aspiration, and in the case of it not being possible to appoint the afore-mentioned official in the Prefecture that he wants, the Ministry has asked to use him in one of the Provinces which have returned under the Italian Administration.

We ask you to kindly give us an answer on the above.
