CONSIDERATION FOR THE LIRI VALLEY
Pontecorvo

Your Excellency,

Please forgive my liberty in addressing this letter to You, but various circumstances and the hope of finding justice, force me to do so.

About a year ago, when Pontecorvo, destroyed by the war was liberated I was appointed Mayor by the A.M.C. and precisely by Capt. Bertelli. In a short time I became very popular and well known by all the Allied officers, so much so that Group Cat. C. Benson of the Eighth Army proposed to appoint me Prefect of the Province of Frosinone.

Some time passed, and since I had not received the appointment to Prefect, Col. J. B. Thornhill made leave my charge as a Mayor and appointed me Commissar for the Liri Valley, the office being in Pontecorvo. Col. Thornhill Provincial Commissioner for Frosinone was very satisfied with me and my work.

Immediately after the Province of Frosinone was returned to the Italian Administration, the Italian Government abolished the Commissariats and consequently my work and employment came to an end.

Now I am earnestly praying Your Excellency to see that I shall be kept in due consideration by the Italian Government either to be appointed Prefect, possibly in Northern Italy, or for another suitable employment.

I was never a member of the "fascist party", on the contrary, on the 1st of April 1942, I was condemned by the Fascist Tribunale Speciale of Rome, to five years hard imprisonment for Resistance antifascism etc.

During the German occupation, I was the only one to do anything against the Germans killing two of them. For this act of mine the German Command condemned me to death.

I am very well known by Judge Tullio Mochisio and also by His Excellency Ambassador Bryan Taylor who has also kindly interested himself about me.

I now have but to beg Your Excellency to accept my apologies and my kindest regards.
