SUBJECT : Case of CARBONI Guido, Sindaco of Castiglione Fidenechi (Province of Arezzo).

TO : H.E., the Minister of Pardon and Justice.

1. Report has been received by RLO, Tuscany to the effect that the Sindaco of Castiglione Fidenechi on 22 Jan 1945 distributed to the residents of his comune 5 kilograms of olive oil instead of the monthly ration of 270 grams.
2. As the act complained of is a clear violation of Italian law, it is thought desirable that CARBONI should be tried by an Italian Court.
3. Would Your Excellency therefore be good enough to authorize proceedings to be started against the Sindaco of Castiglione for the alleged offence. It is understood that the Procuratore Generale, Florence will require your formal consent before instructing the Giudice Istruttore of Arezzo to commence investigations. It is further understood that on the report of the Giudice will depend whether CARBONI is brought to trial or not.
4. Should Your Excellency feel unable to grant the requested authorization, CARBONI will be tried by an Allied Court.
5. As this matter is considered urgent, could Your Excellency let this sub-commission have the required document for the Procuratore Generale at your earliest convenience.
