SUBJ/DT: Movement of Prefects.

24 February 1945

TO : His Excellency the Minister of the Interior.

Your Excellency:

1. I refer to your letter No. 6245 Cabinetto, dated 22 February 1945, and delivered to this office by Cav. CAMIR this afternoon.

2. Chieti: The Allied Commission approve of your proposal to remove the present reffect at Chieti, Avv. PIRELLA Gaetano, and approves also the proposal to appoint Dott. VILLARI, Goffredo, to be Prefect of that province in his place.

3. Foggia: The Allied Commission also agrees to the proposal to recall Gen. GÖTTSCHE OBERHOFER from Foggia and to appoint to be Prefect of that province Dott. PALUZZI Giovanni, at present reffect of Nuoro.

4. Rosarno: Your proposal to recall the present Prefetto Reggente of this province, the Vice Prefect Dott. PAOLI Cesare, and to employ him in the Ministry with inspective functions until the judgment of the Liberation Commission upon him is known, is likewise approved. The proposal to appoint in his place as Prefect of Rosarno Dott. RIESTA Giulio Cesare will require some inquiries on my part and I will write you again about this as soon as possible. In the meantime, I shall be glad to know the address of Dott. RIESTA. I understand from Cav. CAMIR that he may be living either in Rome or Rieti.

5. Nuoro: The proposal to appoint Avv. VILLARANTE Carlo to be Prefect of this province in place of Dott. PALUZZI is likewise agreed.

6. Naturno: I am not yet in a position to give you an answer as to the position of the present Prefetto Reggente, Dott. CARLUCCIO Guido
