SUBJECT: Survey of Cremona and Mantova Provinces.

22 August 1945

TO : RC Lombardia Region.

1. Herewith copies in duplicate of Major Williams' reports on his recent visit to the above 2 provinces: an extra copy is sent for you to pass on to the RC if you think fit.
2. CREMONA. The main point raised here was the shortage of Communal Secretaries: you will observe the comment on same at paras 5 and 6 of the report. The matter has been mentioned to the Ministry and, as anticipated, they are not in a position to supply the gaps: they can only suggest the appointment of temporary Secretaries with the requisite qualifications. They will, however, endeavor to find one ~~in~~ ^{at} Cremona City.
3. It is rather doubted whether the officials whom Major Williams interviewed are facing the question with the right sense of proportion: and it would be as well if the new Prefect's attention were directed to it.
4. Similarly, the ~~personal~~ questions raised in para 8 of the report are now primarily matters for the new Prefect. It is suggested that the observations in para 8 of the report be treated as for the information of the RC only and that the Prefect be allowed to form his own judgment and make recommendations to the RC on his own initiative.
5. MANOVA. This province calls for no special comment. The Sub Commission would be glad, however, to receive the biographical report forms in respect of the 2 career Vice Prefects LEO and RUSSINI.

2. Date: 4 August 1965.

3. The subject of all 70 questions were contained in copies by a special team of Provincial Government's (later in May, 1965) soon after the establishment of WFO. The usual procedure of course, is for the subject to be apprised of confidential by choice of the subject (according to the letter of WFO 4 April 1964 No. 111) which is "without" by the 10. The procedure adopted in this province is fully as valid and it has the great advantage that the position of the subject has been regularized from the beginning so that there can be no doubt of the validity of their subsequent acts. Consequently I had no occasion to recommend any "black" examination or shielded, as I have had to do in every other province I have visited. The usual procedure was adopted for the other officials.

4. The position as to Security remains proceeds the usual features. 45 cases (agreed) are in action. Another 10 have been supplied pending questions. There are 2 Vice-regents (active) acting in place of their former chiefs and there remain 14 non-crown regents. This gives a total of 64 as against 70 originally. The difference of 6 is accounted for by the 9 cases where the regents of a neighboring country is acting. The position in the future remains of the same; but as the subject expects and 20 more cases agreed to be suspended, it is likely to become serious.

5. The Administrative Regiments was suspended in this and the 4 election matters of the 1961 a few days later.

6. The WFO gave no focus "no" and "no". From these the prefecture soon in good shape. There is the unusual feature of 2 political Vice-regents - a Liberal (V.V. Caragard) and a Communist (V.V. Redman) the prefect being a Socialist. There are also 2 crown V.V. of these, but central is under investigation by the Education Commission while V.V. Leo has just been cleared. This is good as Mr. Leo is head of the Education Office and does the inspections for this purpose. The VLO tells me the provincial CEF gives little or no trouble but one on business of the prefecture to be met with out of the provincial capital, the president of the local CEF of Yunnan is in jail and will be total next week by the special Court of Appeals - for collaboration with the Guevarra and turning over 14 prisoners to them.

5. The first batch of electoral forms arrived about 7 July and were distributed within a few days, without the prefecture having to turn to GAO for any transport. The VLO Lao held a meeting of Democratic Council just before 15 April which was addressed by the VLO.

6. The prefect had divided the prefecture into 4 zones, each with one of the largest towns of the province at its centre and had changed the Democratic Council of this central town with the duty of inspecting and reporting on the preparation of the lists in the rest of the zone. Major trouble met this useful device in Yunnan also.

7. The prefect reports weekly to the VLO on the preparation of the lists and these are being sent to GAO. I saw the report for 3 August which seemed quite satisfactory. The prefect is satisfied as to progress made everywhere, except in Democratic Council. There the Democratic Council and had to be suspended after a

SUBJECT: Prefectural appointments in northern provinces.

15 May 1945

TO: Vice President Civil Affairs Section.

1. To date we have received scanty information as to the actual appointments of Prefects in the northern provinces. We have been officially informed that only one Prefect has been formally installed, to wit Dott. Gauguido BORGHI--Socialist--Province of Bologna-- CLN nominee. We have also been informed that in the province of Ferrara the head of the Provincial CLN, who himself is non-political and named HIEBON Renato has been appointed Acting Prefect temporarily pending the selection of a permanent Prefect.
2. In two cases, the CLN nominee is also the Government's candidate and, therefore, the possibility of them being appointed is very good. These are Sig. AVANZINI Ennio--Christian-Democrat--Province of Mantova, and Sig. DEL GIUDICE Pietro--Socialist--Province of Apulia.
3. We have received a signal from Brigadier Dunlop that he expects to appoint the following persons, all of whom are CLN nominees: ita can be taken, therefore, that they have been appointed by now, since we have replies to the signal that the AG has full authority to make appointments after consideration of the Government's candidates. These persons are:

We have received information as to the names of CLN nominees for other provinces and have given this data to the Ministry of the Interior for any observations they might have concerning the persons. Of the 19 names of CLN nominees, only one was known to H.E. BENUTI, who characterized him as a good man. This person was Avv. GIACCHERO--Christian-Democrat--Province of Asti. As stated before, the candidates for the provinces of Mantova and Apulia were also the Government's choice.

1. I gave Dott. BERRUTI a copy of a list of names of CLN nominees for Prefects in various provinces in the North, this information having been taken from telegrams we received from our officers in the field. I said the Allied Commission was interested in learning whether the Ministry has any knowledge of these people.

2. He looked over the list and said that he knew only one -- the CLN nominee for Prefect of Mantova, namely AVANZINI. AVANZINI, he pointed out, has already been suggested by BONOMI as the Government's candidate for that post and that he was a good choice.
