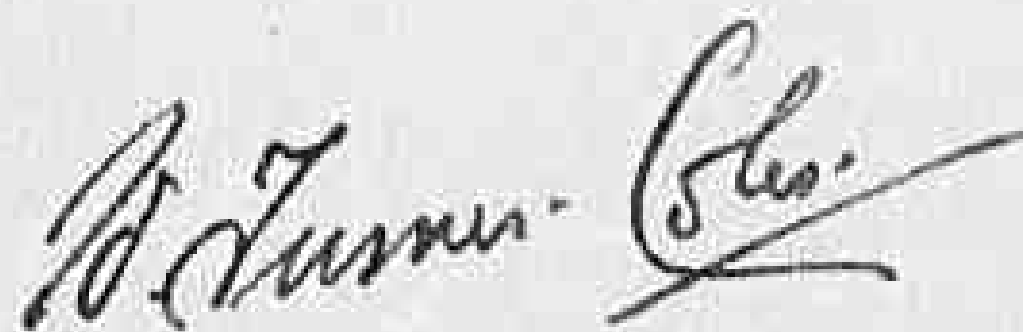

1. I was not able to see the Prefect who had gone to a Regional Conference but I had a long and interesting discussion with the various officers and officials set out above. Avv. CORTONA has been assisting Major Dertam and keeping a special eye on election lists. Major Dertam is Legal Officer for Alessandria also and CORTONA takes care of the Asti office in his absence. The PC has a high opinion of CORTONA who has been a good legal adviser and recommends him highly as assistant and interpreter to any officer who may be left in the North to supervise the preparation of the lists. (See recommendation by PC on Asti file, page 82). CORTONA speaks English well and acted as interpreter during my interview. He also appears to have the details of the electoral procedure at his finger tips.

2. The PC has a high opinion of the Prefect, Ing. ENZO CLAUHERO, who is one of the finest men in Italy. He is a good administrator and gets things done. He was a Partisan leader and organizer and is the choice of the Provincial CLM for Prefect. He is only 35 years old but the PC says he is definitely the proper man for Asti and should be kept on by the Italian Government when AMG goes. The Prefect speaks and writes English well. He is a member of the Demo-Christian Party (which is the strongest party in Asti) with decidedly liberal views.

3. VIV. Avv. Stefano LORENZI is a career official. The PC says he is a good administrator and one of the few strong career officials. He has been very useful in establishing the administration.

4. VPI. Dott. Saverio DE LUCA is also a career official. He is a good official and knows his job but has no push or initiative and just does what he is told to do. I saw the VPI and think he is above the average for Italian officials. He appears to have the production of the electoral lists well in hand.

5. Other officials. There is only one career Consigliere. The Prefect had written to Rome about two months ago for another but had not got any reply. Another Consigliere is essential and if possible one who has had experience as a

3. VIV. avv. Stefano LORENZI is a career official. The PC says he is a good administrator and one of the few strong career officials. He has been very useful in establishing the administration.

4. VPI. Dott. Saverio DE LUCA is also a career official. He is a good official and knows his job but has no push or initiative and just does what he is told to do. I saw the VPI and think he is above the average for Italian officials. He appears to have the production of the electoral lista well in hand.

5. Other officials. There is only one career Consigliere. The Prefect had written to Rome about two months ago for another but had not got any reply. Another Consigliere is essential and if possible one who has had experience as a Capo Gabinetto would be preferred. I promised to pass this on to the Ministry of Interior and try to get some action.

6. Deputazione Provinciale was established on 5th June and was meeting regularly. There are 6 members and 2 supplenti.

7. GPA. The four citizen members of the GPA were appointed on 8th June, and it was meeting as and when required.

8. There is a Giunte Comunale and a Sindaco in each of the 105 Communes in the Province. They appear to be functioning well.

9. Segretari Comunali. There are 62 career segretari and 23 non-career, segretari and all Communes are looked after properly. Some are too small for warrant a full-time Segretario and are being taken care of by Segretari from neighboring Communes.

10. CIM. There has been no trouble from the Provincial CIM. Their advice had been sought and acted upon and they had representation on the Deputazione. They were cooperative and the President had himself gone out to a few Communes where the local CIM was causing trouble and brought them into line.

11. Preparation of the electoral lists. The first lot of forms had all been received and distributed to the Communes in good time and the work had started on the appointed day. The second lot of forms had not been received and would be divided up and distributed as soon as the decisions have been taken as to the number of "sezioni elettorali" in each Comune. The IC will assist with transport if necessary.
12. Many of the Communes had completed the "Elenco" and forwarded the extracts to the various Casellari Giudiziali. They anticipated some delay in getting replies from the Casellari in other provinces. There is only one Casellario in Asti Province and it is in perfect order.
13. Extensions of time. Only 4 Communes have asked for an extension of time. In each case the Communal records have been destroyed and an extension of 30 days has been granted. The Electoral officers are satisfied that the work is going on well and that there will be no delays. The VPI was having some difficulty about finding transportation to get round the Communes largely because he was content to wait until a car was put at his disposal. The VPI should have a car always at his disposal, especially at present. The IC said he would get the Prefect to take the necessary action.
14. Electoral Commissions. Nominations had been received in most cases and all the names would be in in about a week's time. The matter is well in hand and the Commission would be set up well before 20th August.
15. Aburration. The Provincial Commission was established and functioning.
16. From the point of view of local government and the preparation of electoral lists, the situation in Asti Province seems to be very good. SUBJECT: Note of conference with Regional Commissioner and Deputy Regional Commissioner, Piemonte Region - 22 June.

TO : Director, Local Government Sub Commission

FROM : Major Ralph A. Temple, Deputy Director, Local Government Sub Commission

1. I discussed with Mr. and his Deputy the various problems arising out of distribution of electoral material and compilation of electoral lists. Mr. said there might be some difficulty in starting on time in Cuneo and Aosta, where the French still are. It was suggested that the material for the communes in this province still under French control be stockpiled in the nearest points for distribution when the French are relieved. Mr. was of the opinion that it might be three or four weeks after the material reached Regional HQ before they would be in a position to begin the compilation of the lists. The presence of IV Corps and the French situation have prevented direct contact with the communes.

SUBJECT : Prefectural appointments in northern provinces. 15 May 1945

TO : Vice President Civil Affairs Section.

1. To date we have received scanty information as to the actual appointments of Prefects in the northern provinces. We have been officially informed that only one Prefect has been formally installed, to wit Dott. Gianguido BONGHESI-Socialist-Province of Bologna-- CLN nominee. We have also been informed that in the province of Ferrara the head of the Provincial CLN, who himself is non-political and named HIRSCH Renato has been appointed Acting Prefect temporarily pending the selection of a permanent Prefect.

2. In two cases, the CLN nominee is also the Government's candidate and, therefore, the possibility of them being appointed is very good. These are Sig. AVANZINI Emilio-Christian-Democrat-Province of Mantova, and Sig. DEL GIUDICE Pietro - Socialist - Province of Apuania.

3. We have received a signal from Brigadier Dunlop that he expects to appoint the following persons, all of whom are CLN Nominees: it can be taken, therefore, that they have been appointed by now, since we have replied to the signal that the RC has full authority to make appointments after consideration of the Government's candidates. These persons are:
