RE Bolzano)

1. Reference is made to RE Bolzano's letter RM/31/139 of 19 November. A copy of this and the enclosure are sent herewith for information of RE, as the letter does not appear on the face of it to have passed through his RE.

2. The enforcement of obedience to the orders for transfer from Trento to Bolzano is a matter entirely within the competence of RE. The Ministry of the Interior's letter 5173 /L.3 of 13 October (copy enclosed with this office letter AC/4/1/161/10 of 22 October) is a recommendation. The order to the officials named therein to transfer is an order of AMG and not of the Italian Government.

3. Assuming the RE is satisfied that the excuses offered by these officials are insufficiently founded, this Sub Commission advises that peremptory orders be given them through the Prefect to comply with the previous orders given them and report themselves to Bolzano within a reasonably short space of time--say 3 days--failing which they will be (a) suspended from employment and (b) have payment of all salary and emoluments stopped.

4. The attitude of these officials is a familiar story to this Sub Commission and the advice given above is tendered on experience in the last 15 months with many similar cases. Particular value is attached to the financial sanction at para 3(b) above. In my experience, mere suspension without stoppage of pay plays into the officials' hands.

5. Please inform this office of the action you take.

- 2.) I have to report that this order has not been complied with and that the personnel detailed to be transferred from the Prefettura of Trento to Bolzano have not arrived nor in the present circumstances are they likely to arrive.
- 3.) You will see from the attached copy of a letter received from the Provincial Commissioner Trento Province that the employees concerned are naturally putting every obstacle in the way of this transfer which, I understand unofficially, is not being too strongly enforced by the Prefect of Trento.
- 4.) In view of the unsatisfactory financial conditions existing in the Prefettura of Bolzano I urgently request that the orders issued by the Ministry for the transfer of the seven persons concerned should be put into effect without delay.

1. The Ministry of the Interior have drawn the attention of this Sub Commission to the under-staffing of the Accountancy Office ("Ragioneria") of the Prefecture of Bolzano, where they state there are only 5 Accountants and 2 clerks. On the other hand, they say that the corresponding office in the Prefecture of Trento is staffed by 10 Accountants and 10 clerks. They suggest this is more than Trento needs and that the position should be evened up by the transfer of some of the surplus to Bolzano.
2. The proposal appears to be eminently reasonable and desirable especially as, from reports submitted by officers of this Sub Commission who have visited the provinces, the organization of Bolzano Prefecture gives cause for some concern.
3. Herewith are sent accordingly copies in English and Italian of the Ministry's further letter to this Sub Commission, No. 5173/1.3 (Personale), dated 15 October 1945, in which the Ministry specify the individual officials whom they recommend for transfer from Trento to Bolzano. May the Italian copy please be handed to the Prefects and instructions given to them to carry out the transfer.
4. If any further question arises which might require reference to the Ministry of the Interior, it could best be dealt with by direct correspondence between the Prefects and the Ministry, the papers being, of course, passed through AC/EC channels: and the Ministry of the Interior have been so informed.

1. On 19 September, the Chief of Cabinet spoke to this office to inquire if anything was known as to a reported intention to change the present Prefect of Trento.

2. Inquiries have been made and the Regional Commissioner states definitely that he has no intention to change the present Prefect, Dott. OTTOLINI Giuseppe. He has a good opinion of Dott. OTTOLINI and states that the Prefect has considerable support and respect from all parties. The report that he was to be changed came as a complete surprise to the Regional Commissioner.

3. The possibility cannot be excluded that rumors of this nature are started of deliberate purpose for ulterior motives and it is hoped that the Ministry are taking steps to check the reliability of the sources of such reports before taking them up officially with this HQ.

2. The suggestion contained in your letter came as a complete surprise to me. I had always regarded Dott. Ottolini Giuseppe as efficient, honest and devoted to his work.

3. I have consulted Major Mavis, Provincial Commissioner, Trento, who replies in full agreement with his P.P.S.O.:

"We are both in agreement that the allegations are completely unfounded. In fact the Prefect continues to have considerable support and respect from all parties and his reputation is one of honesty, intelligence and energy in behalf of the welfare of his Province, with party matters coming second."

4. It would be most interesting to know whence the reports originated. You will know that Dott. Ottolini is a Communist. In fact he is the only Communist Prefect in the Region. That may have something to do with the case.

SUBJECT: Survey of Bolzano, Trento and Verona
Provinces.

22 August 1945

TO : RC Venetia Region.

1. Herewith copies in duplicate of Major Williams' reports of his recent visit to these provinces; the additional copy is for forwarding to the RC if you think fit.
2. BOLZANO. The major point in this province seems to be the organization of the Prefecture. The provincial report form which has now been received indicates the Prefecture is adequately staffed. I have written you separately about the Deputazione Provinciale.
3. Paras 18 to 21 of this report are Major Williams' personal observations as to the reaction of the minority problem on the preparation of the electoral lists which I think you should see, although discussions on the point are still going on between this RC and the Italian Government, and the ultimate decision may differ from the views indicated in these paragraphs. They are not, therefore, to be taken as an indication of AC policy.
4. TRENTO. The province appears to be in good shape.
5. VERONA. No particular point arises in this province either to which attention should be called. The line taken by the RC with respect to his 2 political Vice Prefects has been noted with interest. The treatment of this GLN device is one on which no general rule is laid down, as local circumstances must govern the decision whether it is best to retain it or not.

Doctor Ottolini had been placed in office as Acting Prefect by the C.L.N. on the cessation of hostilities and was performing the duties of this office when I entered the Province on 7th May 45. His appointment was confirmed by Brig. Gen. HUME G-5 Sect., 5 Army, retroactive as of 2nd May 45. Politics communist.

This is his first experience in Public Office but he has demonstrated a keen understanding of Governmental Organization and procedure as well as being well versed in the economic problems of the Province. He is an intelligent, hard-working and conscious individual who in my opinion has attempted to perform the duties of the Office without playing politics. He has at all times given equal recognition and consideration to all parties.
