Consigliere in charge of preparation of the electoral lists.
25 July 1945.

TO : Director, Local Government Sub Commission

FROM : Captain W. I. Cunningham

1. I was unable to see the Prefect as he had gone to Turin to attend the funeral of SOLMI. However, I had an interesting interview with the VIV and officials responsible for the preparation of the electoral lists. This interview took place in the presence of the IC.
2. The forms had all been received and distributed and the preparation had commenced on the 15th according to law. Prior to this, however, all Segretari Comunal had been told to bring their population registers up to date in order that there might be no delay.
3. No extensions of time would be necessary. Only one Comune had lost its records through destruction and these could be replaced in time as it was not a large Comune.
4. The Casellario Giudiziale was intact and the records in order.
5. The Electoral Commissions had already been formed and were ready to hold sittings when required.
6. The only difficulty was in getting an official round all the Communes to supervise the work. They had a car at their disposal but not sufficient petrol. IC suggested that a larger allowance should be made from Rome for the purpose.

SUBJECT: Interview with Lt. Col. Carter, FO Vercelli - 25 July 1945

TO : Director, Local Government Sub Commission

FROM : Captain W. I. Cunningham

1. The Prefetto Regente Dott. Giovanni CANTONA GWA was a local manufacturer. He was a good type of man and completely honest, but unfortunately he was weak and dominated by the CLN. He was a member of the Liberal Party.
2. VV Dott. Carlo CHERUTI, a political appointment--non-career--appeared to be a good worker.
3. VPI Dott. Renato BARTONE was also a non-career official.
4. The Deputazione Provinciale and the GIA were both functioning.
5. Giunta Comunale were in all 163 Communes.
6. Sindaci had been regularly appointed for all Communes. About 75% of them were good men. The others were not so good and were being watched.
7. Segretari Comunali were looking after all Communes. Mostly career officials. There were 10 non-career Segretari.

8. CLN. The CLN were a problem in this Province and they refused to be curbed. AMG had merely driven them underground and they were working steadily to undermine authority. PC did not consult them any more on account of their attitude. PC thought that the letter (AS/1/27/16) of 21 July re the Consulta was wrong as it would re-establish an official position for the CLN if they had to be consulted regarding the members of the Consulta. I pointed out that this was the Italian Government law for constituting the Consulta and it was being carried out all over Italy in order that the Consulta could be set up. PC thought it a pity that it had to be done while AMG was still in operation in a Province.

9. The preparation of the electoral lists was getting on well. PC produced a report from the Prefect to the Ministry of Interior (copy to AMG for information) setting out the position on 16 July. He gave me a copy of the report. Copies are attached hereto.

10. The Provincial Deputation Commission was established and was working well. They had a good President and refused to be intimidated by anyone.

- 5. *Giunte Commales* were in all 169 Communes.
- 6. Sindaco had been regularly appointed for all Communes. About 75 of them were good men. The others were not so good and were being watched.
- 7. Segretari Commales were looking after all Communes. Mostly career officials. There were 10 non-career Segretari.
- 8. CIN. The CIN were a problem in this province and they refused to be curbed. AMG had merely driven them underground and they were working steadily to undermine authority. IC did not consult them any more on account of their attitude. IC thought that the letter (AG/1/27/IC) of 21 July re the Consulta was wrong as it would re-establish an official position for the CIN if they had to be consulted regarding the members of the Consulta. I pointed out that this was the Italian Government law for constituting the Consulta and it was being carried out all over Italy in order that the Consulta could be set up. IC thought it a pity that it had to be done while AMG was still in operation in a Province.
- 9. The preparation of the electoral lists was getting on well. IC produced a report from the Prefect to the Ministry of Interior (copy to AMG for information) setting out the position on 16 July. He gave me a copy of the report. Copies are attached hereto.
- 10. The Provincial Repuration Commission was established and was working well. They had a good President and refused to be intimidated by anyone.

SUBJECT: Fortnightly report on the election operations.

To the Ministry of Interior
and a copy to the A.M.G. Vercelli.

This is a statement of what we did in the first fortnight of July concerning the election operations.

- a) When this office was established we divided according to instructions the election material among the different Communes of the Province and we forwarded it by any possible means. The Communes acknowledged receipt of it.
 - b) We sent in due time all the communications issued by the Ministry, to the Communes with the necessary warnings for the enforcement thereof.
 - c) We came to agreements with the Attorney's Offices of Biella and Vercelli about the assignment of voluntary staff of local Associations or public Offices to Police Records Offices for extra work (telegraph circular 29/3/1945;
 - d) Since we did not yet know when election operations would begin we thought it advisable to ask communal Secretaries to get everything ready for elections (filling of lists etc.) after having carefully chosen the staff for electoral service. Such instructions were confirmed by the Prefect telegram dated 9 July N° 13284.
 - e) According to the dispositions contained in circular N° 5327 GR dated July 9 1945, taking into consideration the number of people of each district out office on the 7th inst. Fixed the number of Electoral Commissions and Sub-commissions of the Province: one Commission; and one Sub-Commission for Vercelli - one Commission and three Sub-Commissions for Biella- one Commission for Santhià Trino and Vercelli. At the same time we asked the local Provincial Deputation for a list of the members and we asked the Communes of Vercelli and Biella for the names of the communal employees who can act as secretaries to the Commission We have received all these communications and therefore on July 18th all Commissions and Sub-commissions will be formally constituted with a decree of the Prefect.
- We sent some of the Ministry instructions on election operations to the Presidents of Vercelli and Biella Law-Courts so that they

May send them to the Presidents of Commissions and Sub-commissions as soon as possible.

- f) When we received the Regional Order N° 5 which made us acquainted that electoral operations were going to begin on the 15th inst. We sent a telegram dated 9th inst. On above subject to all the Communes. For the Communes where there was neither telephone nor telegraph we sent the order by special courier. We have been receiving since yesterday telegrams acknowledging receipt of same.
- g) We called the attention of public Administrations for Assistance and Beneficence to their duties (art. 5 of Ministerial Decree dated Oct. 24 1944 and art? 3 of L.L.D. 1/2/1945 N° 123)
- h) The Communes (that had already revised their population-registers) will check them again within this month according to the form sent by the Statistical Institute and which was sent by our office to each Administration, after having had many copies printed. The Commune of Andorno Micca whose population register was burnt some time ago is trying to do it over again. We have authorized with a telegram the engagement of extra-staff and have called the attention of the Commune to the dispositions of Min. circular N° 5132 dated May 22nd 1945 so that they may be carefully complied with.
- i) We will soon visit all Communes and Andorno Micca will be the first.
