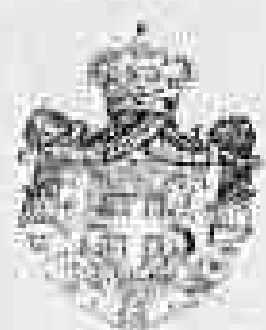

1. With reference to our previous correspondence on this subject, I have now to inform you that the Provincial Commissioner, Belluno, informs me that he has in turn heard from Dott. Dazzi that the Ministry of the Interior has objected to Dazzi's proposed relinquishment of the post of Prefect of Belluno in order to rejoin the diplomatic service.

2. It appears, therefore, that the matter must be allowed to remain in obedience until the Italian Ministry of Foreign Affairs and the Ministry of Interior settle their rival claims as to Dazzi's services.

1. Reference AC/4/1/168/LG of 16th August, I entirely appreciate the arguments which you have put forward in your letter and I have had the opportunity of a further discussion yesterday with the Provincial Commissioner of Belluno.

2. In the light of your letter and the local situation the Provincial Commissioner is going to see the local C.L.N. and inform them that he proposes to recommend the appointment of a career Prefect unless a local man can be found who would be assured of the unanimous support of the C.L.N. and would be approved by the Provincial Commissioner as technically competent to undertake the work. I do not think that in fact the local C.L.N. can put forward any such nominee but I consider it most desirable that they should be given the opportunity.

3. We shall rely on you to impress upon the Italian Government the absolute necessity of finding a really first class career Prefect of Northern extraction to take on this admittedly difficult Province.

1. Reference your RXII/025.111 of 10 August 1945, you will recollect the subject was discussed with the writer and his Deputy when you were in this HQ on Tuesday last, 14 August.
2. I gathered from that conversation what you had in mind was that the Italian Government should put forward one or possibly more names of career Prefects to be considered in competition with such local candidates as there might be. As mentioned during our conversation, to proceed in this way does not accord with the policy of this HQ at the present stage.
3. The policy always has been that it rests with the RC to determine whether he wants a new Prefect and whether or not he will appoint a local man. It is true that upon the sudden liberation of the whole of the North, there were special variations introduced into this policy and that RCs were authorized to decide between the Italian Government's nominee for each Province and the local candidate: but this was a measure to meet the special circumstances of the moment and was not intended to alter the general policy.
4. At the present stage of affairs, the Allied Commission must not act so as to weaken the authority of the Italian Government, especially so as it now contains representatives of the North. Accordingly, if the Government is requested to nominate a Prefect, this HQ would normally then accept the nomination, unless there should be some really grave charge of incompetence or Fascism against them. It is accordingly felt that where a Prefect is recommended to the RC by this HQ, as well as the Italian Government, he should normally be accepted.
5. Since dictating the above, a letter dated 11 August 1945, from the Ministry of Foreign Affairs, has been received (of which I enclose a copy) making formal request for Dott. DAZZI's release. Please be good enough to signal this S/C if you wish to proceed with the nomination of a new career Prefect for Belluno on the lines as described above.

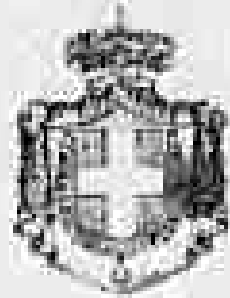

Subject: Dr. Antonio DAZZI: release from his post as Prefect of Belluno.

1. Dr. Antonio DAZZI, an official of this Ministry, who is serving at the present time as Prefect of the Province of Belluno under appointment by the proper Allied Authorities, would be urgently needed to serve at the Ministry of Foreign Affairs.

2. It would appear that the local situation would consent the substitution of said official, whose wish would possibly be to resume his normal function with this Administration.

3. TO : RE Venetia Region.

1. Reference your RXII/025.111 of 10 August 1945, you will recollect the subject was discussed with the writer and his Deputy when you were in this HQ on Tuesday last, 14 August.

2. I gathered from that conversation what you had in mind was that the Italian Government should put forward one or possibly more names of career Prefects to be considered in competition with such local candidates as there might be. As mentioned during our conversation, to proceed in this way does not accord with the policy of this HQ at the present stage.

3. The policy always has been that it rests with the RC to determine whether he wants a new Prefect and whether or not he will appoint a local man. It is true that upon the sudden liberation of the whole of the North, there were special variations introduced into this policy and that RCs were authorized to decide between the Italian Government's nominee for each Province and the local candidate: but this was a measure to meet the special circumstances of the moment and was not intended to alter the general policy.

4. At the present stage of affairs, the Allied Commission must not act so as to weaken the authority of the Italian Government, especially so as it now contains representatives of the North. Accordingly, if the Government is requested to nominate a Prefect, this HQ would normally then accept the nomination, unless there should be some really grave charge of incompetence or Fascism against them. It is accordingly felt that where a Prefect is recommended to the RC by this HQ, as well as the Italian Government, he should normally be accepted.

5. Since dictating the above, a letter dated 11 August 1945, from the Ministry of Foreign Affairs, has been received (of which I enclose a copy) making formal request for Dott. DAZZI's release. Please be good enough to signal this S/C if you wish to proceed with the nomination of a new career Prefect for Belluno on the lines as described above.

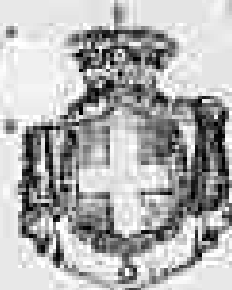

1. Provincial Commissioner, Belluno, informs me that Dott. DAZZI Antonio, Prefetto Regente of Belluno, has been called to Rome to discuss his probable return to work under the Ministry of Foreign Affairs.
2. It is very likely that Dazzi will leave Belluno at an early date.
3. As you know Dazzi was the suggestion of the local C.L.N. appointed by us. He is a career diplomat, a Christian Democrat and has done his job well.
4. I feel however that the time has now come when we should give the Italian Government the chance of sending up a career prefect. It is, or will shortly be, their problem and, as I have already pointed out, the whole relative position of prefects and Cs.L.N. is one which they have got to tackle.
5. Will you please, therefore, enter into discussion with the Ministry of the Interior with a view to securing their suggestions?

3. A number of the Simchi (and Chinto Council) appointed by the U.S.M. have been turned out by violent partisan action; others have resigned because of difficulties from the same quarter. Another reason for the resignation of Simchi is that Simchi received a salary under the same regime whereas the present Simchi do not. However, there is someone discharging the office of Simchi in the 69 Council. They have not been confirmed; but the prefect has the means and will issue a "blanket" decree for confirmation by the U.S.

4. The position as to Simchi Council is as usual. There is a more or less competent person discharging the office in every commune though many are not under him. A number have lost the confidence of the population who have interpreted the prefect's warning at his post as collaboration; the prefect is dealing with this by the usual method of exchange. In the meantime, councils have been confirmed so as to share the prefect's.

5. No Municipio has been changed and the assignments are all in order.

6. The material for the preparation of the Simchi lists reached Bolivia on 25 or 26 June. Circulars and instructions had already been distributed to the Councils, but the actual forms not, due to a question on the part of the prefect and his staff that he must first get exact population figures from the Simchi. I discussed strongly and from this and various immediate distributions on the basis of an estimate of population, the prefect is keeping back a small reserve in case Simchi should find they wanted a few more forms; if this reserve should prove insufficient, let a 10 signal this subordination and we would fly down an additional quantity. 14. The Prefect said he didn't think either the Vice Prefect Vicario or the Cayo Gabiretto were sufficiently capable; in actual fact all the real work is done by the former Vice Prefect Inspector Zampaglione and the Vice Prefect Vicario merely signs. Zampaglione was deprived by his title on liberation but the Prefect thinks he ought to reassume it, as he is in fact secretary of the office; he has been placed in charge of the electoral office. I agreed to the re-assumption of the title.

15. As to the Vice Prefect Vicario and the Cayo Gabiretto is it better to go slowly and wait a while. Their removal or otherwise is essentially a matter of local division. If the removal of either is decided it would seem preferable to replace by a career man.

16. Apart from Zampaglione, there are only 2 career officials in the Prefecture. One of these, a segretario called CHINIA is unpopular in the province though not openable; the Prefect wants him transferred and replaced. The Prefecture seems sufficiently staffed with temporary employees and the only requirement is a Consigliere. The Prefect will write to the Ministry about this and about the transfer of the segretario. I understood to mention the need for a Consigliere on my return.
