1. Reference is made to your letter R 2571 dated 9 Nov. 1945 concerning the above official. *(copy to this S/C)*

2. This sub Commission is fully in agreement with the observation of the PC and PC Sondrio.

3. However, our records indicate that Varese already has a Prefect, Vice Prefect Inspector and 4 Councillors; the transfer would appear, therefore, to be unnecessary, unless there are special circumstances of which this sub Commission is unaware.

4. Accordingly this transfer is entirely a matter for the R.C., and should only be considered after epuration proceedings, if sufficient reason is shown.

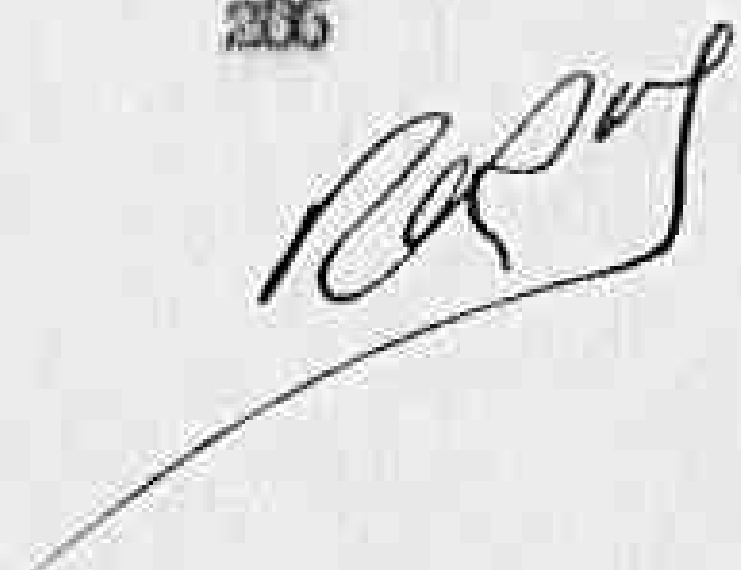

Career : Began his career in 1920 - Has served in the Office of Catanzaro, L'Aquila, Alessandria, Modena, Bologna, and with the Ministry of the Interior. "He has not carried any fascist honours and never actively participated in the fascist party. He is therefore acceptable from a security standpoint" from Security Division -

Comments : Classified always as "excellent"
 He is an intelligent and cultivated person of good character. He claims to have been in contact with the Committee of National Liberation during the German occupation in Rome (Security Branch)
 "48 years of age -- good type -- active -- plenty of drive -- most cooperative" (Appraisal by Lt Col Price PC on 13 Oct. 44)
 "Anxious to get back to mainland be posted north if a vacancy occurs" (Appraisal by Col. R.G.B. Spicer)
 "I hold this Prefect in exceptionally high regard and fit for considerably higher office possibly than that of Prefect" To be noted for an important vacancy in the north. (RC Sardinia, Col. Pennyquick)

SUBJECT: Prefect for Varese.

27 September 1945

TO : RE Lombardy Region.

1. Reference your signal No. 1940 of 21 September and previous correspondence, this Sub-Commission has contacted the Italian Government duly since receiving it, and on 25 September, Major Williams saw the Chief of Cabinet of the Ministry to represent to him that it was over a month since this nomination had been requested and that the failure of the Ministry to provide a name was a source of great embarrassment to this HQ.
2. The Chief of Cabinet explained that the Minister of the Interior (who, as you know of course, is also the Prime Minister) and also the present Prefect's Party, the Demo-Christians, were very anxious that Avv. TOSI should not resign. Both Professor PARRI and the Under-Secretary of State for the Ministry of the Interior--SPAFARO--had recently repeated to Avv. TOSI strong representations that he should remain in office.
3. It was pointed out to the Chief of Cabinet that this was no reason why a name of a possible successor should not be supplied--that if Avv. TOSI should change his mind, there is no objection so far as we know from AMG to his remaining in office--but that if he persisted in his intention to resign that it was essential to have a substitute ready. The Chief of Cabinet promised to speak to Professor PARRI again on the matter and let us know the outcome.
4. We have been endeavoring to get in touch with Captain Heufeld by telephone to keep him abreast of events: and the substance of the above was left in the form of a telephone message at his office today, he being, it is understood, absent from Milan.
5. At the moment of writing, nothing further has been heard from the Ministry: we propose to have the matter taken up at a higher level.
6. We regret very much the delay in meeting your request for the nomination of a career Prefect, but we are doing everything we possibly can to get the Italian Government to move in the matter.

1. The PC characterized the Prefetto Reggente, Avv. TOSI, as an excellent man who is cooperative, loyal and energetic. He is a prominent lawyer who had been nominated by the CLN as Prefect. He is independently wealthy; in fact, he turns over his salary as Prefect to charity. The PC said that TOSI does not care to remain as Prefect and wants to return to his law practice. He still stay in the position, however, as long as AMG is there, but wants to give up the job as soon as AMG can release him. Major Warren said that he should like to have TOSI replaced by a career Prefect about two weeks before the territory is turned over, in order that TOSI be relieved of his job before AMG actually pulls out.
2. The relationship between AMG and the CLN is very good. All the Communes have received the electoral material that had been sent out to the provinces. The Casellari Giudiziali in the province are intact.
3. No Deputazione Provinciale has been established as yet, although there is a President of the Provincial Administration who is entitled "Commissario Straordinario". The latter appointed the 4 citizen members of the GEA. I informed the Prefect and PC that it was imperative that the Deputazione Provinciale be established immediately and that it nominate the 4 citizen members of the GEA. The Prefect said that he has asked for names from the CLN; none have been forthcoming. However, he assured me that the Deputazione Provinciale would be established this week. Thereafter, the 4 citizen members of the GEA would be confirmed by the Deputazione.
4. There are 4 "mandamenti" in the province. The Prefect expects to establish 6 Electoral Commissions and 4 Sub-Commissions.
5. An Electoral Office has been set up in active charge of Consigliere CARLINI, supervised by Vice Prefect Vicario JODICE. The population registers are being checked and in fact no extensions of the time-limits are expected to

as soon as AMG can release him. Major Warren said that he should like to have TOSI replaced by a career Prefect about two weeks before the territory is turned over, in order that TOSI be relieved of his job before AMG actually pulls out.

2. The relationship between AMG and the CLN is very good. All the Communes have received the electoral material that had been sent out to the provinces. The Casellari Giudiziali in the province are intact.

3. No Deputazione Provinciale has been established as yet, although there is a President of the Provincial Administration who is entitled "Commissario Straordinario". The latter appointed the 4 citizen members of the GPR. I informed the Prefect and PC that it was imperative that the Deputazione Provinciale be established immediately and that it nominate the 4 citizen members of the GPR. The Prefect said that he has asked for names from the CLN; none have been forthcoming. However, he assured me that the Deputazione Provinciale would be established this week. Thereafter, the 4 citizen members of the GPR would be confirmed by the Deputazione.

4. There are 4 "mandamenti" in the province. The Prefect expects to establish 6 Electoral Commissions and 4 Sub-Commissions.

5. An Electoral Office has been set up in active charge of Consigliere GERLINI, supervised by Vice Prefect Vicario JODICE. The population registers are in good shape, and in fact no extensions of the time-limits are expected to be filed.

6. All of the 116 Communes in the Province are covered by Segretario Comunale. The Vice Prefect JODICE has sent out a questionnaire to them dealing with the position as to the compilation of election registers.

7. The first report on the status of the election registers has been prepared by the Prefect and will be forwarded through channels to this office and thence to the Ministry of the Interior.

8. 85 Sindaci have been formally appointed. The remaining 31 have not as yet been formally installed. I urged that this be done immediately, perhaps by an order appointing them "en bloc". Substitutions might be made thereafter. I impressed upon the Prefect the desirability of having all persons who participated in the compilation of the lists legally installed in order to obviate the possibility of any technical objections to the validity of the lists being raised. The situation with regard to the appointment of Giunta Comunale is the same as that with regard to the Sindaci, namely 85 have been formally appointed--31 remain to be confirmed in office.

9. Besides JODICE, who holds the rank of Vice Prefect Inspector with functions of Vice Prefect Vicario, there are 2 non-career political Vice Prefects, namely Dott. GALLINI, who is President of the Provincial Epuration Commission, and Professor FADDA, who is in charge of alimentation. The 2 said both are conscientious and fit persons for the jobs they are doing. At the present time, there is no further need for Vice Prefects or Consiglieri. In fact, the province seems to be pretty well staffed with regard to Consiglieri. The Prefect said that Segretari were necessary. I outlined the procedure for requesting such personnel; namely, direct communication to the Ministry through AME channels.

10. In summary, the province seems to be fairly well organized from a local government standpoint and in a position to carry on the job of compilation of the electoral lists. The thing that has to be done quickly is the appointment of the Deputazione Provinciale which body in turn will select the 4 citizen members of the CPA and the 3 or 4 members of the Electoral Commissions. On the Communal level, all of the Sindaci and Giunta should be formally appointed to office. Assurances with regard to the execution of these points were given by the PC and Prefect. Lists of the personnel in the province were secured from the PC, copies for the Province and Region being retained by him. Instructions as to the forwarding of the semi-monthly reports of the Prefect to HQ were given to the Prefect.
