TO : Headquarters, Allied Commission,
(Att: Local Government Sub-Commission).

1. Capt. R.J.P. Dawson, the Acting Provincial Commissioner of NOVARA has reported to the Regional Commissioner that he is not satisfied with the manner in which his Prefect is executing his duties and recommends that a Career Prefect be appointed for that Province.

2. The Regional Commissioner is in agreement with the recommendation as to the advisability of the appointment of a Career Prefect, but considers that, at this late stage in AMG administration, the dismissal of a Prefect who has held office since May last should be avoided unless such dismissal is absolutely imperative from an A.M.G. point of view.

3. Certain actions of the Prefect indicate a leaning to one Political Party, either from conviction or fear, and the Acting Provincial Commissioner has taken steps to rectify the matter as far as possible.

4. It is not considered that the removal of the Prefect from office, although possibly desirable, is imperative.

5. This information is furnished you in order that you may be fully alive to the position in NOVARA Province.

The situation concerning the officials employed at this Prefettura is rather bad, because there are 4 officials, one of them is the "Capo Gabinetto" and the other 3 are in charge of the administrative offices. These employees have not the possibility to do all the work of the Prefettura, because part of their activity is given to the electoral service.

According to this fact, we kindly beg you to inform ACC in Rome to contact the Ministry of Interior asking for 2 officials of "Group A" an adviser and a secretary to be sent immediately to this Province.

He will probably resign when the Province is handed back to the Italian Government and another Prefect will then be required.
