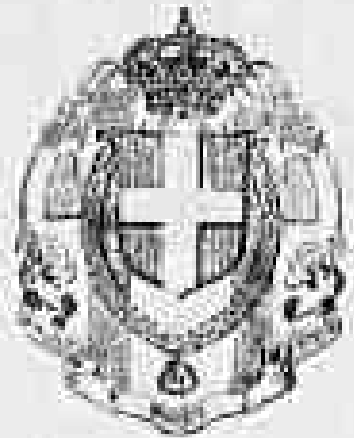

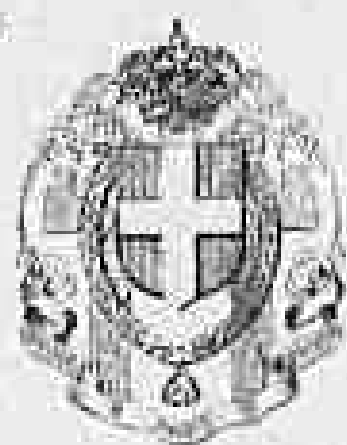

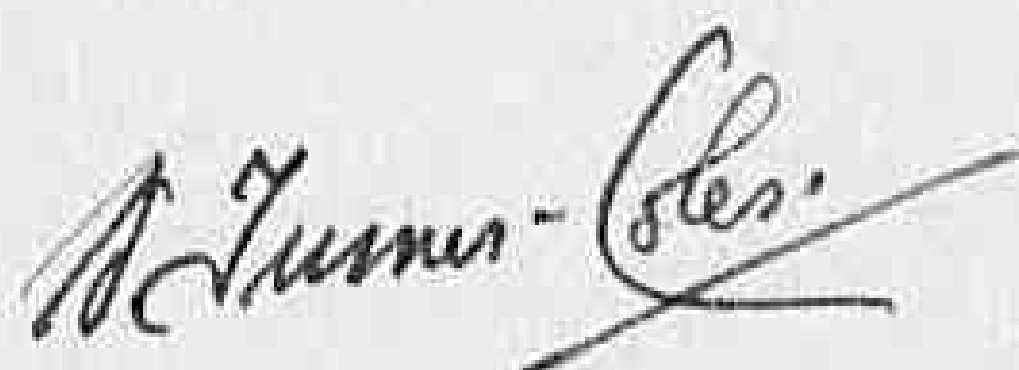

TO : The Minister of the Interior.

1. Reference is made to your 1633/1 dated 16 November 1945. As a Vice Prefect Inspector for Aosta is no longer required, your letters to the Prefects of Aosta and Turin are returned herewith and it is confirmed that the proposed transfer of Dott. ROBERTI to Aosta is hereby cancelled.
2. Dott. CONSOLI has now resumed his duties in Aosta Province.
3. Dott. ALDARESSI has been acting as Vice Prefetto Ispettore in Aosta Province, during the absence of Dott. CONSOLI.
4. The Provincial Commissioner of Aosta recommends that Dott. ALDARESSI be transferred to another area because it is understood that he served in Aosta during the Republican period. Although Dott. ALDARESSI appeared before the Epuration Committee and was re-instated, the Provincial Commissioner recommends that he should be transferred to an area where his former service is not so likely to be questioned.
5. Accordingly, Dott. ALDARESSI is placed at the disposition of the Ministry. Please note that this Sub Commission does not wish Dott. ALDARESSI to be re-employed in Allied Military Government Territory.

Further to my PR/AO/1604 dated 30 Oct. 45. Contrary to expectation Dr. Console, the Consigliere acting as Vice Prefect Inspector, returned from his extended leave yesterday, excusing himself on the grounds of transport difficulties on the downward journey and subsequent ill health. As he has returned with his own private car, which will put him in the exceptional position on an Inspector being able to inspect, it is proposed that he be left in situ until autonomy decides otherwise, and therefore that no substitute be sought for Dr. Aldaresi, as previously requested.

Dr. Console reports that when passing through Rome he asked the Ministry to arrange for his transfer, but since this would first require the consent of the Sub-Commission it need not be taken into consideration.

TO : The Minister of the Interior

1. The Regional Commissioner of Piemonte informs this Headquarters of the necessity of appointing a career Vice Prefect Inspector for the province of Aosta.
2. The situation is that the acting Vice Prefect Inspector CONSOLE Dott. Pasquale, a Consigliere of the First Class, is not well seen in the Province. He was recently granted leave and left for the South of Italy, taking his family with him. He has not returned on the expiration of the period granted him.
3. The return of Dott. CONSOLE to Aosta is not desired and he is accordingly placed at disposition of the Ministry. As his present address will no doubt be known to the Prefect of Aosta, Allied Military Government has been asked to direct the Prefect to inform Dott. CONSOLE of this decision and to communicate his address to the Ministry.
4. Will the Ministry please nominate an official for the post vacated by Dr. CONSOLE. Possibly a suitable candidate can be found from one of the Prefectures where there is an excessive number of Consiglieri. It would obviously be convenient if one of the surplus Consiglieri in Turin could be assigned to Aosta. Will the Ministry be good enough to take up this point and let this office have their recommendations.

Reference your PR/ESC/014.10 dated 26 Oct 45 and enclosed letter from Local Government Sub-Commission.

1. It would certainly be appreciated if a new Vice Prefect Inspector could be provided before the transfer of Dr. Aldaresi so as to avoid any hiatus in the functioning of this branch of the Prefettura.

2. It would also be appreciated if arrangements could be made to prevent Dr. Console, the former acting Vice Prefect Inspector, from returning to Aosta, if he has the intention of doing so. He has already considerably overspent the leave granted to him without any reference to the Prefect, and in addition to the fact that he is a Southern Italian is generally unpopular in Aosta, where he recently made a deplorable impression as a witness in a trial before the Special Courts of Assize. As he took his family with him when he went on leave he would thus be saved the trouble of bringing them back from the South of Italy.

3. The Prefect has been informed of his responsibility to request Consiglieri and Segretari from the Ministry of the Interior direct.

TO: 100 Vicenza (with copy for PO AGORA)

1. Reference your NO/104/014.40 dated 15 October received at this Headquarters on 22 October 1945.
2. Your request that this Sub Commission should endeavour to transfer Dr. ALMAGGI, at present Acting VPI AGORA, to some other Province where his past record is less wellknown, is noted.
3. However, it seems likely that the Prefecture of AGORA would then be in need of a VPI, since the former acting VPI, 1st Consigliere CUNIGLI, is on indefinite leave. If it is your intention that a new VPI should be provided before the transfer of Dr. ALMAGGI takes place, would you please advise this Sub Commission as soon as possible.
4. Further, it would appear that the Prefecture is without Consigliere and secretary. If such officials are required, the Prefect should address the Ministry of the Interior direct.

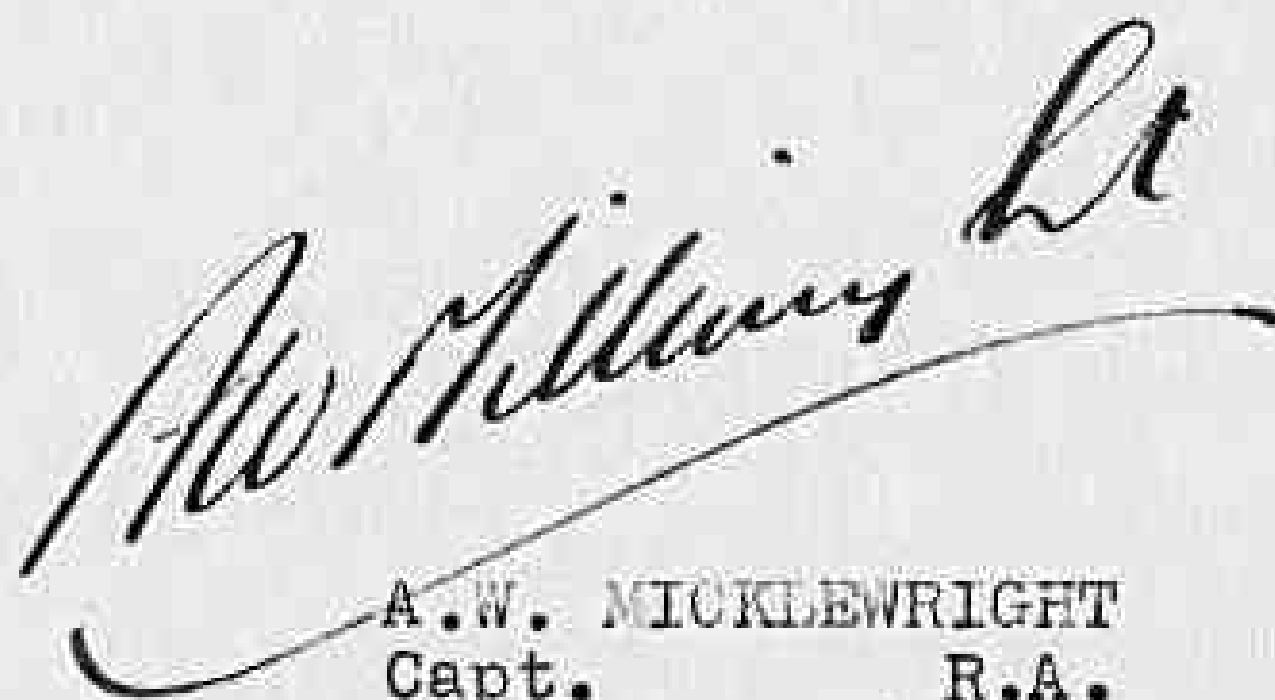

1. With the granting of autonomy to the Aosta Valley and the transference of the rest of the Province to Torino on the departure of AMG, the Prefect of Aosta would like to know how he stands with the Ministry, and requests permission to visit Rome.
2. Avv. Luigi GARDINI, a career Prefect (First Class) was appointed, on recommendation of this and Regional HQ, by AMG Fifth Army on 21 June 45. Previously he had been in retirement in the Province of Asti, having refused to serve under Republic. He has therefore been out of touch with the Ministry for two years.
3. Since he took office Avv. Gardini has worked extremely well in a difficult situation and I heartily recommend that he be allowed to proceed to Rome. I regard him as an example of the best type of Italian official and one of whom the Italian Government should have need at the present time.
4. If his journey is agreed to, Avv. Gardini would like to leave sometime next week, on or about 4 Sept. May a passage by plane please be booked for him.

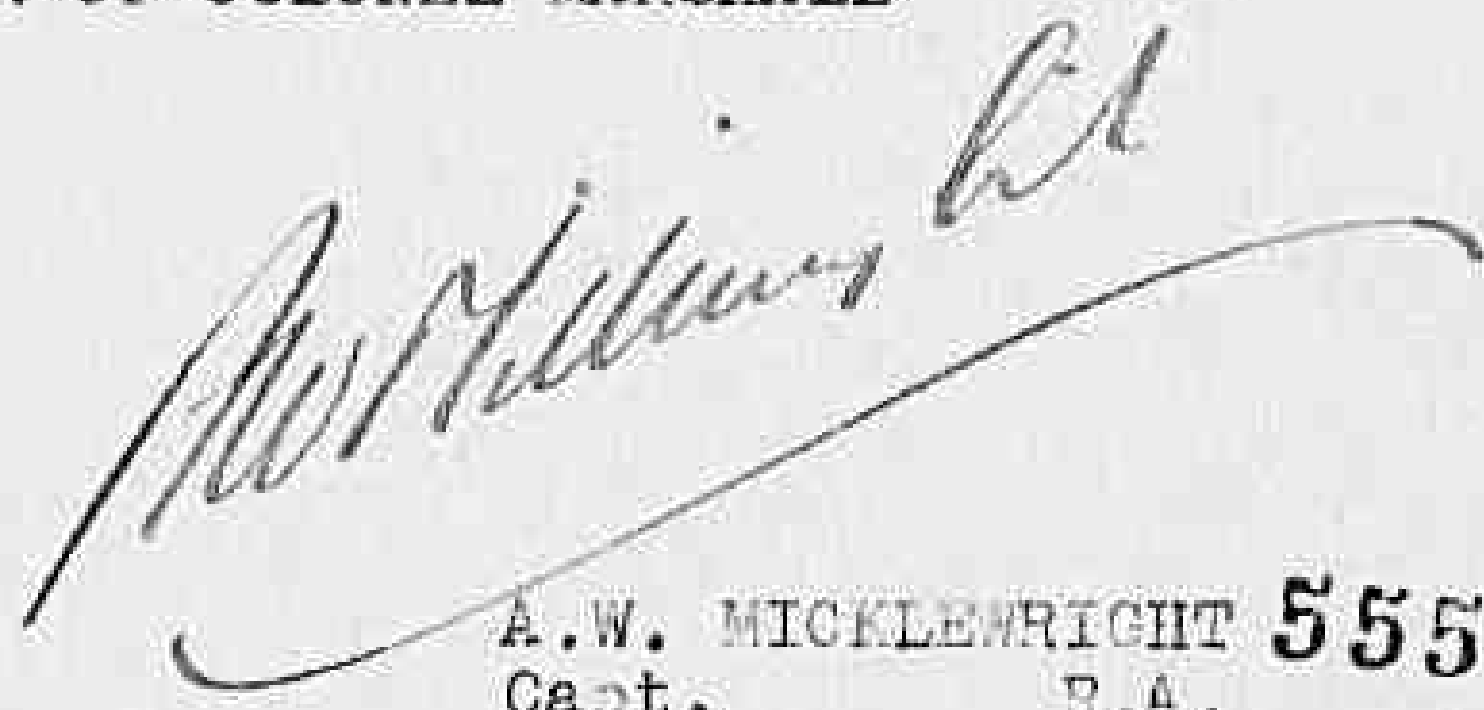

1. The task of re-organizing local government is made even more difficult than usual by the unique political situation in Aosta Province. Not only are there the usual political parties but there are also several other factions:--those who favour annexation to France, those who want autonomy, those who want to remain Italians, and a large portion of the south of the province who say they should be in Torino Province and who won't have anything to do with Val d'Aosta at all! When I arrived, things were further complicated by a strike of all State Employees because their increases of pay became effective on 1st August and not 1st May last. The Prefect and the Capo Gabinetto--both career officials--had not come on strike. It is not certain whether the VFI was on strike or not. He had to be sent for in the morning to talk to me but I gathered from the PG that this is not unusual.

2. Prefect. The first Prefect was a political appointment and was useless. When he went, avv. Luigi GARDINI was brought from Asti where he had been living in retirement because he refused to co-operate with the Republican Fascist Government. He is a career Prefect, Grade III. PG is very pleased with him. He is an excellent official and is doing a splendid job under great difficulties. The Prefect looks a distinguished gentleman and is my conception of what a Prefect should be. I was very favourably impressed with him in the hour we were together. The Prefect is worried about his own position when the Province is handed over. I told him there was no need to worry as the Ministry were only too pleased to have career Prefects in office and were most unlikely to make any changes. He is also worried about what will happen to him if Aosta gets autonomy. On that subject, I could, of course, express no definite opinion.

3. VFI. One is needed urgently. There is a non-career VP, Geo. PARESON, who has remained over from the days of the former Prefect. He is performing much the same functions as the "Vice Prefetto Politico" already mentioned in other reports. The Prefect would like to have a VFI called Dott. Francesco QUAINI, who is at Sonario, sent to him. He has worked with him before. He was anxious, however, that QUAINI should only be sent "in missione" so that his career would not be prejudiced if Aosta gets autonomy. I promised to inform the Ministry of Interior to this effect and if this is not possible to tell them that any VFI is urgently required. X

4. VFI. Dott. Pasquale CONSOLIS, a career Consigliere "con funzioni Ispettorali". He is a mediocre type of official who knows his work but will never be much good in any grade higher than Consigliere.

5. * Other officials

Francesco QUAINI, who is at Sondrio, sent to him. He has worked with him before. He was anxious, however, that QUAINI should only be sent "in missione" so that his career would not be prejudiced if Aosta gets autonomy. I promised to inform the Ministry of Interior to this effect and if this is not possible to tell them that any VPV is urgently required.

4. VII. Dott. Pasquale CONSOLA, a career Consigliere "con funzioni Ispettorali". He is a mediocre type of official who knows his work but will never be much good in any grade higher than Consigliere.

5. Other officials. There are no Consiglieri or Segretari. At least two are urgently required if things are to move at all. The Prefect says quite frankly that things are not going properly. He has written to the Ministry for officials without success. I promised to see what we could do to speed things up. There is a sufficiency of Ragionieri. In fact one is acting as Capo Gabinetto. The Prefect knows a Primo Segretario called VISCELLA at Turin and would like to have him. I said that this was a matter to be arranged on a Regional basis. In any event, two Consiglieri will be necessary.

6. Deputazione Provinciale has not been formed yet. The nominations are all in, however, and the PD has told the Prefect to hold a meeting next week. The 4 citizen members of the CPA will be nominated then. I stressed the importance of this from the point of view of the Electoral Commissions as well as from the purely administrative side.

7. There are 109 Communes in the Province and all have a Giunta Comunale and a Sindaco. They had been nominated by the CIM and approved or not as appropriate.

8. Segretari Commali. With 103 career Segretari, no problem exists here. The Prefect has been worrying about getting Segretari of the proper grade to match the grade of the Comune and has shifted a lot about to achieve this end.
9. CIN. There is nothing of interest to report except that they have a woman President! They have behaved like the average Northern CIN. There are no serious difficulties.
10. Elettoral Lists. It is gratifying to be able to report that in spite of the shortage of officials and administrative difficulties the preparation of the lists has gone on extremely well. The forms were received and distributed in time. They had to be carried by mule over the mountains to outlying Communes. ANI assisted with transport. The new forms had not arrived yet but would be dealt with in the same manner when received. The work had commenced on 15th July and was going well, especially in the smaller Communes. The larger Communes had been a bit slower but except in a few cases the extracts from the "elenco" had now been sent to the Casellari Giudiziali.
11. In spite of the destruction of records in 3 Communes and the partial destruction in another, only one Comune had asked for an extension and this had not been granted.
12. There are two Casellari Giudiziali at Aosta and Ivrea. Both are complete. The Prefect anticipates some delay in getting replies from other Casellari. He asked if he should hold up the lists if replies did not come in or go on with the lists and take the names off later. I said I would prefer to go on with the lists. (Note: The names could be taken off later by the Elettoral Commission on an "objection". It would be absurd to hold up production of the lists because one Casellario failed to function or because a letter got lost in the post.
13. Elettoral Commissions will be set up as soon as possible. Four Commissions will be required and two Sub-Commissions.
