SUBJECT: Officials for Cremona Prefecture.

6 September 1945

TO : RD Lombardia Region (with copy for RD Cremona).

1. Your office spoke to this Sub Commission a few days ago by telephone (Capt. Neufeld—Major Temple) on the question of an additional Consigliere for this Prefecture.

2. We see no need for an additional Consigliere here. Cremona now has a competent career Prefect; 2 Vice Prefects, both Vicario and Ispettore; 2 Consiglieri di Primo Classe (ROSSI and INDRAMOLO) and a First Secretary acting as Consigliere. Cremona thus has 3 officials discharging the functions of Consiglieri. Our agreed policy with the Ministry of the Interior has for a long time been that in present circumstances no province, except the very largest, would be allowed more than 2.

3. We feel no sympathy towards the Prefect's suggestion that he cannot make progress with the preparation of the electoral lists unless he has another Consigliere. Prefectures of all Italy have taken this work in their stride with their normal complement; and in Cremona, Consigliere ROSSI has already been put in charge of the Electoral Office.

4. The question of staff for this Prefecture was dealt with in para 8 of Major Williams' report of his visit to the province on 6 August. A copy was also sent to you under cover of this Sub Commission's letter AC/1/11/12 of 22 August. It is possible that Consigliere ROSSI's desire to get back his Republican rank of Vice Prefect Inspector may have something to do with the position the Prefect is taking.

SUBJECT: Survey of Cremona and Mantova Provinces.

22 August 1945

TO : RC Lombardia Region.

1. Herewith copies in duplicate of Major Williams' reports on his recent visit to the above 2 provinces: an extra copy is sent for you to pass on to the RC if you think fit.
2. CREMONA. The main point raised here was the shortage of Communal Secretaries: you will observe the comment on same at paras 5 and 6 of the report. The matter has been mentioned to the Ministry and, as anticipated, they are not in a position to supply the gaps: they can only suggest the appointment of temporary Secretaries with the requisite qualifications. They will, however, endeavor to find one for Cremona City.
3. It is rather doubted whether the officials whom Major Williams interviewed are facing the question with the right sense of proportion: and it would be as well if the new Prefect's attention were directed to it.
4. Similarly, the personnel questions raised in para 8 of the report are now primarily matters for the new Prefect. It is suggested that the observations in para 8 of the report be treated as for the information of the RC only and that the Prefect be allowed to form his own judgment and make recommendations to the RC on his own initiative.
5. MANTOVA. This province calls for no special comment. The Sub Commission would be glad, however, to receive the biographical report forms in respect of the 2 career Vice Prefects LEO and RUSINI.

3. Date : 6 August 1945
 All Lindoi have been confirmed in office - those outstanding by a decree on bloc. The 2 Desiderio Prefettilio (at Vologno) was appointed in order to have someone at the head of the communal administration while time is taken over the selection of a new Sindaco. Giuseppe Comandoli however have only been confirmed in 74 out of the 110 Comunes.
4. The position as to Secretari Comandoli is causing anxiety to the Italian officials who keep returning to this point in conversation. The 15 non-career Segretari have only the elementary school-teachers certificate and are employed in the smaller comunes. The remaining 95 comunes are covered by 70 career Segretari so that there is a certain amount of doubling. The Italian officials said they received many complaints from Segretari that they could not carry the burden any longer.
5. Cremona is not quite so well situated for Segretari Comandoli as the other provinces of the North that I have visited. I do not think however that the figures justify the claim displayed by the Italian officials of the Provincia. Provincia in Italian Government Territory are generally worse off than Cremona and no assistance can, I think reasonably be expected from the Ministry of Interior: they are in no position to supply Segretari by drawing them from the Centre and South where they are harder to find than in the North. The only answer is that the Segretari Comandoli must continue to work hard - as this class of public officials always has had to do and always will.
6. Cremona city (1936 population about 65,000) is a special case. Its Segretario Comandoli was dismissed just before liberation and its administration is still without a qualified official Alfondo. The Prefect has applied to the Ministry of Interior for the supply of a Segretario Capo di 2° classe - which is one grade below that fixed by law for a city of the population of Cremona. But that is a detail of purely Italian concern. I promised to mention the case of Cremona to the Ministry.
7. The Deputazione Provinciale was appointed on 12 July and the 4 electors

(b) - The Italian officials are very anxious to have as an additional Consigliere one PROSPERO, at present at Rome Prefecture. He has previously served in Grosseto and is, I was told, anxious to return there. In view of the fact that Grosseto already has 3 Consigliere (2 substantive and 1 Prime Segretario acting as Consigliere), when the agreed standard at the present time is 2 I doubt if this request can be justified. The Vice Prefect has already written to the Ministry of Interior about it.

9. The material for the preparation of the electoral lists was received and met limited in good time. Transport is difficult in this province both for the farms and for inspecting Italian officials. Cars are available but they lack tires and spare parts. No allocation has been yet made of the tires now being manufactured by Pirelli in Milano. The PC. stated that an allocation of tires was at the basis of all problems in the province.

10. I advised as to the nature of the further batch of doctored material about to be delivered - which incidentally, I saw being delivered to Lombardia Region HQ. at 0930 hours on Monday 5 August.

11. The magazine are all in order and the Cassellario of the Grosseto Tribunale is intact. Pretori are functioning in all 5 mandamenti.

12. He requested for extension of time have been made and none is expected. I brought back with me the Prefect's first fortnightly report. From this it appears that the first stage - the preparation of the "elenco" will be done within the time fixed.

13. The great difficulty here in the administrative incompetence of the Prefect and the PC. is most anxious to have his answer quickly. The Vice Prefect Vicario is also of not much use: the impression I received according entirely with what the PC. says about him on his Form B.

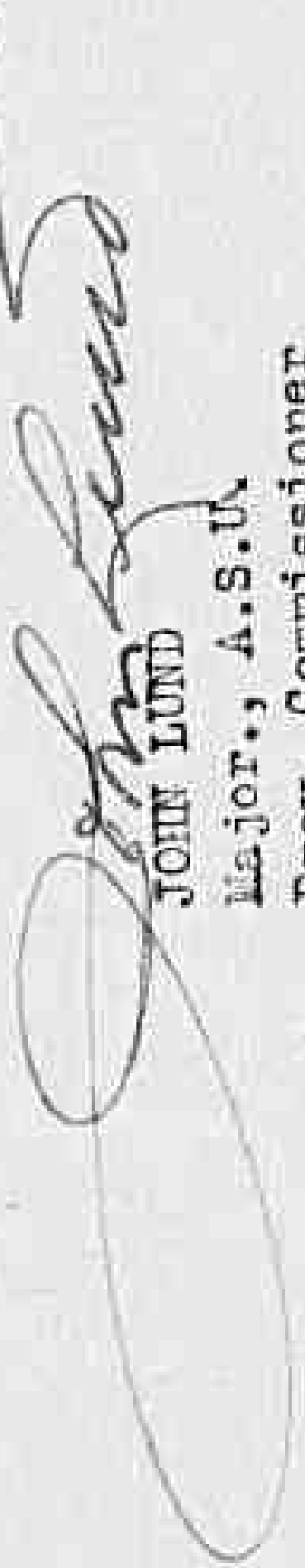

Dott. CATENACCI Corrado, Chief of Cabinet, Ministry of the Interior
Major Ralph R. Temple, Deputy Director, Local Government S/C
Sig. Arrigo NICE, interpreting

1. Major Temple informed Dott. CATENACCI that the Ministry's nominee for the position of Prefect of Cremona--Dott. GIAMMICHELE--was not acceptable to the S/C and added that a letter had been addressed to the Ministry on 1 August requesting a further nomination. Major Temple pointed out that local government conditions in the northern provinces were somewhat delicate at present and it was our policy to send to the North only those Prefects who were known to be good and to have irreproachable records. Major Temple asked Dott. CATENACCI to let the S/C have the name of the new nominee as soon as possible. Dott. CATENACCI said that he regretted that the S/C was unable to accept GIAMMICHELE, since the government knew of no objection to him. However, he fully appreciated the need for the best officials in the North and he would submit a new name as soon as possible.
2. Dott. CAMERA said that owing to the great shortage of officials, President PARRI had said that those officials already at the disposal of the Ministry in Rome should be used first. Dott. CAMERA said that Major Williams had already agreed to have included in the pool those Prefects who might have some minor charges of disfavour against them. However, President PARRI was anxious to send to the North Prefects against whom no objection could possibly be made, particularly as far as reputation was concerned.
3. Major Temple raised the question of the Ministry's nomination of DE ROSA for the position of Prefect of Lucca, and said that no biographical details had been received.
4. Dott. CATENACCI handed a letter containing these details to Major Temple and said that DE ROSA was not subject to epuration proceedings.
5. Major Temple stated that he believed the details to be incorrect insofar as they stated DE ROSA had been Prefect of Lecce during the period 1943-1944. Our records indicated that ROCCA had been Prefect in that Province during the same period.
6. Major Temple said that from the man's record he seemed to be experienced and he would probably be acceptable. Major Temple asked that DE ROSA be sent to the S/C for an interview as soon as possible. Dott. CATENACCI said he would do this.
7. Major Temple then spoke of Rovigo. A request had been made in the middle of July for a VP for Rovigo and we had suggested that a consigliere ff. may be suitable.

Major Williams had asked the Prefect of Rovigo to write direct to the Ministry on this matter and we had no information as to whether this had been done. In any event we had presumed, and had written to the Ministry yesterday, that he had written. Our reports show that a VP is needed in Rovigo, particularly as someone with training was essential for the compilation of electoral lists. Dott. CATENACCI said he would take up the matter.

8. Major Temple then spoke of Ravenna, stating that there was urgent need for both a VPV and VPI. Major Temple gave a resume' of the correspondence which had already taken place with the Ministry on this subject and asked Dott. CATENACCI to give this matter his urgent attention. Dott. CATENACCI promised to take the matter up.

9. Major Temple said that the Ministry had been asked to nominate a Prefect for Modena. Dott. CATENACCI said that the Ministry were proposing General ZANETTI, who is in the pool, for Modena. General ZANETTI would be promoted Prefetto del Regno if and when he was appointed Prefect of Modena.

10. Major Temple stated that he thought General ZANETTI would probably be acceptable and asked Dott. CATENACCI to make arrangements to have General ZANETTI report to Rome as soon as possible.

SUBJECT: Report of survey of Prefectural situation in Cremona Province,
21-22 July 1945.

1. At the specific request of Captain Neufeld, Executive Officer, Lombardia Region, I visited Cremona to discuss the Prefectural situation with Major Lund, the Provincial Commissioner. The PC stated that the present Prefect of Cremona--BRIERTI--was not satisfactory. He could not be relied upon to carry out any directives or any instructions no matter how carefully or how many times they were given to him. He delayed in the organization of Communal and Provincial government and has just recently appointed the Deputazione Provinciale. He is a source of constant irritation to the PC, who never feels sure that anything will be done. The PC had come to the decision that he would have to be replaced, and in fact the President of the CIN was in agreement with him.

2. I suggested that if it were possible, I should like to speak with Avv. FROSSI. FROSSI came in later that evening and I talked with him. He agreed that the present Prefect was useless and that a career Prefect was needed. I asked FROSSI whether the CIN could not find another local man. He replied that they had considered several other persons, but none was capable. Any other choice would be an experiment. He thought that a career man was necessary but stated that he would have to call the Committee together to have them come to general agreement. The PC and I pointed out that we were prepared to send a career Prefect down, but we wanted the CIN's support, unless they could submit the name of another local person.

3. I remained at Cremona that night while waiting for a decision of the Committee, but none was forthcoming. Next morning, the representative of the Committee came to the PC's mess where I was staying and produced a letter addressed to the PC, asking for two days postponement of his decision to change the Prefect. It was necessary, the letter explained, for each representative on the CIN to consult with his respective party.

4. The PC asked me to emphasize the fact that he wanted a decision by

2. I suggested that if it were possible, I should like to speak with Avv. FROSSI. FROSSI came in later that evening and I talked with him. He replied that they had considered several other persons, but none was capable. Any other choice would be an experiment. He thought that a career man was necessary but stated that he would have to call the Committee together to have them come to general agreement. The PC and I pointed out that we were prepared to send a career Prefect down, but we wanted the CLN's support, unless they could submit the name of another local person.

3. I remained at Cremona that night while waiting for a decision of the Committee, but none was forthcoming. Next morning, the representative of the Committee came to the PC's mess where I was staying and produced a letter addressed to the PC, asking for two days postponement of his decision to change the Prefect. It was necessary, the letter explained, for each representative on the CLN to consult with his respective party.

4. The PC asked me to emphasize the fact that he wanted a decision by Tuesday at 6 p.m.--that he either wanted the name of another local candidate or a green light to put in a career Prefect. The PC further emphasized that the Committee was not to deliberate on whether or not the present Prefect was to be retained, because the PC had already decided that he did not have the capacity for the work and that he was to be replaced. The representative said he would convey those remarks to the Committee.

5. Major Lund informed me before my departure that he would call Capt. Neufeld as soon as the Committee came to a decision and have the latter call me. In the meantime, he asked me to ascertain if the Prefect of Perugia--Avv. PEANO--was available. If so, he should like to get him if we were instructed to procure a career Prefect. PEANO had worked with Major Lund when the latter was PC of Perugia. NOTE: This morning (24 July 1945) I received a telephone call from the Secretary of Captain Neufeld who informed me that last night Major Lund had telephoned Milano and left word that I was to be informed that there was a green light on the procuring of a career Prefect. I thereupon instructed Capt. Lewis to set the wheels in motion to secure a career Prefect, preferably PEANO if he was available.
