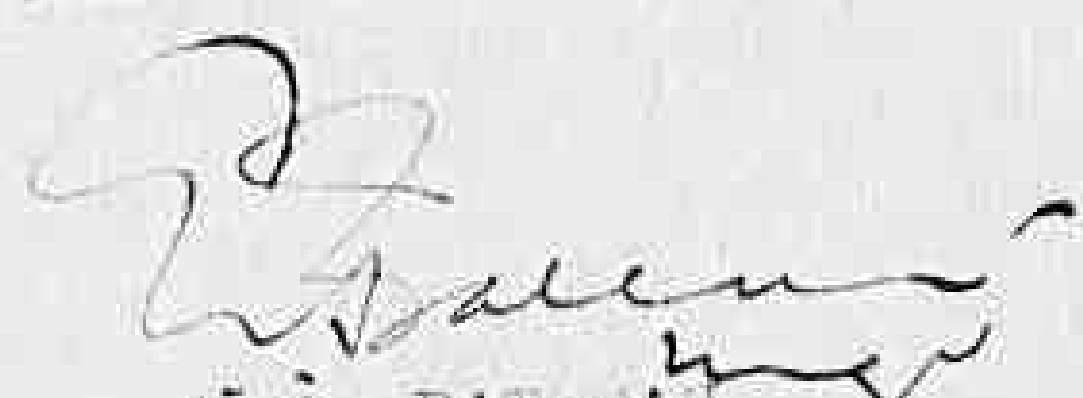

Subject: Situation regarding the Prefecture's staff

I deemed opportune to report to your Ministry the situation in which this Prefecture finds itself owing to the shortage of Group A personnel.

7 officials of Group A are attached to this Prefecture, of which 2 have been assigned to the Cabinet and another one, as already communicate by separate letter, has been removed from office on request of AMG and the Provincial CIN.

Recently an official has been called to head the electoral office and another one to head the relief office, so that four administrative divisions are governed by 2 councillors.

Moreover there is no official for the secretarial duties of the Giunta Provinciale Amministrativa in its jurisdictional capacity.

In order to partly bring back to normal the functioning of the Prefecture's services which in recent times, as it is known, must carry out a more intense activity than in the past, I kindly request your Ministry to please assign to this Prefecture, with courteous urgency, two vice-secretaries and at least one Councillor of 2nd class.

1. The Provincial Commissioner characterized the Prefect ZAMBIANCHI as a good, gentle man who, although the choice of the CLN and a Socialist by party affiliation, administers his province in a non-political manner.
2. HC discussed the case of Dott. Luigi BELLAZZI and said that as a result of the charges made, a public operation hearing was held and the man was cleared. There was nothing serious at all in the charges. As a matter of fact, the CLN are in full support of him. He had done some remarkable work in cooperation with the CLN before the entrance of the Allies and in fact himself seized the Prefettura and installed the Prefect on April 25, and thereafter withstood a 3-day siege. HC had a very high opinion as to his competency. The man impressed me also as being a very capable and enthusiastic official.
3. All persons in the Prefettura have come through preliminary examination. One official named Dott. FRAMERI Orisongo, Consigliere Grade VII, is now "on leave". He is subject to operation, but there does not seem to be enough on him to suspend him. However, the local situation would be better served if he were transferred. I informed the HC and Prefect that I would take this matter up with the Ministry.
4. I discussed the question of promotions of officials with the Prefect and HC, pointing out that although AMG could not promote a person in grade, they could assign him to a position for which he would receive the commensurate salary. There is no need for high ranking personnel, but I outlined the method of requesting lower grade personnel by direct communication to the Ministry through AMG channels.
5. An Electoral Office has been set up in the Prefettura under the supervision of Vice Prefect Inspector GIURA.
6. All electoral material has been distributed to the Communes. Communication is good and courier service is working. In the 217 Communes of the province, all of the Sindaci have been formally appointed by Prefectural Decrees approved by AMG. Giunta Comunale are functioning in all

matter of fact, the CIM are in full support of him. He had done some remarkable work in cooperation with the CIM before the entrance of the Allies and in fact himself seized the Prefettura and installed the Prefect on April 23, and thereafter withstood a 3-day siege. There is no need for high ranking personnel, but I outlined the method of requesting lower grade personnel by direct communication to the Ministry through AMG channels.

5. An Electoral Office has been set up in the Prefettura under the supervision of Vice Prefect Inspector GIRA.

6. All electoral material has been distributed to the Communes. Communication is good and courier service is working. In the 217 Communes of the province, all of the Sindaci have been formally appointed by Prefectural Decree approved by AMG. Giunta Comunale are functioning in all Communes, but 24 need to be formally confirmed in office. This is expected to be done within the next few days. All the sindaci have been called together for a general meeting at the Prefettura and the Prefect has visited all the Communes with the IC. Relations with the CIM are good, and the CIM have been informed of their advisory position. The CIM has much influence in the Communes outside of the city, but no so in the city itself and in the Prefettura. The Prefect does not allow the CIM to influence him.

7. IC believed that 80% of the province is Christian-Democrat, but that party is not well organized. The best organized party is the Communist.

8. There are 7 "amminenti" in the province. Electoral Commissions for each are in the course of construction. These will be completed immediately. No extensions of time-limits are expected to be granted to any Commune. It is hoped to finish the compilation of the lists by 20 October.

9. All the Communes are covered in whole or part by Segretari Comunali. I mentioned the scheme of the Prefect of Brescia of dividing the province into 10 zones with his most competent Secretary in each and assigning advisory and supervisory duties to these persons. IC and Prefect thought it was an excellent idea and intend to adopt it.

10. The Prefect informed me that the Provincial Commission, provided for under Art. 8 of Decree 159, which has the right to disfranchise people because of Fascist activity, was being constituted. I pointed out that they were centrally appointed and that they should take no further action until instructions were sent from HQ to the Regional Commissioner, who would, in turn, inform them as to the position.
