1. Persons interviewed : - Lt. Col. E. DOMINICHI - M.D. (D) - PG
- Major R. MANZONI - Prefect Regent
- V. Gualtieri - V. Gualtieri

2. Date - 7 July 1945

3. SINDACI are in office in all 90 Communes. Most have been confirmed by PG; the PG could have the remainder confirmed before 15 July.

4. Every Comune has a Segretario Comunale, all career men in possession of the "patente". This is most unusual - and fortunate.

5. The Legatione Provinciale held its first meeting a few days before my visit; it then appointed the executive members of the CGA which was to hold its first meeting the next week. The Legatione consists of 1 member from each of the 3 Regimenti.

NOTE - Information from RMO indicates 7 Mandamenti only.

6. The population registers are in order in all communes except Orselle and one or two others. The Prefect has had a talk with the Segretario Comunale of Orselle as to how he should proceed.

7. The distribution of electoral material to communes was completed by 4 July. Yesterday the Prefect held a meeting with the majority of his Sindaco; the whole process was discussed and instructions given.

8. 1 Tribunale at Torino. The Gualtieri is in order. All Pretori in office.

9. The organization of the Prefettura is unusual. The following table illustrates it : -

9. The organization of the Prefecture is unusual. The following table illustrates it: -

10. The PG seemed to regard GILBERTI and GILBERTI as Vice Prefects. I advised him that if he wished them to act as such he had better formally appoint them to the post. GILBERTI is compromised and will have to go eventually by under 60.35: the PG thinks he can be substituted with a local man. BOCCICI was promoted VII by the Republican Government: this being null and void has been reduced to the rank of Consigliere.
11. As compared with the Prefect (Action Party), S. RIVA (Dopo-Christian) is the live wire. The PG has considerable confidence in him and I received a good impression. The Prefect is also a man of personality with his own views.
12. The organization is not "according to the book; but if it works (as it seems to do) and the PG is satisfied, I was not prepared to advise any alteration. I shall see better when our provincial report form comes in. Here the Italian Government discover however, who will I think, require a return to the normal constitution.
13. The electoral office is in charge of a Consigliere di Prefettura, who

will also be the in elections as to the electoral lists.

13. The PC. thinks elections would strengthen the authority not only of the local government agencies but also on the PC; and the manner they are held the better. The prefect thought that the administrative elections should be held in October/November and those for the participants in December. I think he is most sanguine; but he is of course, only considering Treviso, the other 90 old provinces being none of his business.

14. The prefect who said the great problem is public order: he fears the elections won't be free and said that the Communists specifically were still armed. "Give me 1000 G.I.s, and an efficient and organized gendarmerie and I can hold the elections". This was Mr. SARACIN's view as well.

SUBJECT : Prefectural appointments in northern provinces. 15 May 1945
TO : Vice President Civil Affairs Section.

1. To date we have received scanty information as to the actual appointments of Prefects in the northern provinces. We have been officially informed that only one Prefect has been formally installed, to wit Dott. Gianguido BORGHESE-Socialist-Province of Bologna-- CLN nominee. We have also been informed that in the province of Ferrara the head of the Provincial CLN, who himself is non-political and named HIESCH Renato has been appointed Acting Prefect temporarily pending the selection of a permanent Prefect.
2. In two cases, the CLN nominee is also the Government's candidate and, therefore, the possibility of them being appointed is very good. These are Sig. AVANZINI Ennio-Christian-Democrat-Province of Mantova, and Sig. DEL GIUDICE Pietro - Socialist - Province of Apuania.
3. We have received a signal from Brigadier Dunlop that he expects to appoint the following persons, all of whom are CLN Nominees: it can be taken, therefore, that they have been appointed by now, since we have replied to the signal that the RO has full authority to make appointments after consideration of the Government's candidates. These persons are:

4. We have received information as to the names of CLN nominees for other provinces and have given this data to the Ministry of the Interior for any observations they might have concerning the persons. Of the 19 names of CLN nominees, only one was known to H. E. BERRUTI, who characterized him as a good man. This person was Avv. GIACCHERO--Christian--Democrat--Province of Asti. As stated before, the candidates for the provinces of Mantova and Apuania were also the Government's choices.

Subject is appointment of Prefects. Understand that AMB 8 Army has already recommended to you the appointment of Sig MATTEI as Prefect of VENEZIA PROVINCE. In respect of ROVIGO PADOVA and TREVISO I propose to make following appointments:

For ROVIGO Avv. ENICI FUKEDER Aged 40 years Liberal Party nominated by CIN well reported by Lt Col GRAHAM Provincial Commissioner

For PADOVA AA GAVINO SABADIN, Christian Democrat, formerly Presidente of CIN for whole Compartimento, appears outstanding character.

For TREVISO Avv RAMAZINI Partito D'Azione, nominated by CIN, well reported by Lt Col PRICE Provincial Commissioner. Assume that 5th Army have reported to you in respect of VENEZIA Avv. GIULIO Partito D'Azione and VERONA GIOVANNI UBERI Christian Democrat. Will report shortly in respect of BELLUNO Dott ANTONIO DAZZI Christian Democrat. In general am convinced that any attempt to impose imported career Prefects from the south would be a political blunder on part of ROME Government. Am considerably impressed with standing and outlook of CIN nominees in VENEZIA. This view shared by Air Commodore BENSON Colonel SOUTHERLAND and my Provincial Commissioner. Further points for your consideration, ROME nominee for TREVISO Dott SIMONE NATAN well known to Lt Col PRICE and for shorter period to self in SARONIA, not considered strong candidate. Dott SILVESTRO ALES known to Lt Col MC BRATNEY not considered strong candidate. Dott GIOVANNI PALAMARA and Dott ITALO MORELLI said to be of FOGGIA and BENEVENTO have only held these offices few weeks.
