SUBJECT : Col. Giuseppe PARISI - Verona Province

TO : EC. VERONA (With copy for PC. Verona)

1. This Sub Commission has been informed by the Ministry of the Interior that the office of Sindaco in the Comune of LEGNANO (Verona Province) is at present held by Col. Giuseppe PARISI.

2. The Ministry have pointed out that Col. PARISI has been denounced to the Tribunal of War for collaboration with the enemy, having served under the republican government as Inter-Provincial Military Labour Inspector for the three Venetio. It is understood that the Prefect of Verona has been informed of the denunciation by the Bolzano Area Military Command.

3. Further, since this officer is on permanent service with the Engineer Corps he is not eligible for the office of Sindaco according to Italian law (Art. 14 of the Law of 9/5/1940 No. 360 on the status of the officers of the Royal Army). Although this law is not applicable to Allied Military Government Territory, it has always been the policy of the Allied Commission to conform, whenever and wherever it is possible so to do, with the provisions of the Italian law.

4. The above information is submitted for your consideration. Would you please take any action which you may deem fit and advise this Sub Commission accordingly.

The Ministry of War - Cabinet - sent this Ministry a letter, dated 14th instant, n.5231 R.P./III, which read as follows:

"The Bolzano Area Military Command has informed this Ministry that Engineer Corps Col. Giuseppe Parisi who is on permanent service, is at present holding the office of Sindaco in the Commune of Legnano (Verona).

We beg to point out to your Ministry for any necessary action, that said officer has been denounced to the Tribunal of War for collaboration with the enemy, having served under the republican government as interprovincial military Labour Inspector for the Three Venezie.

Also the Prefect of Verona has been informed of this denunciation by the said Bolzano Area Command.

Furthermore, since the officer is on permanent service he may not hold that office, (art. 14 Law 9/5/1940, n.360 on the status of the officers of the Royal Army),

Since the Province of Bolzano is still under A.M.G. jurisdiction all the above is being communicated to the Hon. Allied Commission for action.

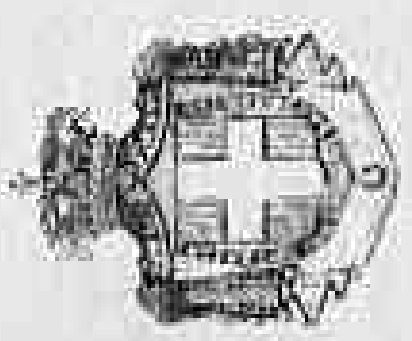

APPENDIX III - VERONA PROVINCE

2. Date: 31 July 1945.

3. The City of Verona has for centuries been a fortress and a garrison town by reason of its geographical position and natural advantages. This fact tends to obscure the considerable industrial importance of this town of 175,000 people. As the PC emphasized to me, it has continued to be an important military HQ to the present day. German GHQ was there; so was their main supply Hq and the main Republican-Fascist ministries. Since the surrender Verona has harboured GI, 15 Army Group; and GHQ 5 Army is only some 40 miles away, at Salo on Lake Garda.

4. This situation has had two results to which the PC drew attention -

- (a) multiplicity of command: apart from Regional HQ, AMG 5 Army and G-5 15 Army Group have to be consulted on certain points.
- (b) weakness in the CLN. Not that the CLN are not as willing to interfere with the processes of government as much as anywhere else in N. Italy, but during the clandestine period they had to work more quietly and slowly than elsewhere. The result is that they were not able to set up so complete a local government structure as in other provinces. For instance, the Prefect was only nominated by the CLN the day before AMG entered the city.
5. The original CLN consisted of young and inexperienced people: its President was a lad of 21. The present President is a most able man, General CANUOPT. It consists of representatives of the usual five parties (i.e. the 6, less Labour Democrats) and a representative of the CVL and the Gioventu della Libertà.

6. The PC had forms "A" and "B" ready for me.

7. Local Government. Sindaci are in office in 91 out of 93 Communes. The other two - Osteria and Ronco all'Adige - have Commissari Prefettizi. The former Sindaci were dismissed for defiance, in Cerrea of the CAO and in Ronco of the Prefect. Some 20 old Sindaci remain to be confirmed. Though the PC and the Prefect are not satisfied of the suitability of these for office, I advised any immediate block confirmation of the lot, so that their acts in connection with the preparation of the electoral lists should not be questioned in that ground.

8. There is a Segretario Comunale in every commune. The 29 shown in form "A" as not being career officials are so in the sense that they have not been formally admitted to the official register or "roll" of Segretari Comunali by means of a 'con-

Though the PC and the Prefect are not satisfied of the suitability of these for office, I advised an immediate block confirmation of the lot, so that their acts in connection with the preparation of the electoral lists should not be questioned in that ground.

8. There is a Segretario Comunale in every commune. The 29 shown in form "A" as not being career officials are so in the sense that they have not been formally admitted to the official register or "roll" of Segretari Comunali "by means of a 'concorso'"; but they have all passed the examination, and have the "patente" and thus have the necessary technical qualifications for the job.

9. ^{Carriere}Giunte Comunali are in ~~case~~ of approval, like the Sindaci, and the Prefect is reducing the excessive number of members appointed by the CIN to the members fixed by law.

10. The Deputazioni Provinciali was confirmed by the PC about 10 days before my visit. It has elected the four elective members of the CPA: Form "A" is out of date in this respect.

11. The Prefecture has a full staff of competent career officials mainly ⁵⁷² (as the PC thinks and so do I) because the CIN was not in a strong enough position to interfere with them before the arrival of AMG. It has been necessary to suspend only one pending epuration - Cons. SURLANO.

In addition to the two career Vice-Prefects, the CIN put in two political -Prefects. With these the PC has taken the line that there cannot be more than one-Prefects and that the career men must be allowed to do their job and have access to the Prefect. He has refused to confirm them in office or to allow

than to call themselves Vice-Prefect: instead he has entitled himself Commissari Prefittini.

13. Although to us the term usually signifies the Commissario Prefittizio of a commune, there is no magic in the phrase and it is appropriate for anyone commissioned by the Prefect to discharge particular functions of any kind.

14. One of the political PCs made himself a nuisance at one time by (a) requesting the PC to discharge a partisan arrested and gaoled for hair-clipping, merely because the offender belonged to his own party the Communists; (b) getting an issue of 1,000 litres of petrol on the Prefect's recommendation and then turning 700 litres of it over to the CIM; and (c) trying to turn a woman out of her apartment in order to seize it for his own mother and sister. He has now quietened down and though he and the others remain at the Prefecture, they do not seem to do much harm.

15. The Communal "magistrate" are all in order, except in the City of Verona where there was considerable damage to the records from bombing on 4 January last. There is one Tribunale with seat at Verona and the Casellario is in order.

16. There are five Mandamenti with Pretori available. The Prefect has requested the Deputazione Provinciale to nominate their appointees on the Electoral Commission and Sub-Commission.

17. The first batch of electoral material was distributed to all communes in good time. The second batch - that for the determination of polling districts arrived the day before my visit. There is some difficulty about transport. The PC can only lend one truck as he is very short of vehicles himself. I suggested the hiring of Italian civilian vehicles which the Italian officials did not seem to have thought of before. It is their practice for the Head of the Electoral office (Cons. GAPPALANI, to go around with the forms and give personal instructions to the Sindaci etc. and they did not seem to think it proper for a Prefectural official to ride in an open lorry! These difficulties are common to all Italy and should not be a reason for the special treatment of Verona Province, but Verona City might have 20 days.

SUBJECT : Prefectural appointments in northern provinces. 15 May 1945
TO : Vice President Civil Affairs Section.

1. To date we have received scanty information as to the actual appointments of Prefects in the northern provinces. We have been officially informed that only one Prefect has been formally installed, to wit Dott. Gianguido BORGHESE-Socialist-Province of Bologna-- CLN nominee. We have also been informed that in the province of Ferrara the head of the Provincial CLN, who himself is non-political and named HIESCH Renato has been appointed Acting Prefect temporarily pending the selection of a permanent Prefect.
2. In two cases, the CLN nominee is also the Government's candidate and, therefore, the possibility of them being appointed is very good. These are Sig. AVANZINI Ennio-Christian-Democrat-Province of Mantova, and Sig. DEL GIUDICE Pietro - Socialist - Province of Apuania.
3. We have received a signal from Brigadier Dunlop that he expects to appoint the following persons, all of whom are CLN Nominees: it can be taken, therefore, that they have been appointed by now, since we have replied to the signal that the RC has full authority to make appointments after consideration of the Government's candidates. These persons are:

We have received information as to the names of CLN nominees for other provinces and have given this data to the Ministry of the Interior for any observations they might have concerning the persons. Of the 19 names of CLN nominees, only one was known to H. E. BERNUTI, who characterized him as a good man. This person was Avv. GIACCHERO--Christian--Democrat--Province of Asti. As stated before, the candidates for the provinces of Mantova and Apuania were also the Government's choices.

Subject is appointment of Prefects. Understand that 5th Army has already recommended to you the appointment of Sig. MONTI as Prefect of VENETIAN PROVINCE. In respect of ROVIGO PROV. and TREVISO I propose to make following appointments:

For ROVIGO Prov. LUIGI FUXERDE aged 40 years Liberal Party nominated by CIE well reported by Lt Col GERMAN Provincial Commissioner

For PADOVA AA GAVINO SABARIN, Christian Democrat, formerly President of CIE for whole Compartimento, appears outstanding character.

For TREVISO Prov. RAMAZINI Partito D'Azione, nominated by CIE, well reported by Lt Col PRICE Provincial Commissioner. Assume that 5th Army have reported to you in respect of VICENZA Prov. GIULIOLO Partito D'Azione and VICENZA GIOVANNI UBERTI Christian Democrat. Will report shortly in respect of BELLUNO Dott. ANTONIO BAZZI Christian Democrat. In general am convinced that any attempt to impose imported career Prefects from the south would be a political blunder on part of ROME Government. Am considerably impressed with standing and outlook of CIE nominees in VENETIA. This view shared by Air Commodore HENSON Colonel SOUVEREIGN and my Provincial Commissioner. Further points for your consideration, ROME nominee for TREVISO Dott. SIGNE NATAN well known to Lt Col PRICE and for shorter period to self in SARDINIA, not considered strong candidate. Dott. SILVERIO ALBI known to Lt Col MC BRATLEY not considered strong candidate. Dott. GIOVANNI BALAMARA and Dott. ITALO MORRIS said to be of PUGLIA and BRESCIA have only held these offices few weeks.
