5. I believe that it is unwise for the RC and PC to ignore the CLN in the choice of a Prefect. In the 4 or 5 cases in other provinces where we have received requests for replacement of non-career Prefects by career officials, in all cases there has been consultation with the local CLN to make sure the nominee would be acceptable and there would be no political trouble. The RC and PC, of course, have the final responsibility for the administration of the province and we are compelled to rely very much on their judgment. In this case, therefore, it would seem that it would be necessary for us to tell the Government that the proposition to appoint the Vice Prefect to the office of Prefect is unacceptable to the local AMG officials who prefer to have him remain as Vice Prefect but desire a career Prefect. The real reasons, of course, might not be stated. The Government itself has indicated that if the proposal was unacceptable, a career Prefect could be found (see para 3 of folio 12). However, before that were done, it seems desirable to bring this to the notice of higher authority at this HQ, inasmuch as it indicates an attitude towards the CLN and illustrates a method of manifesting that attitude--both of which are at variance with original policy laid down in the 27 April 1945 directive cited above. There is the possibility that higher authority may deem it advisable to instruct the RC to accept the Government's nominee of the non-career official. 1. Please refer to folios 9, 9A, 11, 12, 12A, 13, 15, 15B, 15D of ~~folios 14/15/16~~ this file and folio 33 of file AC/47/INT.
2. Briefly this matter presents a case where the incumbent non-career Prefect has proved unsatisfactory and RC has requested his replacement by a career Prefect. The Italian Government was asked to nominate a career Prefect but instead of so doing they sent a representative of the Ministry of the Interior who presented an official proposal that the incumbent Vice Prefect Vicario (Avv. ROLLA, a non-career official) be appointed Prefetto Reggente of Savona, and that a career Vice Prefect Vicario be appointed to fill the vacancy thus created. This proposal, upon being forwarded to the Regional Commission, has been rejected by him and by the RC. They prefer to have a career Prefect with ROLLA as Vice Prefect Vicario.

3. This situation is a little different from the usual one in the following respects:--

There is some indication that this matter indicates an attempt to digress from the policy laid down in the Chief Commissioner's directive of 27 April 1945 (file 9/20/1.CA) on the subject of Committees of National Liberation. Therein it was laid down that PCs try to appoint a person who was acceptable in the locality and try to reconcile the views of the CLN with those of the Italian Government. At the time the directive was issued, the Government's position was to advance the candidacy of career Prefects. Although the final arbiter is the PC, it is still his duty to consult the CLN with regard to the appointment of the Prefect. Apparently in this particular case, the PC and FC have not done so, obviously because they think it unnecessary--approval would be forthcoming. It is because they want to lessen the influence of the CLN that they desire a career Prefect and do not wish to appoint the non-career Vice Prefect to the office of Prefect. The ironic thing about the matter is that the Italian Government's nominee is also apparently the CLN's choice.

1. Major Temple said that, with reference to the proposal to appoint avv. Rolla as Prefetto Erogante of Savona, the opinion of the Regional Commissioner of Liguria had been obtained. The RC had stated that he would be agreeable to the appointment of avv. Rolla as VV; but that he was firmly of the opinion that a career Prefect was needed, who was familiar with the details of administrative procedure: the lack of such an official was felt in the administration of Savona. Accordingly, Major Temple stated the Sub Commission felt obliged to renew their previous request for the nomination of a career Prefect.
2. Sig. De Magistris said that he would see that immediate attention was given to this request. He pointed out that the nomination would be dependent upon a meeting of the Council of Ministers, and that there might be a delay of 3 to 4 days; but he promised to see that the matter was put on the agenda and marked for the immediate attention of the Council at its next meeting.
3. Major Temple said that, with reference to the vacancy for VV, it was desirable to postpone the appointment until the new Prefect was installed.
4. Sig. De Magistris said that he would telephone the details of the nomination of the Prefect to this Sub Commission to avoid delay, and would prepare the usual biographical details.

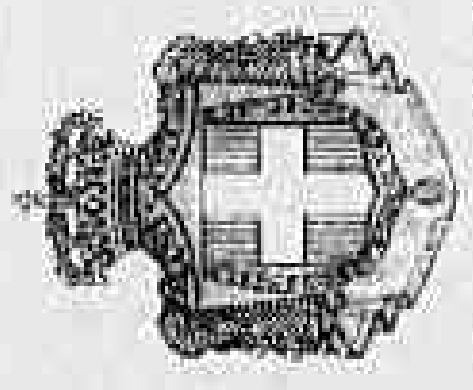

1. Sig. DE MAGISTRIS, as Vice Capo Ufficio to Sig. PARRI, Minister of the Interior, presented a proposal on the part of the Ministry that Avv. Giacomo ROLLA (at present Vice Prefetto Vicario) should be appointed Prefetto Reggente of Savona. It was the opinion of the Ministry that under Avv. ROLLA, as a non-career Prefect, the "political situation would be stabilized": it was also represented that this appointment could be balanced by the appointment of a career Vice Prefetto Vicario.

2. Major Temple drew the attention of the Ministry's representatives to the completely unsatisfactory state of the administration in Savona Province, as shown in the Provincial Commissioner's report, and to the fact that both present Vice Prefects were non-career men. He also noted delays which had occurred in the past in filling vacancies in the administration. Major Temple stated, however, that he would forward the suggestions of the Ministry to the Regional Commissioner, Liguria, for his observations. He also promised to ascertain whether or not a Vice Prefetto Ispettore was still required.

3. Sig. DE MAGISTRIS promised that, should these suggestions prove acceptable, he would make it his personal duty to see that a career Vice Prefetto Vicario was appointed by the Ministry immediately. Also, should these suggestions be unacceptable, it was believed that a career Prefetto could be found. Sig. DE MAGISTRIS then explained that, apart from the political situation, it was also the policy of the Ministry to refrain from making any new appointments amongst Prefects at the present moment, because a new set of regulations were being drafted: the effect of those regulations would be to lower the age-limit so that the administrative posts would be filled by younger men. Although these regulations were provisional, Sig. DE MAGISTRIS believed that vacancies would be filled very largely by the promotion of Vice Prefects. In answer to queries by Major Temple, Sig. DE MAGISTRIS stated that Sig. PARRI was sure that the appointment of Avv. ROLLA was acceptable to the CLN. He also stated that the present Prefetto Reggente was a member of the Republican Party, but that he was not sure what party Avv. ROLLA supported, though he knew it was not the Republican Party.

4. Major Temple promised to put the following points before the Regional Commissioner, Liguria:

- (i) The Ministry of the Interior have proposed the appointment of Avv. Giacomo ROLLA as Prefetto Reggente of Savona. This appointment is stated to be acceptable to the CLN.
- (ii) The Ministry further propose the appointment of a career man as Vice Prefetto Vicario. This appointment would be made immediately upon confirmation of the above appointment.
- (iii) The Regional Commissioner, Liguria, is to be asked to state whether or not the appointment of a Vice Prefetto Ispettore for Savona is necessary.

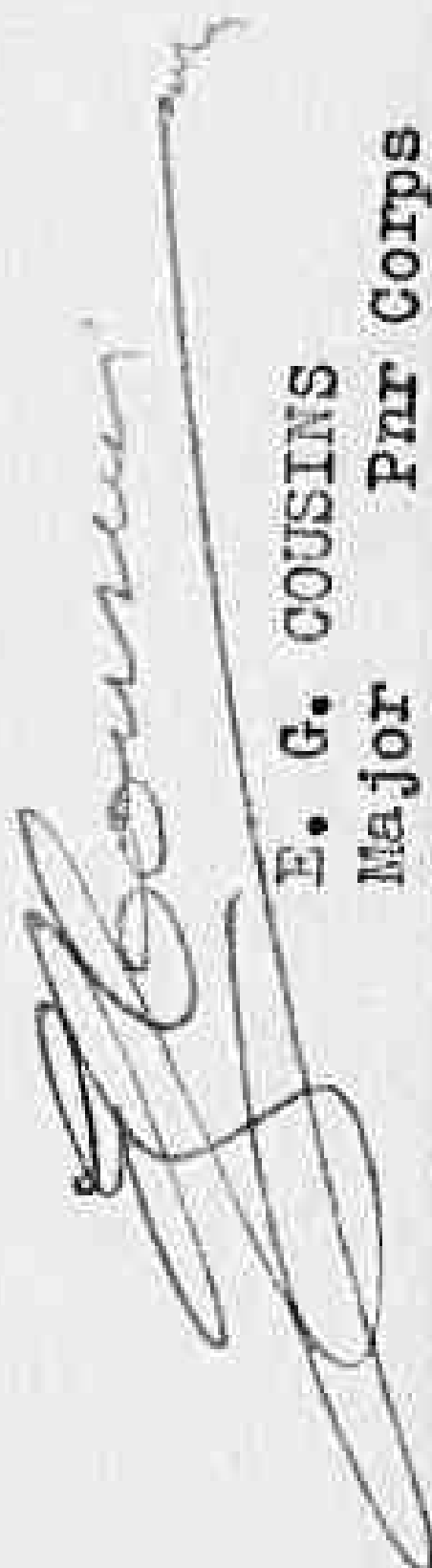

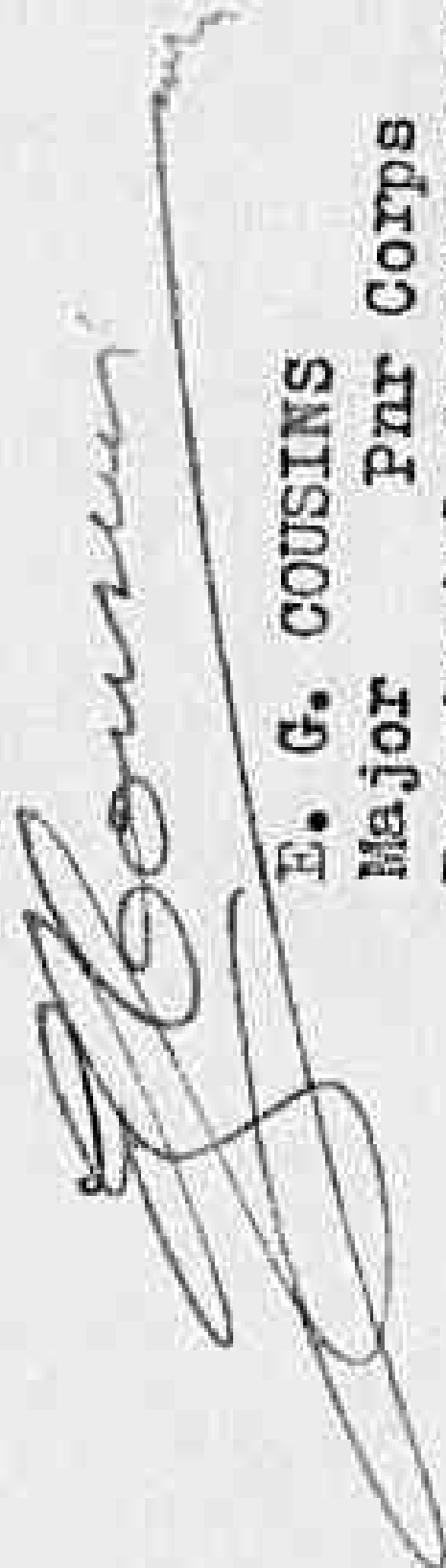

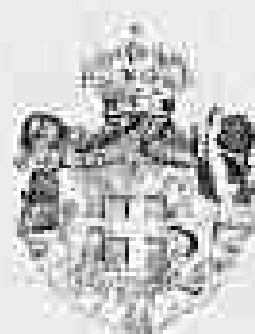

1. I had a short interview with the Prefect on Tuesday morning 24th July before proceeding to Turin as ordered. The Prefect seems a good official and shows decision and keenness for his work.

2. Vice Prefect Dott. Giacomo ROMA is a political appointment and is working well. The Prefect has a high opinion of his capabilities. There is a Vice Prefetto Politico Francesco DE SALVO.

3. Vice Prefect Inspector Dott. Domenico AMARI is a I' Consigliere with the inspective functions. The Prefect thinks a lot of him as he worked with the Partisans for a long time and also because he is a career official.

4. The Prefect said he had sufficient officials and did not require any more. I told him the proper method of application and in case he should require any.

5. The Deputazione Provinciale was working well. It has 6 members and 2 supplenti and gives representation to all the parties.

6. The G.P.A. is also formed and is meeting when necessary.

1. The PO. said that Cpl. John A. MONTGOMERY was handling the presentation of the electoral list and had the Vice Prefect Inspector ready for an interview. It should be noted that the Vice Prefect Inspector and the PO and I had a talk about the local government situation.

2. The Prefetto Reggente Reg. Francesco and the PO. were a non career men. He had been the captain of the C.I.G. and was respected by the people. 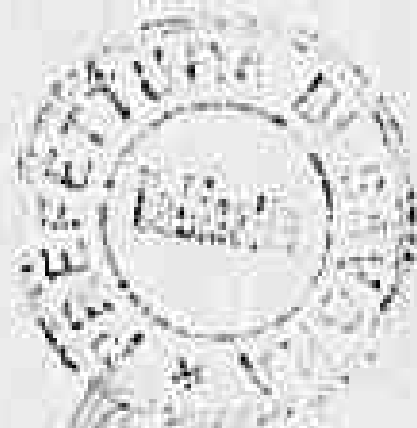

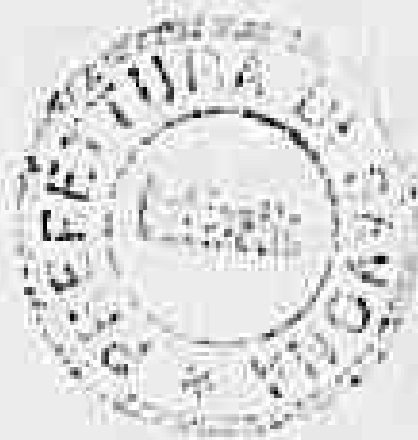

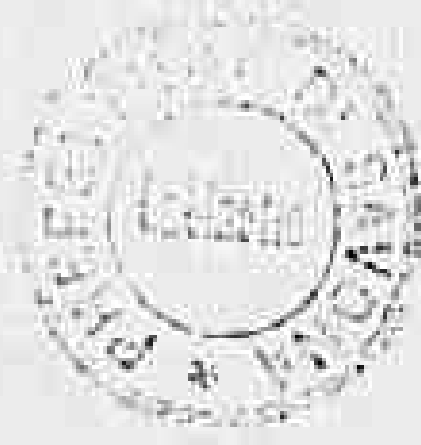

1. Major Temple said that, with reference to the proposal to appoint Avv. Rolla as Prefetto Soggerente of Savona, the opinion of the Regional Commission of Liguria had been obtained. The RC had stated that he would be agreeable to the appointment of Avv. Rolla as VV; but that he was firmly of the opinion that a career Prefect was needed, who was familiar with the details of administrative procedure: the lack of such an official was felt in the administration of Savona. Accordingly, Major Temple stated the Sub Commission felt obliged to renew their previous request for the nomination of career Prefect.
2. Sig. De Magistris said that he would see that immediate attention was given to this request. 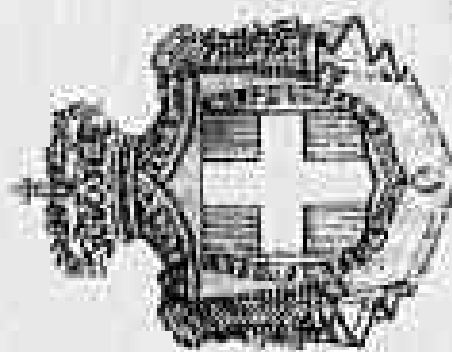

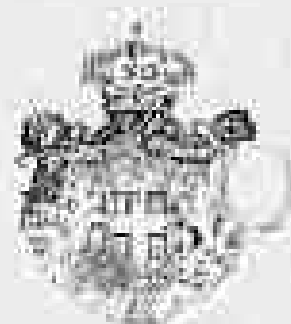

Sig. Arrigo NICE, interpreting.

1. Sig. DE MAGISTRIS, as Vice Capo Ufficio to Sig. PARRI, Minister of the Interior, presented a proposal on the part of the Ministry that Avv. Giacomo ROLLA (at present Vice Prefetto Vicario) should be appointed Prefetto Reggente of Savona. It was the opinion of the Ministry that under Avv. ROLLA, as a non-career Prefect, the "political situation would be stabilized": it was also represented that this appointment could be balanced by the appointment of a career Vice Prefetto Vicario.
2. Major Temple drew the attention of the Ministry's representatives to the completely unsatisfactory state of the administration in Savona Province, as shown in the Provincial Commissioner's report, and to the fact that both present Vice Prefects were non-career men. He also noted delays which had occurred in the past in filling vacancies in the administration. Major Temple stated, however, that he would forward the suggestions of the Ministry to the Regional Commissioner, Liguria, for his observations. He also promised to ascertain whether or not a Vice Prefetto Ispettore was still required.
3. Sig. DE MAGISTRIS promised that, should these suggestions prove acceptable, he would make it his personal duty to see that a career Vice Prefetto Vicario was appointed by the Ministry immediately. Also, should these suggestions be unacceptable, it was believed that a career Prefetto could be found. Sig. DE MAGISTRIS then explained that, apart from the political situation, it was also the policy of the Ministry to refrain from making any new appointments amongst Prefects at the present moment, because a new set of regulations were being drafted: the effect of those regulations would be to lower the age-limit so that the administrative posts would be filled by younger men. Although these regulations were provisional, Sig. DE MAGISTRIS believed that vacancies would be filled very largely by the promotion of Vice Prefects. In answer to queries by Major Temple, Sig. DE MAGISTRIS stated that Sig. PARRI was sure that the appointment of Avv. ROLLA was acceptable to the CLN. He also stated that the present Prefetto Reggente was a member of the Republican Party, but that he was not sure what party Avv. ROLLA supported, though he knew it was not the Republican Party.

4. Major Temple promised to put the following points before the Regional Commissioner, Liguria:

- (i) The Ministry of the Interior have proposed the appointment of Avv. Giacomo ROLLA as Prefetto Reggente of Savona. This appointment is stated to be acceptable to the CLN.
- (ii) The Ministry further propose the appointment of a career man as Vice Prefetto Vicario. This appointment would be made immediately upon confirmation of the above appointment.
- (iii) The Regional Commissioner, Liguria, is to be asked to state whether or not the appointment of a Vice Prefetto Ispettore for Savona is necessary.

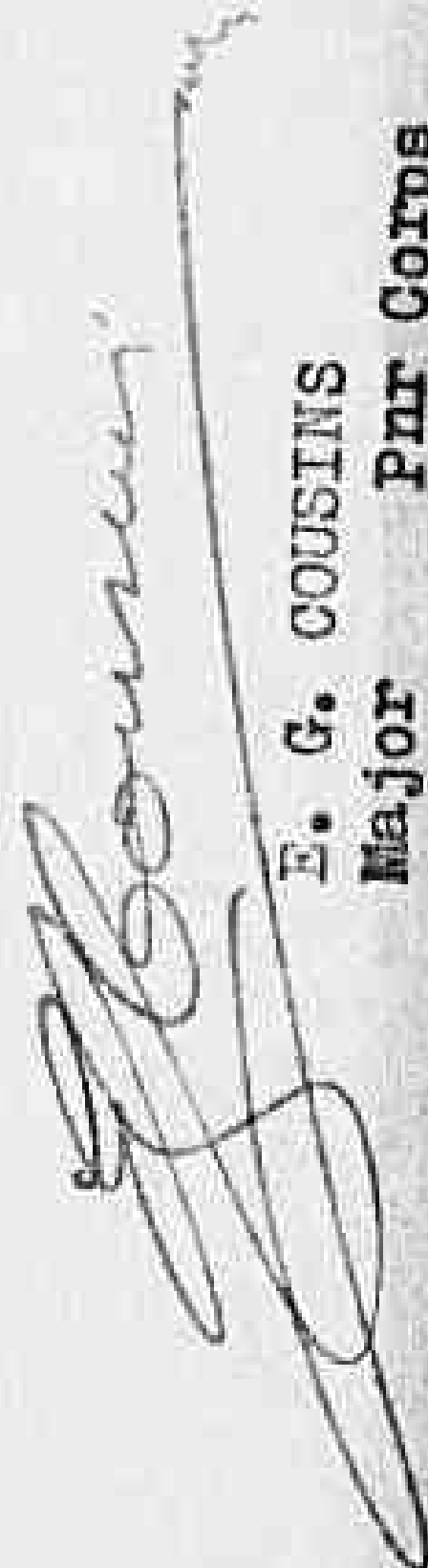

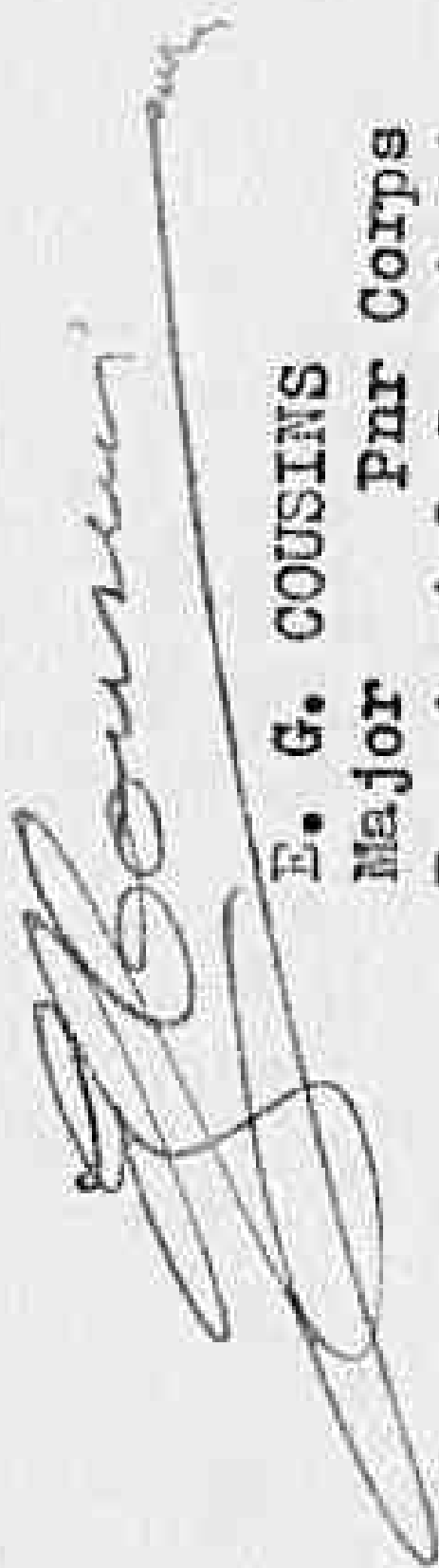

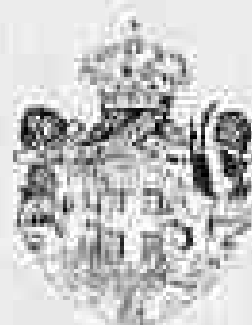

1. I had a short interview with the Prefect on Tuesday morning 24th July before proceeding to Paris as ordered. The Prefect seems a good official and shows decision and keenness for his work.
2. Vice Prefect Dott. Giacomo ROMA is a political appointment and is working well. The Prefect has a high opinion of his capabilities. There is a Vice Prefetto Politico Francesco DE SANO.
3. Vice Prefect Inspector Dott. Domenico AMAR is a I' Consigliere with the respective functions. The Prefect thinks a lot of him as he worked with the Partisans for a long time and also because he is a career official.
4. The Prefect said he had sufficient officials and did not require any more. I told him the proper method of application and in case he should require any.
5. The Deputazioni Provinciali was working well. It has 6 members and 2 supplenti and gives representation to all the parties.
6. The G.P.A. is also formed and is meeting when necessary.

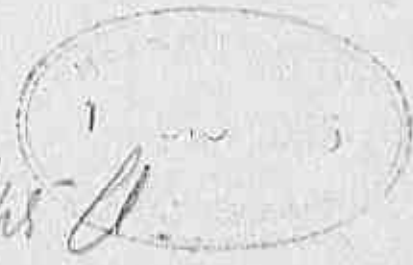

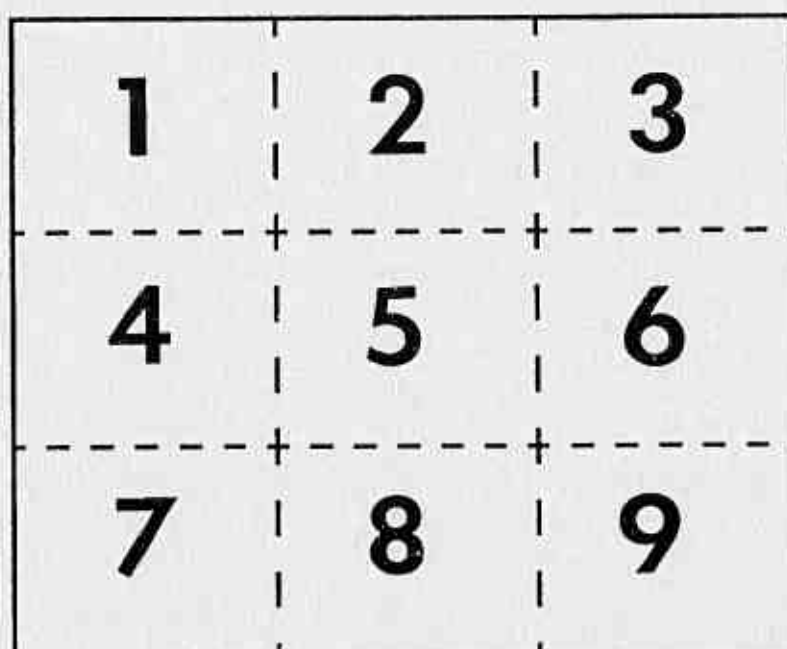
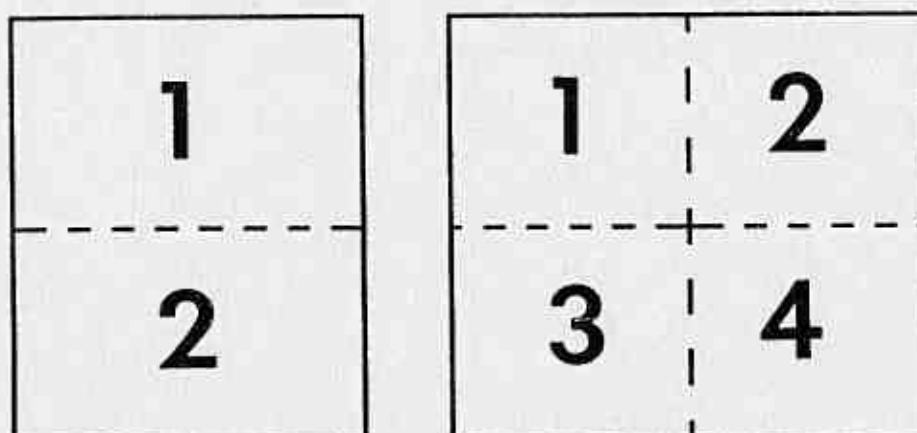
