b. The former Prefect, Rocca was moved to Lecce and the then VEV, Mascotto in his place. He was so incompetent that AG removed him and ordered him to leave Matera Province in 48 hours. Tamburro was then raised from 1st Secretary (Grade IX) to Prefect (Grade IV). This left the office of VEV vacant. It has never been filled. Instead, the VPI is also acting VEV.

Generally - the small size of the Province (only 32 communes and 130,000 people) explains the smallness of the Prefectural staff.
