j. Conditions (economic, health, etc.,) are generally fair. The health conditions of the people in the province is good, but the shortage of soap may give rise to a problem later on. Insufficient housing facilities have prevented the return of many people to Salerno. The lack of adequate communication (railroads, automobile, postal and telegraph) is their greatest problem. The food situation is bad not because of lack of sufficient quantities thereof, but because of inefficient means of transporting it to the under-supplied places. As a consequence, the black market prevails. Two examples of black market prices cited are:

The Head of the Cabinet, Dr. Nardo, stated that they are still using the term "Podesta" (a Fascist one) because "Sindaco" means an elected official. He, and he was certain the Prefect also, had not heard of any order anywhere abolishing the title Podesta and substituting therefor Sindaco. In any event they have avoided any embarrassment by addressing their communications to the communes as such and not to the Mayors.

The title Commissario Prefettizio is used when the Prefect designates a commissioner to act as his representative in administering the affairs of the commune. In Salerno Province, 86 communes have had their old mayors replaced by these Commissari Prefettizi. (See List I).

REMARKS

The Head of the Cabinet, Dr. Nardo, stated that they are still using the term "Podestà" (a fascist one) because "Sindaco" means an elected official. He, and he was certain the Prefect also, had not heard of any order anywhere abolishing the title Podestà and substituting therefor Sindaco. In any event, they have avoided any embarrassment by addressing their communications to the commune as such and not to the mayor.

The title Commisario Prefettorio is used when the Prefect designates a Commissioner to act as his representative in administering the affairs of the commune. In Salerno Province, 86 communes have had their old mayors replaced by these Commisari Prefettori. (See LIST I)

According to Dr. Nardo and Dr. Mancini (Vice Prefect), Commisari Straordinari are prominent persons in the commune who have been "acclaimed by public demonstration" as mayors. The Prefect leaves of their names from the local Carabinieri who write in or from "propagine" columns. The Prefect's office have not known whether April the appointed there 5 extraordinary Commissioners, or even known about them. They have learned that seven communes have three Commisari Straordinari. (See List II). There even are being investigated by the Prefect now.

In 52 communes, there have been no replacements of Mayors at all, from the available information. (See List III)

The title Commissario Prefetto is used when the Prefect designates a Commissioner to act as his representative in administering the affairs of the commune. In Salerno Province 86 communes have had their old mayors replaced by these Commissari Prefetti. (See hist I)

According to Dr. Nardo and Dr. Mancini (Vice Prefect), Commissari Straordinari are government persons in the commune who have been "acclaimed by public demonstrations" as mayor. The Prefect learns of their names from the local Carabinieri who write in a "grapevine" sources. The Prefect's office does not know whether AMG has appointed these Straordinary Commissioners, or even knows about them. They have learned that seven communes have these Commissari Straordinari. (See hist II). These seven are being investigated by the Prefect now.

In 52 communes, there have been no replacements of Mayors at all, from the available information. (See hist III.)

The technique employed by the Prefect in recommending appointments is as follows. The Prefect writes to the local Carabinieri requesting the names of possible delegates. The Prefect then selects for submission to AMG those whom he thinks are best qualified.
